

## Silent chats: City police take up sign of goodwill

Plan is on to train two to four constables at every police station with sign language to ensure easy communication, help differently-abled individuals



n a significant step towards inclusivity, the city police are being trained in basic Indian Sign Language (ISL) to enhance communication with the differently-abled community. As part of this initiative, a workshop was organised on Monday by v-shesh, a social enterprise, in collaboration with the police department on International Sign Language Day. The training focused on equipping Deputy Commissioners of Police (DCPs) from various divisions with essential sign language skills.

This initiative is aimed at ensuring that people with disabilities feel safe and confident when approaching police stations. The training is set to be extended to personnel at the station level, depending on their respective divisions, allowing for better interaction with the differently-abled community across the city.

A representative from the Persons with Disabilities (PWD) Alliance emphasised that such programs build immense trust and confidence within the community. ### Government circular on child rights panel draws flak

hild rights activists and members of the Karnataka State Commission for Protection of Child Rights (KSCPCR) are strongly criticising the circular issued by the Department of Women and Child Development and Empowerment of Differently Abled and Senior Citizens. Considering the circular, issued on September 20, a gag order to create problems for the KSCPCR members, they are demanding the government to withdraw it immediately. "The government has received complaints and criticisms on the suggestions and oral instructions given by the KSCPCR members during their visits and meetings held at districts. To avoid this, it is sug-

gested that the members have to convene meetings in the presence of the KSCPCR Chairman and get his suggestions and instructions. Further, the presence of two KSCPCR members is required while visiting the districts. The members have to submit the report to the KSCPCR Chairman," the circular read.

The KSCPCR committee has five members, one secretary and a chairman. The child rights activists said that it would be too late to get instructions from the KSCPCR Chairman on issues related to students in rural areas and then act on them. They alleged that the government wants to harass the KSCPCR members who have been working for the welfare of children in rural areas. "There is a restriction on KSCP-CR members undertaking tours of districts. Each member has to



tour the districts only for 10 days in a month. I am yet to get the allowance for touring the districts and attending the meetings for the last six months. It is going to be very hard for everyone if we have to come all the way to Bengaluru to get the KSCPCR Chairman's nod for every issue," said a KSCPCR member on the condition of anonymity.

Raghavendra, a former member of KSCPCR from Bellary, said the government has to revise the

travel allowance (TA) that was fixed when petrol was available at Rs 35/litre. "I had to incur a loss of Rs 1,20,000 while working as a KSCPCR member. The member gets the TA of Rs 3/km. I suspect the government does not want them to work for the welfare of children. The need of the hour is to amend the KSCP-CR Act," he said. Shankarappa D, a former member of KSCPCR, said, "The government has no jurisdiction or power to interfere in the KSCPCR functions. Each member of the KSCPCR is allotted five to six districts. It is his/ her duty to attend to children's problems in these districts."

Meanwhile, KSCPCR Chairman K Naganna Gowda said that he has not received the copy of the circular. "We will discuss it after receiving the circular," he added.



## Tanker owners' strike has left Mahadevapura thirsting

Ripples of power supply to borewells in Hoskote being cut off felt in East Bengaluru, where most residents depend on tankers for water; scarcity, steep prices pinch

everal localities in Mahadevapura zone have been dealing with water shortage due to unavailability of water tankers supply for five days. Many others in the area complain that though they have been able to avail of a few water tankers, the prices charged are exorbitant.

The situation is due to an ongoing problem with the Hoskote tanker water supply being cut off. Hoskote tanker owners are on strike as the administration had started disconnecting power supply. There is pressure from the local villagers stating that there is rampant pumping of water from these borewells and Hoskote taluk will not have any more water.

Clement Jayakumar from Mahadevapura Task Force (MTF) said, "In East Bengaluru, water comes from Hoskote taluk. For the last five days there has been a strike by the tanker association because the power supply has been cut for some of the borewells that were pumping water into the tankers. The Deputy Commissioner of Bengaluru Rural has been under pressure from the residents that if all water is being pumped for commercial purposes and going to Bengaluru, then they will not have water."

Bengaluru Rural DC cut the power supply to these borewells. The tanker water cost has also doubled. In Mahadevapura, most of the people are relying on borewells or



tankers, and with less water this year, the demand is soaring. Only about 30 percent of people are getting Cauvery water once a week. The borewell water yield is very less. "The officials are having a meeting with the Hoskote authorities to resolve the issue. If this continues then it will be a major challenge," Jayakumar added.

Residents from several areas like Whitefield, Borewell road, Nallurhalli have been complaining of not getting water tanker supply since Friday. Prices are even going up till Rs 4,000-5,000 for a 12,000 litre tanker.



## CM to not cower and resign yet

Siddaramaiah rejects Oppn resignation demand after HC allows probe against him in MUDA case

hief Minister Siddaramaiah has firmly rejected the opposition's demand for his resignation after the High Court dismissed his petition challenging the Governor's approval for an investigation against him in a site allotment case involving the Mysuru Urban Development Authority (MUDA). Speaking to reporters, the CM accused the Narendra Modi-led NDA government of engaging in "vendetta politics" against opposition-ruled states, including Karnataka, and called the opposition's demands 'a political conspiracy'. Despite the court's decision, Siddaramaiah maintained that he had done no wrong and vowed to continue the legal battle after consulting legal experts and party leaders. He reiterated his commitment to fighting the accusations politically, accusing the Bharatiya Janata Party and Janata Dal (Secular) of attempting to destabilise his government through false allegations and manipulation of constitutional offices.

#### Setback for Siddaramaiah as HC upholds Governor's approval

In a significant setback for the CM, the Karnataka High Court upheld Governor Thaawarchand Gehlot's approval for a probe into allegations of irregularities in the allotment of 14 sites to Siddaramaiah's wife by MUDA. The court dismissed Siddaramaiah's plea challenging the legality of the Governor's decision, ruling that the gubernatorial order did not lack application of mind. The case stems from allegations that compensatory sites were allotted to Siddaramaiah's wife, BM Parvathi, in an upscale area of Mysuru, with claims that the land had a higher property value than the location originally acquired by MUDA. The Governor's nod for investigation, given on August 16, was based on petitions from complainants who



expressed skepticism regarding CM Siddaramaiah's alleged lack of involvement in a land transaction involving MUDA, which purportedly resulted in his family gaining approximately Rs 56 crores. The court made this observation while upholding the Governor's sanction for an investigation under the Prevention of Corruption Act and the Bharatiya Nagarik Suraksha Sanhita.

Justice M Nagaprasanna, presiding over the single judge bench, found it challenging to accept that the Chief Minister's family, who benefited substantially from the transaction, was not involved. The court emphasised the need to investigate how and why the rule was altered in favour of the CM's family.

### CM stands firm amid political pressure

Despite the legal blow, Siddaramaiah made it clear he has no intention of stepping down, comparing his situation to that of Union Minister HD Kumaraswamy, who also faced legal issues but did not resign. Siddaramaiah addresses a press conference in B'luru on Tuesday

 –Justice M Nagaprasanna dismissed the opposition's demands for his resignation, asserting that the inquiry is still in its preliminary stages and there is no reason to step aside at this point. The CM accused the opposition parties, particularly BJP and JD(S), of attempting to buy Congress MLAs and destabilise his government using "money power" and operations like 'Kamala.' He claimed that these parties have consistently tried to undermine his administration because they oppose the government's pro-poor initiatives and social justice schemes.

### Legal and political battle to continue

Siddaramaiah emphasised that his legal and political fight will continue with the full support of his party and senior leaders. Deputy Chief Minister DK Shivakumar echoed these sentiments, stating that there was no question of resignation, as the allegations are part of a larger conspiracy against the CM.

#### **Origins of the MUDA case**

The MUDA site allotment controversy dates back over three decades, involving land originally acquired in 1992. Siddaramaiah's wife, Parvathi, was allotted compensatory plots under a 50:50 ratio scheme in exchange for land in Mysuru. Allegations have surfaced that Parvathi had no legal title over the land in question, sparking the ongoing legal and political battle.

### High Court verdict paves way for further investigations

The High Court, while dismissing Siddaramaiah's petition, clarified that the Governor acted within his constitutional powers in granting approval for the investigation. The court stated that the facts of the case warrant an investigation, particularly since the beneficiary of the alleged irregularities is the CM's family. The ruling has opened the door for further legal proceedings against Siddaramaiah.

## Bank retirees protest for better pension

round 1,000 bank retirees and pensioners under the guidance of the Coordination of Bank Pensioners and Retirees' Organisations staged a dharna at Freedom Park on Monday in support of their long-pending demands. They have demanded the government to revise their pension on par with the Central government pensioners.

"The Central government revises pension of its retired employees whenever it implements the Pay Commission for the employees. Reserve Bank of India (RBI) pensioners also have got their pension revised twice but the pension of bank retirees is not updated so far," said KV Acharya, president of All India Bank Pensioners & Retirees Confederation.

He said that the government has not done anything to revise the pension of bank retirees despite the apex court's judgment stating that wage & pension revision is inseparable.

Speaking with Bangalore Mirror, AN Krishnamurthy, convenor of Coordination of Bank Pensioners and Retirees' Organisations has said that many pensioners are not able to pay the premium of health insurance. "A bank retiree has to pay his three months' pension towards the premium of health insurance. The premium is Rs 1,07,000 and it is not easy for a retired person to pay such a big amount. Earlier, the premium of health insurance was only Rs 7,000," said Krishnamurthy.

He demanded the government to waive GST on health insurance policy for bank pensioners. "With no revision of pension commensurate with the present day cost of living and maintenance of senior citizens, a steep increase in health insurance premium, levy of GST at 18 percent will have an adverse impact on pensioners," he said.

He said that the organisation demands consultative status with the Indian Banks' Association, discussing the issues related to bank employees and retirees.

### Transfer Valimiki probe to CBI: Bank to HC

he Union Bank of India argued before the Karnataka High Court on Tuesday that transferring the investigation into the alleged scam involving the Karnataka Maharshi Valmiki Scheduled Tribes Development Corporation Ltd to the Central Bureau of Investigation (CBI) is crucial for maintaining the integrity of the banking industry. The bank's petition seeks a direction from the court to the government to transfer the probe to the CBI.

Senior advocate BV Acharya, representing the State, questioned the maintainability of the plea, stating that the dispute is between the State and the Union Government. The high court, however, disagreed with this view. Acharya referred to a Supreme Court deci-



sion in the case of State of West Bengal v. Union of India, suggesting that the jurisdiction of all other courts is barred when there is a dispute between the State and Central Government. Attorney General (AG) R Venkataramani, appearing for the petitioner bank, argued that the petition does not rely on the Delhi Special Police (DSP) Act. He emphasised that the Reserve Bank of India (RBI) has the power to issue directions under Section 35A of the Banking Regulation Act to ensure the integrity of banks and that the RBI's master circular designates the CBI as the investigating agency for certain classes of offenses, without requiring the assistance of the Central government.

The AG stressed that the RBI's master circular is binding on the bank and that the scheme is outside the scope of the DSP Act. The AG emphasised the importance of maintaining the integrity of the banking industry and argued that the CBI should investigate the mat-

ter, even if it reaches the same conclusion as the state agency.

The high court noted the respondents' argument that the petitioner bank cannot choose the investigator. The AG countered that while this is a principle in the broader sense, the bank is not choosing but is bound by the RBI's directive. The AG pointed out that the chargesheet includes members of the corporation and outsiders, and that money had come into the bank and flown out, suggesting that the bank had been "used as a tool." He argued that the reasons behind the money's movement and the involvement of the accused require investigation. The high court has listed the matter for further hearing on September 30.

### HC puts stop to livestreaming of court videos without permission

he High Court on Tuesday issued an order prohibiting media organisations and individuals from sharing videos of court proceedings without authorisation.

The order was issued in response to a petition filed by the Advocates' Association Bengaluru (AAB) that sought a direction to the central government to take appropriate measures to prevent individuals, video creators, and media agencies from illegally using court proceedings from live streamed videos.

The order, passed by a single judge bench headed by Justice Hemant Chandangoudar, stated, "Till next date, respondent R6 to R8 [YouTube, Facebook, and X] are restrained from sharing live streamed videos and R9 to R13 [some media agencies] are restrained from displaying the videos on their channels. They (R6 to R8) are directed to delete the videos live streamed on channels posted in violation of rules."

During the hearing, the court noted that a rule prohibiting such videos is already in place. The HC Registry also informed the bench about displaying a disclaimer to discourage the use of the video.

The petition was filed shortly after two viral video clips of Justice V



Srishananda surfaced on social media, in which he was seen making objectionable remarks.

The petitioners argue that the actions of video makers and miscreants who misuse live broadcasting are highly arbitrary, illegal, perverse, and unsustainable in the eyes of the law.

Recently, the Supreme Court has

directed the Registrar General of the HC to submit a report on this case. The matter is scheduled for hearing on Wednesday.

Activists have deemed the order a blow to transparency from the constitutional court. The Campaign Against Hate Speech, Karnataka, initiated an open letter to the Chief Justice of India on Saturday demanding appropriate action be immediately taken against Justice V Srishananda for violating his oath. The letter further demanded that live coverage of all court halls should continue to ensure transparency and accountability of judicial actions.

"The AAB has baselessly demanded that the live streaming be stopped so as to not bring disrepute to the institution of judiciary.

Instead of demanding accountability for his hateful remarks, they have alleged that the circulation of the video of the live stream will "totally damage the image in public of courts.

In fact, the CJI has noted that "social media plays an active role in monitoring and amplifying court-room proceedings."

Despite the immunity offered by the Protection of Judges Act 1986, judges should not violate existing provisions of the law and the Constitution but in fact should be upholding them through conduct which is unimpeachable in its fidelity to constitutional morality," the letter stated.

Traffic cops have urged RTO to cancel driving licences of offenders; CM asks Transport Minister to push for harsher penalties

mid the growing menace of drunk driving in the city, Chief Minister Siddaramaiah has also called for stricter measures, suggesting that the driving licences of those who drive under the influence of alcohol or repeatedly violate traffic rules should be revoked.

Speaking at the launch of 65 new ambulances under the 'Chief Minister's Emergency Ambulance Service' to reduce road accident fatalities, he said that despite strict traffic regulations, many continue to flout them, leading to tragic consequences for innocent lives.

Siddaramaiah urged that harsher penalties, particularly for drunk driving and the use of mobile phones while driving, are necessary to curb accidents. He directed Transport Minister Ramalinga Reddy to ensure that habitual violators face licence cancellations.

Transport minister Ramalinga Reddy told BM, "Drunk driving is one of the most common offences leading to violence on our roads, and stricter enforcement of driving

license cancellations for habitual offenders will be implemented."

#### **Power to disqualify**

According to the Indian Motor vehicle Act, the licencing authority holds the power to disqualify an individual from holding a driving license or revoke it if certain conditions are met.

After providing the licence holder with an opportunity to be heard, the authority may take this action if they are convinced that the person is a habitual criminal, habitual drunkard, or is habitually addicted to narcotic drugs or psychotropic substances as defined under the Narcotic Drugs and Psychotropic Substances Act, 1985.

This ensures that individuals who pose a risk to public safety due to such habits are barred from driving.

#### 1,146 cases

During a recent special drive targeting drivers and riders operating vehicles under the influence of alcohol, conducted by all traffic police stations, a total of 1,146 cases were registered in just one week. The city has been seeing a surge in drunk and drive cases, and other violations related to it.

The Traffic Police have submitted a proposal to the Regional Transport Office (RTO), urging the full cancellation of licences for habitual drunk driving offenders.

This practice is not new, as the

Traffic Police have consistently submitted the driving licences of such offenders for cancellation, with enforcement efforts from their side remaining steadfast.

DCP North Traffic, Siri Gowri, highlighted the delay in licence cancellations by the RTO, stating, "Not all driving licences submitted for cancellation are processed on time.






» Connect adjacent dots with vertical or horizontal lines, creating a single loop (Fig A). » Crossovers or branches are not allowed (As shown by dotted lines in Fig B). » Numbers in the puzzle indicate the number of lines that should surround it, while empty cells may be surrounded by any number of lines. » You can't draw lines around zeros. » Each puzzle has just one unique solution.

#### How to begin:

Example (Fig A) - Begin with the zero next to 3. Since no lines can be drawn around zero, mark crosses around it, as shown. Now there is a cross in one space around 3. So we know the three lines of 3 can only be drawn in the remaining three spaces. Next, these lines can only be extended in one direction each. Continue, using the same logic.
