Air Marshal Amar Preet Singh to be new Chief of Air Staff

AIR Marshal Amar Preet Singh, a fighter pilot with more than 5,000 hours of flying experience, will take charge as the chief of the Indian Air Force after incumbent Air Chief Marshal V R Chaudhari retires on September 30. Air Marshal Singh is currently serving as the Vice Chief of the Air Staff,

"The government has appointed Air Marshal Amar Preet Singh, PVSM, AVSM, presently serving as Vice Chief of the Air Staff, as the next Chief of the Air Staff, in the rank of Air Chief Marshal, with effect from the afternoon of September 30," the defence ministry said. As Chief of the Air Staff, Air Marshal Singh's priorities are expected to be the procurement of new fighter fleets and advancing the modernisation agenda of the force in view of the fast-evolving regional security landscape, including challenges along the Line of Actual Control (LAC) with China.

The number of the IAF's fighter squadrons has come down to around 30 as against the authorised strength of at least 42. The air warrior played a key role in the IAFs hosting of the multinational wargame Tarang Shakti' recently. Known as a fine strategist, Air Marshal Singh, in a message to the DRDO and other agencies apparently over delays in delivery of Tejas jets and other military systems, said publicly at an event in July that self-reliance in defence cannot be at the cost

of national security. Born on October 27, 1964, Air Marshal Singh was commissioned into the fighter pilot. stream of the Indian Air Force in December 1984. In his long and distinguished service spanning nearly 40 years, he has served in a variety of command, staff, instructional and foreign appointments. An alumnus of the National Defence Academy, Defence Services Staff College and National Defence College, the air officer is a qualified flying instructor and an experimental test pilot with more than 5,000 hours of flying experience on a variety of fixed and rotarywing aircraft. The officer has commanded an operational fighter squadron and a frontline air base.

BECOMES YOUNGEST LEADER TO HOLD TOP POST

NEW DELHI

SENIOR Aam Aadmi Party (AAP) leader Atishi took oath as the Chief Minister of Delhi on Saturday. The oath of office and secrecy was administered to Atishi and her cabinet ministers by Lt Governor (LG) Vinay Kumar Saxena at the Raj Niwas, Before the swearing-in ceremony, all the ministers met AAP national convener Arvind Kejriwal.

Atishi is the third woman to become Chief Minister of Delhi and also the youngest to hold the top post. Her succession to the CM post followed Kejriwal's resignation as the Chief Minister after his bail in the liquor policy scam by the Supreme Court.

Atishi, who represents Delhi's Kalkaji constituency was unanimously chosen as the leader for the top post at the AAP legislature party meeting on September 17.

Apart from Atishi, Gopal Rai, Kailash Gahlot, Saurabh Bharadwaj, and Imran Hussain, who were part of the outgoing Kejriwal government, were sworn in as ministers. One post remains vacant.

Mukesh Ahlawat is a new entrant in the Atishi cabinet. Being a first-time MLA from Sultanpur Majra and also the only Dalit face, Mukesh Ahlawat's elevation will enhance the AAP government's outreach to the backward communities.

Before the swearing-in, Ahlawat told IANS that there is some sadness within the party because of Kejriwal's resignation but despite the setbacks, he will remain the sole leader of the party.

The swearing-in ceremony remained a low-key

affair as the party didn't engage in either show of strength or making big boasts about the new government taking oath, ahead of Assembly elections. Atishi was also one of the senior-most ministers in the erstwhile Kejriwal government as she held multiple portfolios and was also seen as 'filling in the gap' in the absence of Kejriwal and former Deputy Chief Minister Manish Siso-

In the outgoing Kejrigovernment, Atishi held 13 portfolios including finance, revenue, PWD, power and education among others. Rai held environment, development and administration general departments while Bharadwaj looked after the health, tourism and urban development departments among others. Gahlot was in charge of transport and Hussain of food and civil supplies.

Ruler must tolerate dissent in a democracy: Gadkari

PUNE: Union Minister Nitin Gadkari has said the biggest test of democracy is that the ruler tolerates even the strongest opinion against him, and it leads to introspection. Writers and intellectuals should express themselves fearlessly, the senior BJP leader said at a book release function held at MIT World Peace University here on Friday.

"The biggest test of democracy is that the king tolerates the opinion strongest against him and introspects over it," he said. In India, there is no problem of difference of opinion but "there is a problem of lack of opinion," the Road Transport and Highways Minister said. "We are neither rightist, nor leftist. We are opportunists. It is expected from writers and intellectuals that they express their opinions without any fear," he added. Gadkari also said that as long as untouchability and notions of social inferiority and superiority persist, the work of nation-building can not be said to be complete.

Centre clears appointment of CJs of 7 HCs

A day after the Supreme Court sought details of reiterated Collegium recommendations for the appointment of judges and questioned over delay in notifying these names, the Centre on Saturday cleared the appointment of Chief Justices of the High Courts of Delhi, Himachal Pradesh, Jammu & Kashmir and Ladakh, Kerala, Madhya Pradesh, Madras, and Meghalaya.

In a post on X, Union Minister for Law and Justice Arjun Ram Meghwal announced that President Droupadi Murmu was pleased to appoint Justice Manmohan, the acting Chief Justice, as Chief Justice of the Delhi High Court.

Justice Rajiv Shakdher of the Delhi HC has been appointed as Chief Justice of the Himachal Pradesh High Court, while its Chief Justice M.S. Ramachandra Rao has been transferred as Chief Justice of the Jharkhand HC.



AP may hand over laddu row to CBI probe

Growing demand to book former TTD chairmen Karunakar Reddy and Subba Reddy

WILL Andhra Pradesh Government seek a CBI probe into the irregularities in the Tirumala-Tirupati Devastanams (TTD) and other temples that took place during the five-year term of YSRCP government which includes using of adulterated ghee in making of laddu prasadam and Annadanam Prasadams not only in Tirumala temple but in other important temples like Simhachalam and Annavaram.

If the fast-pace developments that are taking place at the Government level on one hand and the kind of illogical explanations that are coming from the YSRCP leaders as well the growing demand from the public and religious heads, points towards the possibility of the Government seeking a detailed probe by a central agency in next couple of days. There is also growing demand from public and leaders that cases should be booked against former TTD chairmen K Karunakar Reddy

and Y V Subba Reddy. Chief Minister N Chandrababu Naidu on Saturday held a meeting with Executive Officer J Syamala Rao, additional EO and ministers to discuss about the preliminary reports they had presented to him and the way forward. The EO would be submitting a detailed report on Sunday. The EO also explained on the procedures to perform Samprokshana (purification) of the entire premises starting from Laddu Potu (Laddu kitchen). In addition, a three-day Mahasanti Yagam is also likely to be performed.

It is learnt that Naidu had told the Centre that he would be sending a detailed report not just on the irregularities that had taken place in laddu prasadam or the NDDB CALF report on adulteration of ghee but on various other aspects.

Naidu also directed the Endowments department to ensure there should be no place for any kind of adulteration in any temple across the state.

Borders peaceful as Pak fears Modi: Amit Shah

Junior docs resume duties partially

KOLKATA

JUNIOR doctors on Saturday rejoined their duties partially at various government-run hospitals in West Bengal after a hiatus of 42 days. They were on 'cease work' in protest against the rape and murder of an on-duty woman doctor at RG Kar Medical College and Hospital. The junior doctors rejoined their duties in essential and emergency services at all state-run hospitals but not in the outpatient departments (OPDs). "We have started rejoining duties today. Our colleagues have started returning to their respective departments since this



morning only in essential and emergency services, but not at the OPDs. Please do not forget that this is only a partial resumption of duties," Aniket Mahato, one of the agitating doctors, said. He said his other colleagues have already left for flood-hit districts of

the state where they would start 'Abhaya clinics' (medical camps), to demonstrate their commitment to public health even amid ongoing protests.

Emergency services returned to normalcy at various state-run hospitals, with the doctors rejoining work. "It is a their cause but it had become very difficult for regular patients like us to get treatment for the last one month or so because of the 'cease work'," Dipankar Jana, a patient at Bankura Medical College and Hospital, said. Several patients were seen

pouring in at an 'Abhaya clinic' in flood-hit Panskura in Purba Medinipur district. "We have received very good response in these clinics. junior doctor manning one such clinic, said. The agitating doctors

said that they would wait for another seven days for the administration to fulfill their demands for justice for the deceased doctor and the removal of state health secretary or else they would start another round of 'cease work'. The doctors have been protesting since August 9 when the body of a woman medic was found at RG Kar Medical College and Hospital, demanding justice for the deceaseddoctor as well as removing key officials from their posts alleging their involvement in the case.

After 23 years, Punjabi man stranded in Lebanon returns home

CHANDIGARH

WHEN Gurtej Singh travelled to Lebanon to earn a better living for the future of his family in Punjab, little did he know that he would have to wait 23 years to reunite with them.

A native of Mattewara village in Ludhiana district, Singh moved to Lebanon in 2001 with five to six people from his village. While the others returned home following the outbreak of a war in the country in 2006, Singh became stranded after losing his passport.

"I went to Lebanon in 2001 for work to give a better life to my family," said Singh, now aged 55. "(When the war broke out) I also wanted to return to India. I went to the Indian Embassy several times but they wanted some proof (to issue a duplicate passport)," he told PTI on Saturday.

He finally returned to India on September 6 after AAP Rajya Sabha member Balbir Singh Seechewal raised the issue with the Ministry of External Affairs.



Seechewal said he took up the matter with the authorities concerned, following which a copy of Singh's lost passport was made available and he could finally return.

Singh admitted that, having lost his passport, he lived in constant fear of being caught. He said he used to think how he would return to India in the absence of a passport. His family in India also tried to facilitate his return but in vain.

Unable to get a duplicate passport, Singh said he thought he might never see

his family again, "I used to think how I would go back to India," he said.

Before moving to the Lebanon -- where he worked as a labourer at a vegetable farm - Singh was employed in a factory manufacturing sweaters in Ludhiana.

When he went to Lebanon, Singh said his elder son was six years old and the younger one was three. "Now, my elder son has a six-year-old son," he said. His younger son is yet to get married.

Man held for assaulting cop

HOSHIARPUR (PUN-IAB): A man was on Saturday arrested for assaulting a police officer at the inter-state check post at Chak Sadhu here. Hoshiarpur Superintendent of Police (Investigation) Sarbjit Singh Bahia said the incident occurred when a police team intercepted a motorcycle with three occupants, who were coming from Himachal Pradesh on Friday. Instead of cooperating with the police, the three individuals allegedly assaulted Assistant Sub-inspector Rakesh Kumar, tore his uniform, and attempted to snatch his service pistol before fleeing, Bahia said. One of the accused, Sukhbir of Marnaian, has been arrested in connection with the incident while raids are being conducted to apprehend his two accomplices, Amariit of Marnaian and Jindi of Tanuli, Bahia added. www

AAP MLA Kunwar bereaved, wife dies at 48

AMRITSAR: AAP's Punjab MLA Kunwar Vijay Pratap Singh's wife Madhumeeta died on Saturday. She was 48. She was admitted to a private hospital on Friday after complaining of uneasiness. She is survived by Singh and their two daughters. Her cremation was attended by Cabinet minister Harbhajan Singh, AAP MLA Ajay Gupta, Congress MP Gurjeet Singh Auila, and other political leaders and senior district administration officials. Chief Minister Bhagwant Mann expressed grief over her death and said on X, "Received the sad news of the sudden demise of the wife of our Amritsar North MLA Kunwar Vijay Pratap ji... Heartfelt condolences to the family of Kunwar ji in this hour of sorrow..." Singh is the AAP MLA from Amritsar North. He joined the party after resigning from the Indian Police Service.

Father, son arrested for defacing national flag

BAREILLY(UP): A man and his son were arrested for allegedly defacing the Indian national flag by removing the Ashok Chakra and replacing it with Arabic text, police said. Police received information about the incident from a photo shared on a social media platform, Station House Officer Sanjay Tomar said, adding that the flag was found on the roof of a house in Mohammadpur locality. Mohammad Qadir and his son Mohammad Fazil were arrested and charged under the the Prevention of Insults to National Honour Act, 1971. They were sent to jail on Friday, he added.

Stray dog menace

SRN Hospital deploys 40 security guards



PRAYAGRAJ (UP)

TO deal with the stray dog menace, the Swaroop Rani Nehru (SRN) Hospital of the city has deployed 40 security guards, including 10 gunmen, an official of the hospital told PTI on Saturday.

The security guards have been provided by the Uttar Pradesh Bhutpurva Sainik Kalyan Nigam Ltd with which the medical college has entered into a contract.

In compliance with the Allahabad High Court's order dated August 22, 2024, the principal secretary, Medical Education Department

and superintendent-in-chief, SRN Hospital, Prayagraj filed their affidavits on September 18, disclosing the plan to deploy 40 security guards in the hospital.

Earlier, the court had taken suo motu cognisance of the rodent menace at the SRN Hospital, an associate hospital of the Moti Lal Nehru Medical College, a state medical college. However, during the course of hearing, the court was informed that dog menace is

also prevalent there. A division bench comprising Justice Manoj Kumar Gupta and Justice Manish Kumar Nigam was hearing the matter.

According to the affidavit, the Prayagraj municipal commissioner has been requested to start a drive to catch stray dogs. The broken doors and entry points are also being repaired.

The court asked for an additional affidavit from the superintendent-in-chief, SRN Hospital regarding the plan for the construction of separate duty rooms for female doctors in departments where they are not available and fixed October 21, 2024 as the next date of hearing.

Defamation case against Rahul in UP court Hearing postponed to October 1

SULTANPUR (UP)

THE hearing in a defamation case against Leader of Opposition in the Lok Sabha Rahul Gandhi in a MP-MLA court in this Uttar Pradesh district was postponed on Saturday due to a health camp organised by the bar council.

The matter will now be heard on October 1. Plaintiff Vijay Mishra's lawyer Santosh Kumar Pandey said his client's statement was to be recorded on Saturday, but due to the health camp organised by the Bar Association on the civil court premises, the lawyers were busy in it and no court work could be done.

"The court has postponed the matter to October 1," he said. Gandhi has been accused of making objectionable comments during the 2018 Karnataka polls about Union Home Minister Amit Shah, who was the BIP president then.

Mishra, a local Bharatiya Janata Party (BJP) politician, filed a complaint against Gandhi in August 2018. Since then, the matter has been going on in the court. Gandhi surrendered before



the court during the "Bharat Jodo Nyay Yatra" on February 20 and was granted bail on personal surety bonds of Rs 25,000 each.

Subsequently, the court issued several notices to the Congress leader to record his statement, but he was unable to appear before it due to the Lok Sabha polls. Gandhi finally appeared before the MP-MLA court on July 26, got his statement recorded and said the case was filed to gain "cheap publicity".

The former Congress chief,

who appeared before Special Judge Shubham Verma, said he never gave a statement against anyone that could lead to a case of defamation, his lawyer Kashi Prasad Shukla had told reporters.

The matter was posted for further proceedings on August 12 but was deferred as the judge was on leave. On the next two dates on August 23 and September 5, the hearing did not take place as the plaintiff could not appear in the court due to ill

label. During the state-level 'Silk Day function here, Horticulture Minister Chetan Singh Jouramajra launched the department's logo for silk products, marking the commencement of the initiative.

He announced that every effort would be made to double silk production by the

end of 2025.

Jauramajra said sericulture is currently practised in approximately 230 villages across the sub-mountainous districts of Gurdaspur, Hoshiarpur, Pathankot and Ropar, with 1,200 to 1,400 silk rearers.

The state primarily produces two types of silk: bivoltine mulberry and eri silk. Annually, 1,000 to 1,100 ounces of mulberry silk seeds are reared, yielding 30,000 to 35,000 kg of mulberry silk cocoons, while 200 ounces of eri silk seeds produce 5,000 to 8,000 kg of silk cocoons.

"This occupation is predominantly adopted by people living below the poverty line, landless individuals or those with small landholdings," said the minister, adding currently a silk rearer earns an annual income

of Rs 40,000 to Rs 50,000, which is considered insufficient. Jouramaira said the government would establish its own reeling units to process cocoons, ensuring silk farm-

ers receive higher prices for

their produce. He said a reeling unit for converting cocoons into silk thread is being set up in

Pathankot. With the operationalisation of this unit, the income of silk rearers can potentially increase by 1.5 to two times.

Addressing the gathering, Special Chief Secretary (Horticulture) K A P Sinha said the state has 13 government sericulture farms and with the established infrastructure at these farms, the department's technical staff is providing necessary facilities to silk farmers, such as plantation assistance, distribution of silkworm eggs, rearing young silkworms and support for cocoon marketing. was

Amid Tirupati row, Raj govt to run special campaign for prasad quality check

LAPUR

AMID the ongoing controversy over animal fat and fish oil found in Tirupati temple laddus, a special campaign will be launched by Rajasthan's Food Safety Department from September 23 to 26 to check the quality of bhog and prasad in temples.

Samples of Savamani and the prasad given regularly in temples will be tested under this campaign. Additional Commissioner of Food Safety Department, Pankaj Ojha

said: "This investigation will be done under the campaign Shuddh Aahar, Milawat Par Vaar' in Rajasthan on the initiative of the Chief Minister. In this, all the big temples where prasad is made daily in the form of bhog, the quality of various food items will be checked."

So far, 54 temples in the state have applied for a Bhog Certificate. Besides the quality of prasad, hygiene will also be inspected. The concerned departments of Rajasthan have been informed accord-



ingly. This campaign will be run by a special team.

Food Safety and Standards Authority of India (FS-SAI) launched a certification scheme for Bhog under the "Eat Right' initiative. Under this scheme, vendors selling prasad and food items at religious places are given certificates. This certificate is given to temples and religious places that follow food safety standards and hygiene standards. So far, 54 religious places and temples in Rajasthan have been registered

for the Bhog Certificate by the Food Safety and Drug Control Department, Jaipur. Moti Dungri Ganesh Temple of Jaipur is the first religious place to receive a Bhog Certificate. Prasad given at a religious place that has received this type of certificate vouches for the standards and quality assurance of FSSAI. This certificate is renewed after an audit every six months. For the certificate, the team of FSSAI prepares a report after inspecting the standards of the temple kitchen.

Delhi court frames rape charge against self-styled godman Daati Maharaj

SETTING the stage for trial, a court here has framed the charges of rape, unnatural offences and criminal intimidation against self-styled godman and preacher Daati Maharaj and his brothers, Ashok and Arjun, on Friday.

"Order on charge passed and charges framed against accused persons accordingly," said the online daily status of Additional Sessions Judge (Special Fast

Track Court) Neha.

The court, meanwhile, discharged another of Daati's brothers, Anil, in the matter. After the court framed the charges on Friday, the accused pleaded not guilty and claimed trial. The court has posted the matter for submitting evidence for the prosecution on October 18.

Pradip Tiwary, the victim's counsel, said the court framed charges against Daati Maharaj alias Madan Lal Rajasthani and his brothers, Ashok and Arjun,

under Indian Penal Code (IPC) sections 376 (rape), 377 (unnatural offences), 506 (criminal intimidation) and 34 (common intention).

A complaint of rape was filed by a disciple of Daati against the self-styled godman and his three brothers -- Ashok, Anil and Arjun - at the Fatchpur Beri police station in South Delhi on June 7, 2018 and an FIR was registered on June 11 for the alleged offences of rape, unnatural sex, molestation and common intention under the IPC.


On June 22, police questioned Daati, who was charged with raping the disciple at his ashrams in Delhi and Rajasthan. The case was later transferred to the crime branch, which filed its chargesheet on October 1.

On October 3, 2018, the Delhi High Court transferred the matter to the Central Bureau of Investigation (CBI), saying the manner in which the Delhi Police carried out the probe "cast a shadow on the investigation".

Deprecating the Delhi Police's conduct, it said the accused was not arrested even after recording the complainant's statement before a magistrate under section 164 of the Code of Criminal Procedure (CrPC).

On October 26, the agency registered an FIR against Daati and his three brothers for allegedly raping the 25-year-old woman at his Ashram in Fatehpur Beri on January 9, 2016 and for having unnatural sex with the victim.

▲ make laddu in Tirupati temple has erupted into a massive row, Reports emerged that a testing lab had found the presence of "beef tallow", "lard" relating to pig fat, and "fish oil" in the ghee used to prepare the laddus. AP CM Chandrababu Naidu alleged that ghee contaminated by "animal fat" had been used to make the laddu during his predecessor Jagan Mohan Reddy's tenure but there is lack of clarity on what Reddy's role was in the alleged contamination. The temple management claimed that its ghee suppliers might have taken advantage of lack of in-house adulteration testing facility but did not come clean on who they might be and if they had a connection to Reddy. The lab called the Centre for Analysis and Learning in Livestock and Food (CALF) of the National Dairy Development Board had issued an important caveat with its report — that there can be chances of a false positive result in cases of overfeeding of cows with feeds rich in vegetable oils or milk technologically treated and so on. But this barely landed on the public consciousness given the heightened emotions. There are uncomfortable questions such as why a lab in Gujarat ran the tests when Hyderabad has venemted labs.


The failure of crops in the South African countries and the failure of the international community to supply foodgrains to the needy in the drought-hit areas do not justify the mindless mass butchering of elephants,

India may miss 2030 child health targets

TNDIA is likely to miss the ■2030 deadline for achieving sustainable development goals (SDG) related to children's health - reducing the prevalence of stunting, and under-five and neonatal mortality, according to the Goalkeepers 2024 report released by the Bill and Melinda Gates Foundation.

The report is based on estimates from the Institute of Health Metrics and Evaluation, United Nations Children's Fund and the World Bank. Malnutrition is the most pervasive health crisis facing the world, and is the cause of half of all childhood deaths in the world, the report says. This will only be aggravated by changing climate, it added.

"Stunting [where a child is short for his/her age] is a proxy for overall cognitive and physical underdevelopment," according to a September 2017 report by the Bill and Melinda Gates Foundation, as IndiaSpend reported in January 2018. "Stunted children will be less healthy and productive for the rest of their lives, and countries with high rates of stunting will be less prosperous."

Increased funding for nutrition and innovative solutions such as fortifying food, providing better prenatal supplements and investing in agriculture could help the world to meet the SDGs like reducing child mortality, infant mortality and maternal

mortality, said the report.

Further, India is on track to meet SDG targets on reducing maternal mortality, and has already met the target on reducing malaria incidence, data from the report

not enough to meet targets: Nine years after world leaders agreed to the 2030 deadline to end poverty, fight inequality and stop climate change, the world is off track, said the report. As of 2023, India's neonatal mortality i.e., deaths within 28 days of birth is 22 deaths per 1,000 live births. By 2030, this is estimated to decline to 18 deaths per 1,000 live births, 50% more than the target of 12. Globally, by 2030, neonatal mortality is expected to be 15.

Similarly, India's early childhood mortality or deaths within five years is estimated to decline from 35 deaths per 1,000 live births to 29, which is 16% more than the target of 25. The global average is estimated to fall to 31 deaths per 1,000 live births.

Worldwide, 23% of children will be stunted in 2030, about 1.5 times the target of 15%. India's figure is expected to be 35%. "India's targeted approach to improving child health through nutrition programs and vaccinations provides a hopeful outlook," a spokesperson for the Bill and Melinda Gates Foundation told IndiaSpend, adding

In terms of mortality,

that initiatives like Mission Poshan 2.0 are at the forefront of combating malnutrition, reaching over 95 million beneficiaries.

With more drought and heat, child malnutrition to increase: Worldwide, an additional 40 million children will be stunted and 28 million will be wasted - where a child has lower-than-expected weight for height by 2050 because of climate change, found the report. "The kids who survive malnutrition never truly escape it," Bill Gates, co-chair of the Foundation, wrote in the foreword to the report.

A 1% loss in adult height due to childhood stunting is associated with a 1.4% loss in economic productivity, according to World Bank estimates. Stunted children

earn 20% less as adults compared to non-stunted individuals, we had reported. Further, experts say that early childhood malnutrition increases the risk of developing non-communicable diseases such as hypertension, diabetes and heart disease in adult life, as IndiaSpend reported in October 2019.

"In terms of mortality, we may meet the 2030 deadline for the SDGs, or at least not be too far off the mark, but undernutrition goals seem further off," said Dipa Sinha, professor of economics at Ambedkar University in Delhi.

In the 90 days between June and August 2024, about 19.5 million Indians experienced above-average temperatures for at least 61 days. Children are vulnerable to climate change even before they are born: Climate-related hazards can increase the risk of low birth weight, increase the risk of death due to air pollution and extreme heat, and intensify infectious disease like malaria. Climate change will also increase food insecurity and contamination.

"Drought-like situations have impacted agriculture, leading to compromised nutrition for children," said Subhendu Bhattacha-Director, Research and Knowledge Exchange and Child Rights and You. "They are particularly vulnerable to extreme heat because their bodies heat up faster and cool down slower than adults."

Lack of nutrition and the risk of contracting TB are interrelated. The lack of nutrition makes a person more susceptible to TB, while having TB increases the chance of malnutrition. Malnourished patients also find it harder to recover from TB.

India's containment of TB is more or less on par with the 2% fall in the incidence rate globally, we had reported in May 2023, However, the decline is well below the 10% drop the World Health Organization had targeted to be achieved by 2025, and the 17% decline projected for the following decade, to end TB by 2035. The SDG sets a target of

universal access to family planning. India has a 76% demand for family planning, but it also has a 9% unmet need for family planning, according to the National Family Health Survey, 2019-21 (NFHS-5). Unmet need reveals the gap between a woman's reproductive intentions and her contraceptive behaviour. The gap could be caused by lack of access to contraceptives, but it could also reflect cultural, social and religious beliefs that forbid contraception or do not allow women to take independent decisions about family planning, as we reported in July 2019.

Women bear the brunt of contraception in India. as IndiaSpend reported in 2020. Female sterilisation

is the most popular form of contraception in India, we reported in July 2024. While two in three women reported using any form of family planning methods in NFHS-5, more than half of them - or 37.9% of married women in the reproductive age group - chose sterilisation. India is also expected to fall short on a composite index of universal healthcare, with an estimated score of 56 compared to the world average of 62.

Need to fund health, nutrition

Undernutrition causes \$3 trillion in productivity loss by stunting children's physical and cognitive capabilities, according to the report. Malnutrition costs low income countries 3-16% of their gross domestic product, which is equivalent to a permanent 2008-level recession for them.

More economists should track malnutrition because poor nutrition can hamper economic growth, the report said.

Covid-19 may have undone decades of progress on childhood nutrition, as we reported in December 2020. In January 2022, we reported that India underspends on nutrition.

About 40% of all children in India live in severe food poverty, meaning that they eat two or fewer food groups out of the eight recommended.

India, along with Ethio-

pia, Kenya, Nigeria and Tanzania, can protect 109 million people from being stunted by increasing dairy productivity, found the report. Other solutions being implemented worldwide include double fortifying salt and other pantry staples and providing supplements that contain essential vitamins and minerals to pregnant women.

"Relying on fortification is a piecemeal approach. For sustainable improvement in nutrition we need more comprehensive interventions. Wages and livelihoods affect stunting much more than supplements and fortified food," said Sinha. More recent research sug-

gests that the gut microbiome can help with absorption of nutrients, according to the report. "Studies have found that providing pregnant women with micronutrient supplements can help babies gain additional weight and develop healthier gut microbiomes, preventing malnutrition and improving overall health outcomes," explained the spokesperson from Bill and Melinda Gates Foundation.

Challenges on path to a developed India

THE health of any complex man body or a nation's economy, can't be determined by its size, what matters is the shape it is in. GDP growth has become the dominant measure of the health of all economies. Gross Domestic Product is total market value of goods and services produced by a country's economy during a specified period of time, including all final goods and services.

India is going to become a developed country within a decade or so as our rising GDP trends show. But there are certain impediments that need to be addressed towards realising a developed India.

Inequality

Economist Jayan Jose Thomas said that lacklustre record of India's development strategy in the early decades after independence was not on account of the government doing too much in the area of technology building, but because the government couldn't intervene effectively to ensure social developments. Independent India didn't implement a successful programme of land reform. Ownership of assets continues to be very low among the socially backward communities, led them to disadvantages due to the lack of assets that translated into hurdles in acquiring education, and also the country underinvested in basic education for the masses. This consequently resulted in inequalities in the social spheres and better paying jobs going more to the social groups who have had greater access to higher education.

Economic growth

The persistence of inequalities has negatively impacted industrial and economic growth in India. Domestic demand has been lopsided, coming as it does largely from the upper income classes of the population. This has slowed down the growth of manufacturing of high-quality, mass consumption goods. In contrast with the East Asian countries like Japan and China, where by 1950's itself, land reforms and other measures had created a relatively egalitarian social structure, which formed the

basis for progressive economic and social changes in the later years. After independence, in the early decades, India's efforts in building III's, IIM's, establishment of industrial production like steel, fertiliser, drug production etc., with state support was the right decision. The country should reinstate such efforts, if it has to stand a chance in fast growing economic fields.

The real economy of a nation includes its natural capital assets - all of the gifts from nature that we don't have to produce - are immensely valuable but not marketed, ecosystem services provide us with those assets. These services include climate control, water supply, storm protection, recreation etc. These natural assets have been estimated to contribute significantly more to the human well-being than all na-

tional GDP combined. But we

are overlooking these contri-

butions which has led to mas-

sive depletion of these assets.

Unaccounted ecosystem

Uneconomic growth We are in the state of uneconomic growth. An ecological economist, Herman Daly is of the view that the country is increasing production at the expense of resources and well-being. The decline in well-being, associated with extended economic growth to arise as a result of the social and environmental sacrifices made necessary by growing encroachment on the ecosys-

Unemployment

mental in long term.

A group of economists have mentioned that the country is facing serious problem of unemployment. Being developed is not enough, the wealth needs to be well dis-

tem, is uneconomic and detri-

tributed. Another economist mentioned that the organized sector is mechanized and automated and generates only few jobs. This resulted 94 percent of the labourforce is in unorganized sector, largely working at low wages. On eShram portal, 30 crore have been registered for employment in November 2023, and about 1.2 crore are new entrants for the jobs every year. The growth of organized sector at the expense of the unorganized sector results in rising unemployment.

Jobless growth

The country's GDP is increasing, but employment growth rate doesn't, it means we are having jobless growth. The employment challenge can no longer be met only through higher GDP growth, it has to be in consonance with the well-being of the whole soci-

According to the First Deputy Managing Director, International Monetary Fund, Gita Gopinath, to make India the third largest economy by 2027, there is a need to create 148 million jobs by 2030, revamp higher education and improve skills of workforce. She emphasised the need to undertake land reforms, improve ease of doing business and the regulatory environment, implement labour code etc. in addition, to identifying key thrust areas and states and central governments work more diligently to implement growth- oriented policies for moving ahead on the vision of

a developed nation. According to the IMF, GDP of the US and China is in the range of thirty and twenty trillion dollars, which makes half of the world's GDP. Whereas Germany falls in the range of six and that of Japan is more than four trillion dollars. In-

dia's GDP is nearing four trillion dollars. But India is the fastest growing economy in the world having overall growth rate of 7% and will be surpassing Japan within next few years, to become the third largest economy. advanced countries. India needs to revamp industrial growth, increase manufacturing, with the state support like the US and China are ravishing government support for their industries. This will help to reduce unemployment problem to a larger extent, including increasing export and reducing import, while reducing import tariff to become player in global supply chain.

In education, especially higher education should be made accessible to all including the dispossessed. The employment opportunities need to be provided based on their qualifications. India presently has skill mismatch in the workforce and needs a workforce which is much more skilled and has much higher level of education. There is need to take up land reform, a way forward to reduce social inequalities and to ensure women safety. One of the most important aspects the government should look into, to protect and conserve our natural assets. There is need to have space for advancement in technology but it should not be tilting the ground to favour automation, instead must develop safety nets and social security for its workforce.

To become a developed nation India needs to have economic growth, inclusive of all the important aspects which improve living standards of most of the population of the country, with a fair thought that developed nation is one which provides everyone with basic needs and the possibility of dignified life.


One of the 30 bridges which is a pedestrian bridge on the 'Seine River,' the lifeblood of Paris, the 'Pont des Arts' is famous for the 'Love Lock Tradition' which became quite famous in Paris, It is a very interesting and human interest belief, where couples attach padlocks to a bridge and throw away the key as a symbol of their everlasting love. Over a period, the 'Pont des Arts Pedestrian Bridge' was covered with thousands of locks, turning it into a kind of monument to romance, but in the process, the weight of these locks began to damage the bridge, leading to safety concerns. A decade ago, in 2015, authorities removed the locks and replaced the bridge's railings with glass panels to prevent further damage. Despite this, the tradition continued in other locations, and Paris is still full of romantic spots.

The Sacre-Cœur Catholic Church area located on Montmartre Hill, the highest point in Paris, became another popular location for couples to attach love locks to railings and fences around the church contributing to the city's romance culture. Sacre-Cœur Basilica is a major landmark known for its stunning white-domed architecture and panoramic views of Paris, It was built between 1875-1914 as a symbol of national reconciliation after the Franco-Prussian War and the Paris Commune.

Montmartre is a picturesque place in Paris, known for its rich artistic history, charming streets, and stunning views of the city, and once home to famous artists like Picasso and Van Gogh. The reason for the presence of love locks in this area is largely due to its romantic and scenic appeal. The Church itself is a major landmark that attracts many visitors, making it a natural spot for the love lock tradition to take root. The Church is noted for its Romanesque-Byzantine style, expansive mosaics, and the vast piazza in front, which offers one of the best viewpoints in the city.

Typically, Paris City has a Famous Prostitution Area! Historically, 'Pigalle Area' particularly around Boulevard de Clichy, has a reputation for its adult entertainment venues and has been a focal point for discussions about sex work in Paris, and has been known for its association with sex work and nightlife. Pigalle retains some of its historical character, while ensuring that the area remains safe and welcoming for all residents and visitors.

Paris streets by and large remained narrow due to historical preservation and it is said that widening would disrupt the historical and architectural integrity of many neighborhoods. The city's planning focuses on preserving the character of its historic districts, which often means maintaining existing street layouts rather than expanding them. The close alignment of buildings along streets that were designed before the advent of modern urban planning, helps create a dense, walkable urban environment. Driving or walking through Paris, it is seen that the 'Road Traffic and Parking Discipline' is unique.

To reduce road traffic and pollution, various measures were taken, such as expanding pedestrian zones, implementing car-free days, and promoting use of public transport and bicycles. Paris has limited parking spaces and enforces orderly parking practices to manage space efficiently. Double parking or zigzag parking is rare. Paris City has low use of two-wheelers unlike other cities. The strict parking regulations discourage the use of scooters and motorcycles, as finding parking can be challenging. It is a compact city making walking and cycling convenient and practical, and encourages pedestrian and cyclist mobility. Dedicated bike lanes and pedestrian zones are seen.

Paris is famous for its old-looking apartments with their grand façades, that open directly onto the streets, wrought-iron balconies, high ceilings, etc. These buildings were constructed before modern zoning laws, leading to a blend of residential and commercial uses. Their value can vary significantly depending on the location, though they still offer the charm of 'Parisian Architecture' reflecting the neighborhood's prestige, proximity to landmarks, and the level of renovation the apartments have undergone.

Their design fosters a lively, street-level environment, encouraging interaction between residents, businesses, and visitors, and promoting a sense of community and vibrancy, with shops, cafes contributing to the city's lively street life. However, Street vending and pavement shops are regulated tightly in Paris to maintain order and aesthetics. The city has strict rules governing where vendors can set up, leading to fewer such shops. Most commercial activities are concentrated in designated areas such as markets and shopping districts rather than on the pavements. This is the 'Cultural, Historical, and Artistic Richness of Paris. Can We Be the Vishva-Guru?


The expression Vishvaguru is rather tricky. It is a compound word in Sanskrit which can mean the guru for the world, or one for whom the world is the guru. We do hear claims that Bharat is the Vishva-guru, but we have to be conscious of the irony of language. A well-known verse in the Manu Smriti seems to be the inspiration for such claims. The verse says that 'the people of all lands on earth would have to learn their charitam (code of conduct) from the first-born men of this land (2-20).

Our spiritual masters rarely make this claim. Prior to Manu the Vedas said, 'let all noble thoughts come to us from all directions. The Vedic sage used the word Vishva (world), implying that we are also humble enough to receive all good thoughts from anyone in the world. Our sages acknowledged the then Greek astronomers, saying, 'they too are equal to rishis: though they are mlechhas, shastra is well protected by them'. Mlecchha referred to those who did not follow the Vedic culture.

of a civilization and the

attitude to other civilizations can be the indicators to see whether one can claim to teach anything to the world. Indian civilization is unique in this regard. This is perhaps the only civilization which asks the human being to go beyond religion and investigate the Supreme Reality for oneself. A person on this path becomes an ati-varnashrami, one who transcends the definitions of varna and ashrama. He goes beyond all identifying factors like brahmana varna or grihastha ashrama. Though the ritualistic study of Vedas was restricted to some, this knowledge was not denied to anyone. 'Go beyond the Vedas, go beyond all the

All beings or people seem as though divided, but there exists an underlying unity in all. As against this, there can be the vision to divide people into different categories. This vision is due to rajo guna.

In such a world view, with unconditional love for all, tolerance and acceptance are ingrained. It is the only means for world peace, as it does not ask its followers to impose on others in any way - either politically or spiritually. Even the idea of guru is not an imposition, because we are only holding a formula for world peace, it is for others to follow or not. One becomes a guru only when there is a disciple, but the absence of a disciple does not diminish his stature. It is for the guru to be spiritually strong so that the world feels bound to acknowledge it, if not follow.

The question of varna division comes as a counter. This division is a mere acknowledgement of the diversity in human nature in The expression Vishvaguru is rather tricky. Maratha leader Jarange-Patil's health fails on fifth day of hunger strike

Jalna (Maharashtra)

THE health of Shivba Sanghatana leader Manoj Jarange-Patil started deteriorating on the fifth day of his sixth hunger strike here on Saturday, his party leaders said.

Since Friday noon he was feeling exhausted and sickly,

and his supporters were concerned to see him lying restlessly on his stomach or not communicating with them.

Last evening, at one point, Jarange-Patil got up to address his people, but his legs didn't seem to support his weight and he suddenly fell into a heap, appearing to be motionless.

However, his aides who were around managed to catch him in time and prevented him from falling down and hurting himself.

They helped him sit upright again and after that he again took some rest at the hunger strike venue.

From Friday night, many of his alarmed followers,

some with tears in their eyes and many women seen weeping, made frantic appeals to Jarange-Patil to break his hunger strike, or at least get some medication to revive him, but he remained adamant.

Later, state Minister Shambhuraj Desai called up Jarange-Patil with the same

plea, plus many of his close aides repeatedly goaded him to get treated for his frail health, and he reluctantly agreed to do so in the wee hours of Saturday.

A medical team present at the spot immediately administered him with saline and certain medicines, which he has started taking, while going a little easy on the agitation since Saturday morning. As the hunger-strike gets

longer and the date of Maharashtra Assembly elections looms closer, Maratha groups have issued calls for a shutdown (bandh) in Beed and Osmanabad districts to express solidarity with Jarange-Patil (MNS)



Huge cache of arms & ammunition recovered

KOLKATA

A day after the Manipur government informed about the ingression of tribal militant outfits from Myanmar, the Indian Army in coordination with the state police recovered two caches of weapons and warlike stores during raids in Churachandpur, Thoubal and Imphal East.

The Army's Eastern Command, based in Kolkata, highlighted the efforts by troops to restore peace in the region, with the demilitarisation of the local population as a primary objective.

"In the first operation, a search operation was carried out a search in the heavily forested upper reaches of Thangjing Ridge in Churachandpur district. The operation led to the recovery of two 9 mm pistols along with two pistol magazines, a singlebarrel rifle, two locally fabricated rockets measuring 5.5 feet and 3 feet respectively, a modified long-range mortar, two modified medium-range

mortars, four mortar bombs, nine rounds of 9 mm ammunition, 6.2 kilograms of Grade Two explosives, and warlike stores," it was stated by the Army.

The army said that in a separate operation, acting on

specific intelligence inputs, a team of Indian Army and Manipur Police carried out a search at Changbi village, located in the fringes of Thou-

bal and Imphal East districts. "This operation resulted in the recovery of two carbines,

two pistols, a single-barrel gun, nine hand grenades, eleven rounds of small arms ammunition and other warlike stores," it was further mentioned in the statement.

On Friday, Kuldeep Singh, security advisor to the Manipur government, revealed some extracts of the intelligence report that stated how the 900 militants had split into groups of 30 each and were planning to carry out acts of violence.

He said that security forces had been directed to carry out intelligence-based operations to seize weapons and other equipment that may be used by the militants. These weapons are not among those looted from police armouries, Singh had mentioned.

Over the last 16-odd months, ever since ethnic clashes erupted in Manipur, there has been a concerted effort by militant outfits to drive a wedge between various security agencies operating in the state. (IANS)

Sibal on Tankha's defamation case

'Politicians have no right to tarnish lawyers' image'


MADHYA Pradesh High Court on Saturday conducted hearing in a defamation case against former Chief Minister Shivraj Singh Chouhan, former Minister Bhupendra Singh Yaday and State BJP President V.D. Sharma.

The case was filed by Congress Rajya Sabha MP and senior advocate Vivek Tankha, who alleged that the trio BJP leaders have made false allegations against him regarding the OBC reservation. The case was filed earlier in January 2022.

Senior and renowned advocate Kapil Sibal represented for Tankha during the hearing in the court on Saturday.

The case was heard in the court of Justice Sanjay Dwivedi. After the hearing was over, advocate Sibal said, "It's not about Vivek Tankha only, but about all the advocates who exercise their duty in the courts."

"We (Tankha) filed a petition against the Madhya Pradesh government's ordinance regarding the municipal body elections, and not against the OBC reservation quota," Sibal said talking to the press after the court hearing



in Jabalpur on Saturday.

He claimed that the trio (Shivraj, Bhupendra and VD) had told the court that case was filed on the basis of media reports, and the news reports have not quoted them line-by-line. However, the court wasn't satisfied with their reply. "This is the case between practicing lawyers and the politicians. If the politicians, who are on top posts, would make such baseless allegation and would try to tarnish a professional's image, then we have to take a stand against them," Sibal added.

Vivek Tankha, who was also present in the court with Sibal, said he was satisfied with the court's hearing.

Nine members of family in Guj attempt suicide

NINE members of the Soni family from the Kevdavadi area of Rajkot attempted mass suicide by consuming poison on Saturday. The family members have been rushed to Civil Hospital for emergency treatment.

Reports said that the Soni family - jewellers by profession - took the extreme step after traders from Mumbai withheld Rs 2.75 crore for 22-carat gold jewellery they had supplied.

Despite repeated follow-ups over the last 11 months, the payment was not made.

It is alleged that the traders not only failed to clear the dues but also issued threats to the family.

Police have launched an investigation into the case. They are examining the circumstances surrounding the family's financial difficulties and recording statements from various individuals involved.

The family has named individuals from Mumbai - Vijay Kailasji Rawal, Prashant, Mahendra, and others - as responsible for withholding the payment.

The condition of the family members deteriorated quickly after consuming the poison, and they were immediately shifted to a government hospital for treatment.

In a similar case in 2023, seven members of a family, including three children, were found dead in their apartment in Surat in what police suspect to be a case of mass suicide. The family, reportedly facing severe financial distress, left a note explaining their drastic step.

The bodies were discovered after neighbours detected a foul smell coming from the residence. When repeated knocks on the door went unanswered, the neighbours alerted the police. Upon arrival, authorities found the lifeless bodies of the family members, including a contractor, his wife, his parents, and the couple's three children, a six-year-old son and two daughters aged 10 and 13. mass)

Only a caste, economic and income census can redefine India's socio-economic landscape

India, a land of staggering diversity, continues to grap-Lple with profound socioeconomic disparities among its populace. Only a minuscule percentage of people lords over the majority of national resources, facilities, privileges, opportunities and responsibilities. A tragic irony is that those comprising SCs, STs, and OBC estimated to be around 75 per cent of the population, have over the years been victims of socio-economic and educational exclusion, deprivation and institutional atrocities.

No doubt, things have certainly improved ever since India started following the rules as prescribed in the Constitution but we have miles to traverse to achieve the goal of an inclusive Viksit Bharat for which a 2047 deadline has been fixed. It is quite possible that the Indian economy becomes a \$30 trillion economy by then but I will keep my fingers crossed so far as the inclusivity of the attributes of a developed nation are concerned. If we are really serious about making a new and inclusive India, we need to know well the socio-economic and educational conditions of different social groups in general and those who have been on the margins for decades in particular. Towards addressing this, the Union government conducts periodic census exercises that delve deep into demographic data, including caste, economic status, and income levels. These exercises are not just statistical endeavours but pivotal tools in shaping policies and interventions aimed at equitable development and social justice. However, their limitations underscore the need for a wholesome caste-economic census, a demand which has gained momentum in recent years.

Barring a few political parties, the majority are in support of a comprehensive casteeconomic-income census and fine-tuning of welfare schemes

and affirmative measures on the basis of its findings so that the idea of last mile development and empowerment is fructified in a sustainable manner.

One has to understand that caste has been a defining feature of Indian society for centuries, influencing social dynamics, economic opportunities and political landscapes. The caste census, distinct from the regular population census, will provide invaluable insights into the socio-economic status of various caste groups. It will help identify marginalized commu-

nities that

processes. By mapping the distribution and socio-economic indicators of different castes, policymakers can tailor affirmative action programs such as reservations in education, employment and political representation. 

Similarly, the economic details will capture data related to economic activities across sectors and regions and will provide a comprehensive snapshot of the country's entrepreneurial landscape, from small-scale enterprises to large industries. This granular data will aid in formulating targeted policies to support economic growth, promote entrepreneurship, and enhance productivity in an inclusive manner. Moreover, the economic data will serve as a crucial benchmark for assessing the effectiveness of government schemes and initiatives aimed at fostering economic development. By identifying growth hotspots and areas of underdevelopment, policymakers can

channel resources strategically

growth and reduce disparities between urban and rural areas. We all know well that income

inequality remains a pressing issue in India, where a significant portion of the population struggles to meet basic needs. People's income details will help us in quantifying these inequalities by capturing data on household incomes, expenditure patterns, and wealth distribution. This data will be instrumental in designing targeted welfare programmes and social safety nets to alleviate poverty and improve living standards. Moreover,



ic policies on different income groups. It will provide empirical evidence to gauge the effectiveness of poverty alleviation measures, such as subsidies, pensions, and financial inclusion programmes. By ensuring that benefits reach those who need them the most, the caste and income census will contribute to fostering a more equitable society.

I am of the firm opinion that the combined insights from caste, economic, and income census exercises will form the bedrock of evidence-based policymaking in India. They will enable them to identify vulnerable populations and prioritize resource allocation, and monitor the progress of development initiatives over time. This datadriven approach is essential for tackding chronic socio-economic disparities and advancing the goal of inclusive growth. Furthermore, the census exercises will facilitate transparency and accountability in governance by providing reliable data for public scrutiny and academic research. They will empower civil society organisations, researchers and advocacy groups to press for policy reforms that address systemic inequalities

and promote social justice. Yet one wonders why some people are opposed to conducting a comprehensive census exercise, which will be an indispensable tool for promoting inclusive development, social cohesion and ensure equitable distribution of opportunities. By harnessing the power of data, India will chart a path towards a more just and prosperous future for all its citizens.

Let there be no doubt that only a holistic empowerment of all sections of society will help us address the colossal issue of caste-based discrimination, which has a deep-rooted history in India, spanning millennia, shaping social, economic, and political structures across the subcontinent. Originating from ancient Vedic texts, where society was stratified into varnas based on occupation, caste divisions evolved into a complex hierarchical system over time, doing an irreparable damage to our social ecosystem. Over centuries, the caste-based hierarchical system became rigid, with each caste assigned specific roles and privileges. A vast chunk of the population among us faced severe social ostracism and economic deprivation. Their marginalization was not merely social but also institutionalized through practices like untouchability.

Post-independence, Constitution has certainly outlawed discrimination based on caste and introduced quota in education and employment for historically marginalized communities, aiming to uplift them but in vain. Still caste-based discrimination, deprivation and denial persist in various forms.

Economic disparities, unequal access to education, and persistent social prejudices continue to affect millions, challenging our collective quest for social equality and inclusive development. Efforts towards social justice and empowerment remain crucial in ensuring a more equitable future for all Indians.

Investment in clean energy has accelerated since 2020, and spending on renewable power, grids and storage is now higher than total spending on oil, gas and coal.

The rise in solar and wind deployment has driven wholesale prices down in some countries, occasionally below zero, particularly during peak periods of wind and solar generation. This lowers the potential for spot market earnings for producers and highlights the need for complementary investments in flexibility and storage capacity.

Investments in nuclear power are expected to pick up in 2024, with its share (nine per cent) in clean power investments rising after two successive years of decline. It is projected to reach \$ 80 billion in 2024, nearly double the 2018 level, which was the lowest point in a decade.

Grids have become a bottleneck for energy transitions but investment is rising and spending is expected to hit \$400 billion this year, driven by new policies and funding in Europe, the United States, China and parts of Latin America. Investments in battery storage are ramping up and are set to exceed \$50 billion in 2024. But spending is highly concentrated.

Investment in energy efficiency and electrification in buildings and industry has been resilient, despite the economic headwinds. But most of the dynamism in the end-use sectors is coming from transport, where in-



vestment is set to reach new highs in 2024 (+eight per cent compared to 2023), driven by strong electric vehicle (EV)

The rise in clean energy spending is underpinned by emission-reduction technological gains, energy security imperatives (particularly in the European Union) and an additional strategic element: major economies are deploying new industrial strategies to spur clean energy manufacturing and establish stronger market positions. Such policies can bring local benefits, although gaining cost-competitive foothold in sectors with ample global capacity like solar PV can be challenging. Policy makers need to balance the costs and benefits of these programmes so that they increase the resilience of clean energy supply chains while maintaining gains from trade.

In the United States, investment in clean energy is expected to increase to over \$300 billion in 2024, 1.6 times the 2020 level and well ahead of the amount invested in fossil fuels. The European Union spends \$370 billion on clean energy today, while China is set to spend almost \$680 billion, supported by its large domestic market and rapid growth in the so-called "new three" industries: solar cells, lithium battery production and EV manufacturing.

With the large number of resources and funds being diverted towards renewable energy innovations, ensuring those resources are allocated properly is a must. Avoiding inefficiencies and unexpected costs should be examined in every process of energy transition. One of the main factors of unforeseen costs is poorly designed systems, which can come from a large variety of sources, such as poor geological conditions or inefficient power grid designs.

The human element of the

transition should also not be forgotten. Attention needs to be paid to workers in the fossil fuels industries, such as oil workers, coal miners, and gasoline-car factory workers, whose livelihoods depend on these jobs. It is estimated that 2.7 million jobs related to fossil fuel industries globally will be lost. This does not mean that green energy should be abandoned, rather, a fair transition should be ensured for all. Another cost to consider is the waste produced by renewable energy technology and its supporting infrastructure. The waste from renewables globally is expected to increase by 3,000 per cent for solar, 200 per cent for wind and 600 per cent for energy storage by 2030 from 2020. The waste would accumulate from the replacement of end-of-life systems, It was reported that Vietnam would potentially generate 3.1-3.5 million tonnes of solar PV waste and 1.5-5.1 million tonnes of wind turbine waste by 2050.

Over 90 per cent of renewable energy waste is recyclable and contains high-value minerals. However, the current issue with renewable energy waste is the lack of recycling infrastructure, making unfeasible. economically Through investment, these challenges can be overcome, and a circular system of clean energy components can be created. Renewable energy recycling will be a large market, with solar alone estimated to be worth \$2.7 billion by 2030.

By the end of 2050, it is expected that the ROI from the \$131 trillion global investment in energy transition will be about \$61 trillion.
