## **CRANES REPLACE 'NO IMMERSION' BANNERS ON TANK BUND**

BANNERS screaming "No idol immersion on Tank Bund" appeared along the road around Hussainsagar last week. They were set up by the GHMC and Hyderabad police. They referred to Telangana High Court orders issued in 2021, banning immersion of PoP idols in the lake.

On Sunday evening, the posters were replaced with over a dozen cranes on the Tank Bund stretch for immersion of idols on Tuesday.

Iron grills that were installed have been removed to make way for placing the cranes. The change of scene confirmed that as usual, like previous years, the centralised Ganesh idol immersion will take place on Tank Bund, NTR Marg, Peoples Plaza and Necklace Road on Tuesday in a hassle-free manner.

During the past one week, devotees from various parts of the city thronged the Tank Bund stretch. They were seen leaving their idols on the boundary wall of the lake as they were not able to immerse them in the lake because of iron grills.

Hyderabad Mayor Gadwal Vijayalaxmi told *TNIE* that the state government has always arranged cranes on the Tank Bund a day before the idol immersion. "The same is done today. There is nothing new and around Hussainsagar."

this has been happening for the last few years. The state government wanted the festivities to be held in a cordial, joyous and peaceful manner," she said.

When asked, GHMC Commissioner Amrapali Kata avoided the issue and said "no comments".

The Bhagyanagar Ganesh Utsav Committee (BGUS) has said that they would not accept any attempt to stall the idol immersion in Hussainsagar. They even threatened to launch an agitation if proper arrangements were not made for the immersion of idols.

Hyderabad in-charge and Transport Minister Ponnam Prabhakar even visited the Khairatabad Ganesh pandal and Tank Bund to inspect the preparations for the immersion. He appealed to devotees to celebrate the festival peacefully.

The procession of the 70-foottall Lord Ganesha idol in Khairatabad will commence on Tuesday morning and it will be immersed in Hussainsagar by afternoon at Crane No. 4 on NTR Marg Road.

The GHMC commissioner said, "About 15,000 GHMC staff members have been drafted to facilitate the immersion. Ten control rooms have been established to resolve any issues. It has deployed 450 cranes

#### **CM REVIEWS PREPARATIONS FOR IMMERSION**

Hyderabad: In view of Ganesh idols immersion, Chief Minister A Revanth Reddy on Monday instructed the police department to effectively supervise and monitor the immersion at the Tank Bund as well as important Ganesh pandals and lakes. The chief minister chaired a review meeting with senior officers at the Command and Control Centre on the arrangements for the immersion. During the meeting, Hyderabad CP CV Anand informed the chief minister that the immersion process was being monitored with the help of 733 CCTV cameras across Greater Hyderabad. Along with monitoring, the chief minister suggested that the staff be given instructions and alerts from the command control every hour. He directed Anand to focus on sensitive areas. The chief minister also asked the city police chief to maintain a record regarding blind spots and hot spots.

New rule for Balapur Ganesh laddu auction

THE auction of Balapur Ganesh laddu, which attracts attention from all over the country, will see a new rule this time. All those who want to participate in the auction of the 21-kg laddu on Tuesday will have to deposit money equal to last year's bid amount with the Balapur Ganesh Utsav Committee. Earlier, only outsiders were supposed to deposit some amount and register their names to bid for the laddu while locals of Balapur were exempt from this condition.

The successful bidder from Balapur was given one year time to pay the entire amount.

Last year, the laddu had gone under the hammer for ₹27 lakh and those wishing to bid for the prasadam this time have to de-

posit an amount equal to this. The enthusiasm is high among the devotees over this year's auction. With each passing year, more and more devotees from two Telugu states make a beeline to grab the popular Balapur Ganesh laddu. As the laddu is gaining popularity every year, this year it is expected to be auctioned for ₹29₹30 lakh. Believed to bring good luck to the successful bidder, Balapur laddu has been the centre of attraction for the past two decades during the Ganesh festivities.

Before the auction begins, the Samithi takes out a Ganesh procession at around 5 am in the village after performing a puja. The procession passes through the lanes and bylanes of Balapur village for about three hours and reaches the temple at 9 am. The auction starts soon after. The bidding will go on for up to 10-15 minutes. The upset price is fixed by the committee at ₹2,100.

Last year the laddu was bagged by real estate businessman Dasari Dayanand Reddy from Turkayamjal.

The tradition of laddu auctioning was started in 1994 by members of local BGUS. Kolan Krishna Reddy, a native of Balapur, had bidden it for ₹450. By and by more people scrambled to grab the laddu as it was believed to have brought luck to the winners and was auctioned for a record ₹17.60 lakh in 2019. After bidding, the winner distributes it among his close friends and family.

## Water camps at 122 places; 35L sachets to be distributed: HMWSSB

THE Hyderabad Metropolitan Water Supply and Sewerage Board (HMWSSB) has made adequate arrangements to provide drinking water to devotees coming for Ganesh immersion

#### on Tuesday.

Speaking at a teleconference with CGMs and GMs on Monday, HMWSSB Managing Director K Ashok Reddy said that 122 water camps are being established at various immersion points. He added that special camps are being set up at Tank

Bund, Telangana Secretariat and other places.

"Apart from the camps, 35 lakh water sachets will be made available to the devotees and fresh water will also be provided in water drums at the required places," Ashok Reddy said. Further, the director said that

nodal officers have been appointed to manage and monitor the water camps established for immersion. Moreover, a route officer has been appointed to monitor the places. Officials have been advised to remain alert for the next 72 hours.

Ashok Reddy directed the of-

ficials to take steps to check sewage overflow problems in the areas where procession routes are identified. He said sewer jetting machines should be made available and asked them to coordinate with the police, GHMC and management committees to avoid any problems.

Arrange enough ambulances, health camps in city: Minister

Hyderabad: State Health Minister Damodar Rajanarasimha has instructed officials to arrange enough health camps and ambulances during Ganesh immersion. The minister asked to establish 30 health camps along with doctors and nursing staff in various areas across the city where the immersions will take place. It is reported that ambulances will be available at the camps to address emergency cases. The minister also instructed the officials to be alert and provide medical aid to tourists and devotees flocking at Tank Bund during the festivities.

Sridhar Babu said, "With facilities like Laurus Labs' new manufacturing and R&D centers and 3GV, we are not just creating world-class infrastructure but also fostering an environment that nurtures innovation and collaboration."

## Axe falls on Kolkata's top cop

Didi accepts demand of agitating doctors after first meeting; 2 other babus to be replaced

WEST Bengal Chief Minister Mamata Banerjee on Monday accepted three of the five demands of the agitating junior doctors, including the transfers of Kolkata police commissioner Vineet Kumar Goyal, following their first meeting at her Kalighat residence to resolve the RG Kar standoff.

A new commissioner of Kolkata Police will be announced at 4 pm on Tuesday, she said. Mamata had earlier refused to budge on shifting him, reasoning she needed him till the puja festival is over. But

"Goyal did not wish to continue in his position," she informed. "We have decided to remove Kolkata Police's deputy commissioner of north division as well," she added.

She also accepted the demand to replace the director of health services and the director of medical education. As for the other demands, a panel headed by Chief Secretary Manoj Pant will look into

them, she said and urged the medicos to end their agitation.

Mamata claimed the talks were fruitful as nearly 99% of the demands were accepted while reiterating that no punitive action will be taken against the doctors who join duty.

After four unsuccessful attempts, protesting junior doctors participated in the meeting that was scheduled at 5 pm but began at 6.50 pm and ended around 9 pm. Both sides took two more hours to finalise the minutes of the meeting.

"Forty-two agitating doctors and chief secretary Manoj Pant

I would appeal to the junior doctors to come and sit for the talks. Every issue can be resolved through discussions. And we must strive to find a solution —Mamata Banerjee

signed the minutes of the meeting," Mamata said. Both sides got copies of the minutes.

The medicos have been on protest demanding justice for the rape-murder of a trainee physician at the RG Kar Medical College on August 9. Escorted by a pilot police vehicle, the junior doctors arrived at Mamata's home at 6.20 pm.

Meanwhile, the CBI interrogated RG Kar's former principal Sandip Ghosh and police officer Abhijit Mondal together in connection with the rape and murder case. They were asked about their activities on August 9 immediately after they learnt about the death. **P8** 

ers looted the state for 10 years, enjoying power while accusing others of family rule. Referring to BRS' objection over the installation of a Rajiv Gandhi statue, he said: "You built a farmhouse and Pragati Bhavan on 1,000 acres. Ten years weren't enough to install the statue of Telangana Talli?"

On Monday, Revanth unveiled the statue of the former prime minister in front of the Secretariat. Recalling the legacy of Chakali Ilamma, a key figure during the Telangana Armed Struggle, Revanth said that Ilamma had declared that *gadis* (forts) should be liberated from the doras (feudal lords). Drawing inspiration from her, the chief minister pledged that KCR's farmhouse would soon be filled with *jilledu* (milkweed) plants and said the Congress

#### Will get statue shifted to Gandhi Bhavan: KTR

BRS working president KT Rama Rao on Monday expressed strong indignation over the Congress government installing a statue of Rajiv Gandhi in the spot proposed for the Telangana Talli sculpture. TWO months after a gunman's bullet nicked his right ear, former US President Donald Trump was the target of yet another apparent assassination attempt on Sunday, the Federal Bureau of Investigation said.

Authorities said a man armed with AK-47 was hiding in shrubbery about 400 yards to 500 yards away from Trump as the former president played golf at Trump International Golf Club in West Palm Beach. One of the Secret Service agents noticed the barrel of a rifle pointing out of shrubbery and the force opened fire in the direction of the lurking gunman.

Upon hearing gunshots, the suspect fled the scene in a vehicle and was arrested shortly. No shots were fired at Trump. In his first reaction to the incident, Trump said, "Fear not! I am safe and well, and no one was hurt. Thank God!"

US media named Ryan Wesley Routh as the suspected gunman. He was charged with possession of a firearm as a convicted felon and possession of a firearm with an obliterated serial number at his initial court appearance on Monday. **P9**

THE Congress poll manifesto for J&K released on Mondav was silent on Article 370 but promised the restoration of statehood and the Durbar Move, rehabilitation of migrant Kashmiri Pandits, unemployment allowance and one lakh government jobs.

Senior Congress leader Pawan Khera and J&K Congress chief Tariq Hameed Karra released the manifesto on a day when the poll campaign came to an end for first of the three-

phase assembly polls. The party pledged to work towards granting statehood and restoring the Durbar Move shifting of Secretariat between

But it made no mention of the controversial Article 370 that had given J&K special status. Article 370 was read down the Centre on August 5, 2019.

The Congress also pledged to give first priority to those domiciled in J&K for jobs, govern-The party said it will take concrete steps to create a conducive ment contracts, land allocation atmosphere for the safe and dignified return and rehabilitation of the and concessions on utilising displaced Kashmiri Pandit community. It promised a white paper on corruption and establish a Lokayukta within the first 100 days to probe charges against officials allegedly involved in scams over the past 10 years.

The Congress also promised to confer all rights on Displaced Persons from 1947, 1965 and 1971 and West Pakistan Refugees, including rights to sell and transfer allotted state land and Evacuee Properties.

The party pledged to provide an unemployment allowance to qualified youth of up to ₹3,500 per month for one year. "We will fill 1 lakh vacant government posts and provide a job calendar within the first 30 days to fill

#### them," it stated.

The Congress pledged to increase allocation of free ration from the current 5 kg to 11 kg per person, as it was earlier. "Under the Mahila Samman Scheme, we will provide ₹3,000 monthly transfers to women heads of households among economically weaker sections. Under Sakhi Shakti, we will provide interest-free loans up to ₹5 lakh for every woman Self Help Group."

The party also promised ₹72 per kg as the minimum support price for apples.


Uttam says modalities for new food security and health cards by end of the month, superfine PDS rice from January

CIVIL Supplies Minister N Uttam Kumar Reddy on Monday said that the government will complete the process of framing modalities to issue new food security cards and health cards by the end of the month.

Authorities would start accepting applications by the end of October, the minister said, disclosing that the state government will supply superfine rice under the public distribution system (PDS) from January 2025.

Uttam was speaking to the media after a Cabinet sub-committee meeting to examine and



recommend the eligibility criteria and modalities for issuance of new food security cards, and health cards. The meeting was attended by

Revenue Minister Ponguleti Srinivasa Reddy, Civil Supplies Commissioner DS Chouhan



and other senior officials.

The Civil Supplies minister announced that it was decided that ₹500 bonus for paddy crop would be given from present kharif season.

The meeting primarily decided to suggest to the state gov-

ernment to introduce 'smart cards' with information embedded in QR code/ microchip/ barcode and to continue the existing eligibility criteria.

However, the sub-panel opted to remove the clause "land ownership" as it was ambiguous to the monetary income eligibility. The meeting also invited suggestions from all MPs, MLAs and MLCs across the political parties on the existing eligibility criteria. It was also decided to consider the recommendations of the Saxena Committee constituted by the Supreme Court to advise it on the suitable methodology for BPL census.

Uttam said that the previous

BRS government had deleted 5.98 lakh cards and issued 6.47 lakh cards between 2016 and 2023. He said that the previous BRS regime issued some of the cards during the byelections with the aim of luring voters.

The minister said that the eligibility criteria for PDS in Telangana is family income below ₹1.5 lakh in rural areas and ₹2 lakh in urban areas. He said that this was against the eligibility criteria of ₹1.2 lakh in rural and urban areas in Karnataka, ₹1 lakh in Tamil Nadu, and ₹1.8 lakh in Gujarat. He said that the sub-panel will study this and give its recommendations to the state government.

"That is why I quit Congress and joined the BRS," Kaushik Reddy claimed. His party colleague MLA KP Vivekananda alleged that the law and order situation has deteriorated after Congress came to power in the state. After the directive of the High Court, all the 10 MLAs who switched their loyalty from the BRS to the Congress were feeling insecure, Vivekananda said As the BRS plans to take action against the defected MLAs, the chief minister started diversionary politics and sent Arekapudi Gandhi to the residence of Kaushik Reddy, Vivekananda alleged. If the BRS does not get justice on disqualification petitions, the party leaders would meet the President, he disclosed.

## **Rajiv Gandhi statue location leaves KTR seething**

BRS working president KT Rama Rao on Monday expressed strong indignation over the Congress government installing a statue of Rajiv Gandhi in the spot proposed for the Telangana Talli statue. A spot between the Secretariat and Telangana Martyrs' Memorial was earmarked for the installation of Telangana Talli statue, Rama Rao said, declaring that the BRS would relocate the Rajiv Gandhi statue to Gandhi Bhavan if it was voted to power in next Assembly elections.

In a statement here on Monday, Rama Rao condemned the state government's "shameful act" of installing Rajiv Gandhi statue "undermining the identity of Telangana". In protest against Chief Minister A Revanth Reddy's action, the BRS working president called upon party workers and leaders to conduct 'paal abhishekam' to all Telangana Talli statues across the state on Tuesday. He also urged the BRS cadre and Telangana supporters to express their dissent against the Congress government's decision. Rama Rao stated that the entire Telangana society was deeply hurt by the installation of Rajiv Gandhi statue in a place meant for Telangana Talli. He advised the chief minister to rectify this mistake immediately saying that "otherwise, the people of Telangana would teach a lesson at the right time". Rama Rao clarified that while they had no objection to the Congress government installing a Rajiv Gandhi statue, they were opposed to its location as the spot has been earmarked for the statue of Telangana Talli. He reminded that KCR had chosen this location in July 2023 for the Telangana Talli statue, a decision widely accepted by Telangana society. The BRS working president said that his party would take steps to ensure that the Telangana Talli statue was installed in its rightful place. He reminded that the BRS had always cautioned about the Congress compromising the self-respect of Telangana for "slavery of Delhi" if it came to power. "Revanth Reddy is doing exactly that prioritising the approval of Delhi bosses over the sentiments of Telangana people. Those who compromise Telangana's identity for political gains would face political extinction," he said. The BRS working president said that BRS was the only party that would fight without compromising on Telangana's identity and interests. He said that BRS stands for the welfare of Telangana people, not for the approval of Delhi bosses and would continue to be the shield protecting Telangana's interests.

The chief minister praised Rajiv Gandhi, stating that he took charge when the nation was in crisis.

"Rajiv Gandhi gave the right to vote to 18-year-olds, empowering the youth. He is credited with amending the Constitution to provide more powers and funds to gram panchayats and introducing women's reservation in local bodies. Rajiv Gandhi also spearheaded the technological revolution in India," the chief minister said.

Taking a jab at KTR, Revanth said: "If not for Rajiv Gandhi's introduction of computers in the country, KTR might have had to sell idlis and eggs in Guntur or tea in Siddipet. KTR has reached this level because of Rajiv Gandhi's vision, yet the BRS leadership remains arrogant despite having lost power in the state."

He then issued a challenge to those threatening to remove Rajiv Gandhi's statue: "Let them come. I will see what

### Notices to Revenue officials in contempt plea

The case was filed by Ali Bin Mohammed Bhakan, who claims ownership and possession of land in Bum Rukun Dowla village, Rajendranagar mandal. The petitioner alleged that the authorities wilfully disobeyed court orders.

In an earlier writ plea, the judge had directed the respondents to refrain from interfering with the petitioner's peaceful possession without issuing proper notice and following due process of law. However, according to the petitioner, the authorities have failed to comply with these directives.

Senior counsel L Ravichander argued that the respondents' non-compliance amounted to contempt of court. In light of this, Justice Reddy ordered notices to the authorities and adjourned the matter for further hearing.

### Plea against order on land record corrections junked

bench of the Telangana High Court has upheld a deci-

sion of a single judge in a land dispute case dismissing  $\lambda$ a writ appeal filed by one Sagi Hanumantha Rao.

The appellant claimed rights to over 64.5 acres of agricultural land in Kondapalli village, Gangadhar mandal of Karimnagar district, through his mother, who he said purchased it in 1963. However, the names of some individuals were wrongly entered in the possessory column of the land records, Hanumantha Rao said.

The government pleader, however, argued that the appellant's mother had approached the RDO for corrections after a prolonged delay of 57 years. The special tribunal had rightly dismissed her appeal, and the single judge had correctly confirmed this decision.

The bench agreed with the single judge's assessment and dismissed the writ appeal. The appellant was granted the liberty to approach the competent civil court to ascertain his title and possession over the subject property if he so desired.

## Expansion of Hyd-Vij highway to start soon

DEPUTY Chief Minister Mallu Bhatti Vikramarka on Monday revealed that the state government aims to add an additional 40,000 MW in Renewable Energy (RE) by 2035.

Vikramarka said that the state government was developing a comprehensive renewable energy policy to ensure sustainable, reliable and affordable power, promote RE projects and attract private investments. Addressing the Global Re-

newable Energy Investors Meet and Expo in Gandhinagar, Gujarat, Vikramarka said that with over 300 days of sunshine,

Telangana has an estimated solar potential of approximately 26.4 GW. Stating that Telangana was one of the top windy states in India, he said that there is wind potential of approximately 54 GW at 150 meters.

"The state has two major hydro projects with pump opera-

tions in Srisailam and Nagarjunasagar. There is further potential to undertake Pumped Storage Projects (PSP), utilising reservoirs or lift irrigation

projects or abandoned mines etc. Other RE potential includes green hydrogen, geothermal and mini-hydel," the deputy CM added.

He said: "India has set an ambitious goal of adding 500 GW of renewable energy capacity,

and Telangana, with its dynamic economy and thriving industries, including IT, pharmaceu-

Announcing that the state government was formulating the comprehensive renewable energy policy, Vikramarka said that the key features of this policy include investment incentives such as tax benefits and subsidies, single-window clearances, transparent resource allocation and procurement guidelines, a robust infrastructure plan for transmission and grid connectivity. The state is also promoting partnerships with research institutions, incentives for RE manufacturers, he add-

ed. He urged the investors to ioin the "Telangana Mission".

"The upcoming initiatives of the government such as Artificial Intelligence City (AI City) and Future City centering around sustainable technologies as well as the Regional Ring Road (RRR) connecting key industrial corridors, as well as the Musi Riverfront Development Project, are expected to drive the energy growth further. Telangana's abundant resources, its skilled workforce, and pro-business initiatives such as TS-iPASS, offer compelling opportunities for companies in the renewable energy sector to thrive," Vikramarka said.

## Jani used influence to prevent victim from getting hired: FIR

Meanwhile, taking to X, singer Chinmayi Sripada said, "Jani Master basically started abusing this girl when she was a minor... I truly wish this girl all the strength to fight through this."

The complainant said that Jani Master ransacked her home, vandalised her vehicle, sent threatening parcels and even sent unknown men to intimidate her. She further claimed that he pressured her to convert to his religion and marry him, and that his wife had also assaulted her at her residence. On one occasion, he allegedly grabbed her hair and smashed her head against a mirror inside a vanity van.

The woman also stated that Jani Master used his influence in the industry to prevent her from getting hired for projects, depriving her of job opportunities. Initially registered as a zero FIR, the case was later transferred to the Narsingi police for further investigation. It was registered under Sections 376 (2)(n) (repeated rape), 506 (criminal intimidation) and 323 (voluntarily causing hurt) of the Indian Penal Code (IPC).

#### **Recently conferred** national award

Jani Master began his career

as a choreographer in 2009 and has worked in over 80 films, including Eega, Jai Ho, Baahu*bali: The Beginning* and *Geetha Govindam*, collaborating with stars such as Rajinikanth, Salman Khan, Prabhas, Ram Charan, Jr NTR, Vijay Deverakonda, Ravi Teja, Nani and Allu

Arjun. The choreographer was recently conferred a National Award for his work on the song 'Megam Karukkatha' from the 2022 film *Thiruchitrambalam*, sharing the award with Sathish Krishnan.

## Chikungunya bigger menace than dengue at present, say doctors

178 chikungunya cases reported in TG between January and August

FOLLOWING the dengue panic at the beginning of this year's monsoon, chikungunya has now turned into a bigger menace in terms of vector-borne diseases in Hyderabad. As per the official data of the state health department, 6,405 dengue,178 chikungunya, 200 malaria and 6,192 fever cases have been recorded in Telangana from January to August 31.

Although influenza continues to plague the city with colds, coughs, fever, and body aches, chikungunya is taking a bigger toll on the health of people, especially due to post-viral chronic chikungunya arthritis (CCA), also known as postviral

The post-viral arthropathy, identified by severe joint pains, can be experienced in patients for more than five weeks after recovery and can be debilitating. Doctors said that at present, mild dengue, chikungunya and influenza patients continue to show up in significant numbers daily, with 5-10 chikungunya cases witnessed every day.

Dr Naveen Kumar, consultant physician at a leading pri-

vate hospital, told *TNIE*, "We do have dengue cases coming in but right now it is the combination of dengue, chikungunya and influenza that is affecting people's health severely. Even patients with post-viral compilations are showing up after recovery from the vectorborne diseases, which is prolonging their overall recovery. The usual recovery phase of a viral infection is about one to two weeks, we are seeing pa-

#### tients taking more time to recover from the post-viral effects."

Doctors also noted that chikungunya cases this year were the most severe in the last ten years and dengue was comparatively milder.

Dr Avash Pani, consultant paediatrician at another leading private hospital in the city, said, "We are seeing at least 10 patients of viral fevers in the OPD, especially influenza and chikungunya. There are some mild dengue cases too, which are recovering at home with medications. In the days ahead, influenza will be a bigger concern and a spike is expected, although we see less dengue cases."

Doctors underscored the differentiating symptoms between dengue and chikungunya. They said while in dengue there would be a severe headache, pain behind the eyes and back pain, and chikungunya would manifest severe joint pains. Children under five years of age, pregnant women, elderly and persons with comorbid conditions were at a higher risk of viral-related complications.

## Centre's test reveals DL smart cards in TG vulnerable to data breach: NGO

A Punjab-based NGO, Raahat, has claimed that several smart cards issued in Telangana for vehicle registration certificates (RCs) and driving licences (DLs) were found to be noncompliant upon being tested by the Union government's technology partner, the National Information Centre (NIC). The

NIC functions under the Ministry of Electronics and Information Technology (MeitY).

On the sidelines of a press conference in Hyderabad, the complainant Kamal Soi, chairman of Raahat, told *TNIE*, " In June, the NIC's Smart Card Technology Division had confirmed to me that they had received 20 cards as samples with two different answers to reset

(ATR). However, upon testing with an OEM tool to identify the chip maker and model, they found that 12 cards were non-compliant for chipmaker Samsung and chip model - S3K140A.'

In May, Soi alleged that the chips in the smart cards, supplied by Colorplast India Private Limited, were manufactured in China and vulnerable

to data breaches. He said the chips did not comply with Smart Card Operating System for Transport Application (SCOSTA) guidelines.

On Monday, Soi displayed a letter from the former Transport Commissioner to the TGT-SL and a show cause notice to Colorplast dated June 24 directing the latter to submit its response within 10 days.

"But to my knowledge no response from Colorplast has been received by the department so far despite the passing of over three months," he added and demanded the authorities blacklist the company from participating in any future tenders.

*TNIE* contacted Transport department officials regarding the allegations but has not received a response yet.





#### **KEJRIWAL'S RESIGNATION DRAMA ATTEMPT TO WIPE TAINT OF CORRUPTION**

FTER doggedly refusing to demit office for more than five months since he was arrested on March 21 in an excise policy scam, Delhi Chief Minister Arvind Kejriwal announced he will soon do exactly that. The announcement came a couple of days after he was released on bail from Tihar jail by the Supreme Court. While the bench relaxed most of the bail conditions, those by a coordinate bench left him hobbled as they had disallowed him from visiting the chief minister's office and the Delhi secretariat. His powers to sign files were also severely restricted. The logical next step was to go back to the court to get the constraints removed. For, Hemant Soren was not subjected to such conditions when he got bail from the SC after 149 days in prison in a land scam. Soren had followed constitutional morality by resigning as Jharkhand CM before going to jail, though the statute does not say it in so many words. He took back the position in a blink after walking out of jail.

However, Kejriwal is anything but predictable. He sought to conjure a spectacle by claiming he would occupy the CM's chair only after the people's court cleared his name by giving him a fresh mandate. For him, electoral victory is the ultimate badge of honesty, not exoneration by the judiciary. By extension then, all elected lawmakers are clean, which is absurd. In the process, he framed the next Delhi elections as a Kejriwal-versus-the-rest contest. A product of the anti-corruption movement, his conscience curiously was not pricked when the Delhi administration went to seed in the 176 days he was in jail because no policy decisions could be taken in the absence of a functional CM. Apparently, he is trying to retake the Mr Clean label and shake off anti-incumbency, as his government's popularity is visibly slipping. Since Kejriwal seems not to trust anybody except his wife Sunita, it would be a big leap of faith if anyone else is chosen as his successor as CM. While the state is due for elections in February, he sought snap polls in November along with Maharashtra. But the poll call can be taken only by the Election Commission after the new CM dissolves the assembly and formally seeks early elections. The next few days could indicate how it would all play out.

NE day in February 2024, I was on a flight from Mumbai to Bengaluru. Sat next to me was a young girl of 14. Sitting across the aisle and travelling with her was her older brother, all of 19. The two were on their

way to see their grandmother. Ria is just into her early teens and Rishabh (names changed with permission) is just about in the last of his teenage years.

The bubbly Ria settled into her seat and immediately started chatting me up with a signature comment of a frequent flyer, "I hate aisle seats." "So, you fly a lot?" I asked, and thus began our conversation. We spoke a lot, but there is one big thing that caught my attention. At some point, I asked her a question we 'oldies' love to ask the 'youngies' (forgive the ageism, please): "What's your ambition, Ria?" Pop came the reply without a pause, "I want to be a fashion blogger."

Midway through the flight, I requested Ria if she could switch seats with Rishabh. She obliged. "What's your ambition, Rishabh?" was popped at him, too. Without a thought, Rishabh said he wanted to be a radio jockey and that he was already checking out how to go about it.

This planted a thought in my head—to check out from the larger India, quite apart from the hallowed space of air-travellers, what the ambition of the new young are. I started research across urban and rural spaces. We talk of 475 urban agglomerations in India today and a whopping 6,43,700 villages; my research covered a nano percentage of these. But it is nevertheless telling.

New India and the new Indian are divided in ambition. While urban folk by and large are now experimenting with ambition that is less solid in its intent than ever before, rural Indians have embraced the ambitions that exclusively belonged to the Gen Y and Gen Z folks of urban India.

Young Indians in urban, rural and deep-rural areas have markedly different ambitions about their careers. Thankfully, these disparate aspirations add up to a vibrant, balanced country

Cluster 2 folks in the rural markets are a whole bit different. They are getting aggressively educated and want to move away from what their parents have been doing. In this set, 41 percent want to be in services. The services they talk about are a bit different than the urban folk. Banking is big. IT, ITES and civil services, starting with the IPS. Medicine and engineering are big hits here. As is teaching. A big chunk of 51.5 percent want to be in manufacturing. There is big ambition to own their own units rather than work for others.

A paltry 7.5 percent want to be in agriculture. Even here, the desire is to be in spaces away from the food crops cultivated by their parents. Horticulture, sericulture, prawn farming and even windmills to harvest energy are the spaces being talked about.

The folks in deep-rural markets are the ones who are talking of the future in a rather futuristic manner. Their choices may sound 'rustic', but if you sit back and think, they are all about what the markets will want in the future. Out here, 56.2 percent want to be in core agriculture. They want to do better at what their fathers and grandfathers have been doing. They speak the language of 'natural agriculture'. This cluster is talking of studying the sciences. Biology, physics, maths and geography are big hits. Engineering is a passion. Joining the armed forces (the army, in particular) is an ambition. Teaching is spoken about in hushed tones as an ambition of high repute.

Then, 41 percent in this deep-rural cluster want to be in manufacturing. The idea of making life in the village self-sufficient is just about gathering steam. "Why must I go out of my village and leave my family, food and friends, when I can really stay here?" is the moot question. The accent is still on working for others. The rest seem a confused lot as of now. So the ambition of the young in the three Indias explored seem different. Fortunately for us, if you add it all up, I think we are sorted. The three parts of India are in many ways working in tandem with one another. Ours is a country that will not see imbalance. The three parts have their own self-balancing mechanisms at play. And this sure is the real balance of India of the future. What say?

#### **NEERAJ MISSED TOP SPOTS, BUT MATURED AS ATHLETE**

VER since Neeraj Chopra won gold at the Tokyo Olympics and later was crowned the world champion, he has often hit the No 1 spot in competitions. That's because of his consistency. He touched 89.94 metres in mid-2022; so 90 metres was only a natural progression. Then he was injured and had to miss the Commonwealth Games in 2022. Year 2023 was remarkable with gold at the World Championships and Asian Games. However, the latest season panned out differently as Neeraj competed in fewer events. In terms of improving his distance, there was a bit of stagnancy. What seemed effortless in the previous couple of years, seemed laboured this time. He had to rely on his last few throws to ascend the table. There have been discussions about a groin injury troubling him for some time, but Neeraj did not reveal it until the Paris Olympics, where he finished with silver behind Arshad Nadeem. He again finished second at the Diamond League in Brussels; there, too, he revealed he had fractured his left hand days before the event. It has been a year of second finishes and injuries.

But the season presented another side of Neeraj—of one who would not give up even when things are not going his way. At the Olympics, he had only one competitive throw of 89.45 m. Like most Indian medallists, he could have ended his season there. But he stood by his commitment to the Diamond League. At Lausanne, where he peaked better, he had to rely on his penultimate throw of 89.49 metres to push himself to the second spot. So, for the 26-year-old, it was a year he understood his body better, one in which he had to be mentally very strong. He might not have improved his performance, but he grew as an athlete while finding ways to navigate from tight spots.

The next season will be different. The world will see a more mature athlete. He has to take care of his adductor deciding soon on whether to go for surgery or rehab, so that he is fit for the next season. With the World Championships scheduled next September, he would get time to recover. And he would want to defend the gold he won in Budapest.

### SAVING IC 814 AND OTHER FLIGHTS OF IMAGINATION

FTER hitting a few air pockets, Anubhav Sinha's series IC 814, about the Kathmandu-Delhi Air India plane that was hijacked by ISI agents in 1999 and force-landed in Kandahar, is now cruising well.

The air pockets were due to the 'hurt sentiments of Hindus'. The terrorists were referred to by code names—Chief, Doctor, Burger, Bhola and Shankar. The last two names, associated with Lord Shiva, were 'politically motivated', they said, to extenuate the terrorist elements. The OTT platform duly issued clarifications and disclaimers. 'Sorry' is the collective password for our times.

*IC 814* is not the first such product subjected to a social media boycott: Anubhav Sinha's own Article 370 (problem: Kashmir sensitivities), Aamir Khan's Lal Singh Chaddha (majority community unfairly seen as intolerant of minority rights), Akshay Kumar's Raksha Bandhan (adverse remarks on sanatan dharma), Ranbir Kapoor's Brahmastra (hero's meat-eating habits in real life pitted against the character he portrays), and Shah Rukh Khan's Pathaan (SRK being 'partial' to Pakistan in the past).

As for the efforts in cancellation sponsored by the liberals: Sandeep Reddy Vanga's Kabir Singh (toxic masculinity), Vivek Agnihotri's The Kashmir Files (gaslighting the Muslim community), Sudipto Sen's *The Kerala Files*, (exaggerating the threat of love jihad), Reddy Vanga's Ani*mal* (toxic masculinity), and Vinay Sharma's JNU (politically unfair and regressive), to name a few recent instances. A cancellation call is a drumbeat of execution by other means. The underlying motive is always to censor imagination. The objections are limited to political, religious or cultural content. It is rarely about how these movies triumph or fail as art. The idea of cancellation, pioneered into existence primarily by the liberals and now resorted to by the right, is a movement away from aesthetics that's a fundamental condition of the arts. The Kashmir Files' problem, for example, is not so much about truth or its distortion, as it is not a documentary. It is the grossness of form. The poor aesthetics generate distaste, not catharsis. Leni Riefenstahl was a Nazi propagandist, but her Triumph of Will is still art. The culture of cancellation, pioneered by the political and cultural left as a corrective movement and now equally weaponised by the religious and cultural right,

is effectively thought-policing. It does not respect the idea of imagination. It resists the idea of the idea. This is an Indian endemic. If patriotism for the right is a means to justify the shackling of the imagination, political correctness for the left serves pretty much the same purpose. Both converge and shake hands on censorship.

Art's purpose is rarely catechism and mostly inspiration. It is the forum where

is the return on his investments in six months. Even in traditional technologies, from cars to computers, roads to rockets, India makes do with borrowed imagination. Besides the idea of satyagraha, what might be a reasonable modern Indian invention?

Why should the general run of our movies be any different? Almost all movies mentioned here fail because they dare not be beautiful, or experientially transformative. Yet, we conduct protest marches in the cause of free speech. Well, we cannot have free speech in a culture phobic of imagination.

Year 2047 is the magic moment when India is supposed to emerge as a fully developed nation. The BJP and RSS believe we were once a great nation—especially in the Gupta period (320-550 CE). This is not without substance.

In a recently-published excerpt from his latest book, The Golden Road: How Ancient India Transformed The World (which I am yet to read), William Dalrymple talks about the great contribution that Aryabhata (476-550 CE) and Brahmagupta (598-670 CE) made in mathematics. I cannot but observe that this endorsement of the Indian past from Dalrymple, a die-hard liberal, would warm the cockles of the Hindu heart. Especially since the narrative is couched in the currently-fashionable language of apologia flowing from the white male guilt of the coloniser. But assuming our future, after a fashion, is in the past, a sophisticated return to it still cannot account for the great gaps in the Indian imagination that once invented the 0, but then lost count. In the 1980s, Allan Bloom's The Closing of the American Mind attacked the US university system that encouraged an approach to scholarship based on moral relativism as it undermined critical thinking. Bloom uncannily anticipated the reigning woke culture. Foreign invasions or otherwise, the Indian mind has been in closure for over a thousand years. It is terrified of the art of ideas. IC 814 was rescued, but its representation as an idea remains endangered.

#### NURTURING YOUNG ENTREPRENEURS

HE launch of Bhaskar (Bharat Startup Knowledge Access Registry), a digital platform for the country's startup ecosystem, is a welcome move. ## 'Collegium good. Pool of women judges should expand'

Justice (retd) Hima Kohli recalls her enriching experience in SC, speaks on collegium system, pendency of cases and what it means to be a woman judge

HE day she demitted office as the chief justice of the Telangana High Court, she was promoted to the Supreme Court in 2021. Now retired, Justice Hima Kohli has been described as a "people's judge," a "fierce protector of women's rights" and a "symbol of women's empowerment." In an interview with **Suchitra** Kalyan Mohanty, the judge spoke on a range of issues the judiciary is grappling with. **Excerpts**:

You served as the Supreme **Court judge** for almost three years. How do you describe it? Three years is

very brief period to be able to the court for a longer time. contribute as effectively as one should have. I took oath as a judge of the apex court virtually on the eve of my demitting office as a judge of the HC. I'm grateful that I was considered by the collegium headed by CJI N V Ramana (retd) to be elevated to the SC, along with eight of my other colleagues. Had I stayed a little longer time in the

Supreme Court, I could have perhaps made more effective contribution. I did my best in those three years. It was a very enriching experience.

Judges, lawyers and people have described you as one of the finest judges. As an SC judge did you get enough time serve the cause the justice? I think whatever time one gets, one should make the most of it. I would think that by the time many of us en-

ter the Supreme Court, we are left with about four years before we officially retire. Maybe, we need more time to contribute to

#### You became the first woman CJ of Telangana HC. How do you see your tenure?

Telangana was carved out of Andhra Pradesh. Their courts were common; till about 2019, the high court was unified. It was an enriching experience for me, as the first woman CJ and the second CJ of that state.



A huge pendency of cases was a daunting task. When I went in, I was the only woman judge. By the time I left, a request had gone to the SC to increase the number of judges. I requested the then CJI Ramana to expedite the process. Fortunately, it was during my tenure that the judge strength went up from 24 to 42. This was one of the steps to handle the prolonged litigation period.

It was a landmark day for the judiciary when you took oath, along with two more women judges in the SC on August 31, 2021? How was your experience?

It was the first time in the history of SC that nine judges took oath together from different states, from different HCs. It was a chance that we were three women who took oath together. That was also the first

time in the history of SC we bonded well among us. I said in my farewell speech that we, nine of us describe ourselves as V9 (Victory 9) and had a special bonding, almost like batch mates. We worked together, sat on benches together from time to time, and have carried that relationship forever.

You delivered 39 verdicts and were a part of 207 benches, during your tenure as the SC Judge. You are praised as a "fierce protector of women's rights." Your reaction.

People's perception is important. However, I certainly think that the voice of woman should be heard more effectively. They carry with them a different experience on the bench.

How would you describe the SC collegium's role in giving a bigger role to women in the judiciary?

The question of more women joining the higher judiciary would arise when the collegiums in different state HCs take it into consideration while shortlisting names. The important part is that there should be

enough women in the pool of selection. That pool must expand. Till that happens, you can't have more women coming into judiciary. The point is when it comes to high courts and the Supreme Court, the pool shrinks. It will take time for more women to reach the higher echelons of judiciary.

**During your tenure in Delhi** and Telangana HCs or an SC judge, was there any political pressure on you? I haven't come across any such occasion where I could be pressurized. In any case, I don't think anybody had the guts to approach me with any kind of pressure. People kept a respectful distance. Whatever I did, I did it with a free mind and with an assurance that it was within the four corners of law. Let us not forget that a judge is answerable to his conscious.

Is it the best option to appoint judges to higher

judiciary through collegiums? Is it the right method where judges appoint judges? The collegium route is the best one, as it stands today. Judges are strictly not appointing

judges because there is a role of the state in it. After all, files go to the government. Many times, these files are returned. The selection process in 'judges appointing judges,' also involves clearance from the Intelligence Bureau. The SC collegium does its duty diligently.

#### You've dissented on a couple of SC verdicts. How would vou like to describe it?

A dissent is a view one must respect. It is not necessary that all of us think alike. We come from different backgrounds, cultures, and have varied viewpoints and philosophies in life. But it's not often that I dissented. It's not planned, it happened that too in a couple of cases where I differed.

#### What are your post retirement plans?

I am not 'retiring', I said that much in my farewell speech. I stand by that. I will try to do photography on nature, birds, flowers and trees. I may also write poetry. I am also a trained mediator under the Singapore international mediation centre as an SC judge. I will see how I can explore more of this world.





FILMS will now be accessible to the hearing and visually impaired. Standards, aimed at making cinema accessible for people with disabilities in public places like theatres, have come into effect, the information and broadcasting (I&B) ministry said on Monday. The ministry had notified the guidelines in March. "All feature films that are to be certified in more than one language would be required to provide at least one accessibility feature each for the hearing impaired and visually impaired, i.e. closed captioning/ open captioning and audio description," the ministry said in a statement. It announced that the "accessibility standards" module in e-Cinepramaan has been successfully deployed as per the September 15 deadline. "The applicants may now apply/submit their films with the required accessibility features for the hearing and visually impaired, as specified in the guidelines," the ministry said.

theatre owners will develop self-regulatory plans foraccessibility, following consultations with disability stakeholders and implement accessibility features within two years. A committee appointed by the ministry with half its members being persons with hearing or visual disabilities and representatives from the film industry will oversee implementation of accessibility standards and provide guidance.

The Delhi HC had asked the Centre in November last year to put in public domain the draft guidelines for making the experience of watching films friendly for those with hearing and visual disabilities.

**RG KAR:** Jawhar Sircar says he disapproved the handling of the case by TMC govt **Docs** demand end of threat culture in medical institutions

## 'Total societal movement in Bengal'

Y time is up, Sir." Jawhar Sircar quipped in his quintessential style while tendering his resignation to Rajya Sabha Chairman Jagdeep Dhankhar. Never shied away from airing his views—off course, erudite—the Presidency College alumnus cracked the UPSC exams at an early age and went on to become one of the most formidable and distinguished bureaucrats heading several high-profile departments at the state as well as the Centre. The Bengali bhadralok had a clear vision for the country's public broadcaster—Prasar Bharti—when he was CEO. He quit the Trinamool Congress very recently in the wake of the horrific rape-murder of a trainee doctor at RG Kar Medical College and Hospital as he didn't like the handling of the case by the state administration. **Excerpts**:

#### Would you call the protest against the rape-murder of a trainee doctor at RG Kar Medical College and Hospital political?

I believe that the bulk of the protest is non-political. It is outpouring of public emotion demanding justice for the victim — a young doctor. I have never seen such sustained spontaneous protest in my life. I am not aware of any such protest. I can say that the current protest is bigger than the food movement in 1959 or students' movement by the Left during 1966-67.

That's the point of differences I had with the Trinamool Congress leadership, which, as a political party, refused to acknowledge that most of the pro-



tests are non-political. The party sees the role of the Opposition parties the BJP and the CPM — in engineering the protests.

The second part of the protest, Reclaim The Night may appear to be occupation of public space at night—both spatial and temporal space—but it has a wider meaning for the society. It is a manifestation of a women led people's demand for justice not only for the poor woman victim but for womankind as a whole.

Look at how women from all walks of life have hit the streets to 'Reclaim' seeking a guarantee for justice from government but also from society. Their pent-up anger against patriarchy in society also. The horrific rape-murder of the 31-year-old doctor was the trigger point for this wider issue.

The protests are signs of people's anger against the TMC government? It is a total societal movement happen-

ing. Else, how would one describe the participation of almost all sectors from cab drivers to Swiggy delivery personnel, from common citizens to housewives, old and young—join the protests. The message is loud and clear —Bengal isn't prepared to let culprits to go unpunished. It is a collective angst. It is a clear assertion of the people of Bengal that they will tolerate horrific rapes that happened in Hathras, Unnao or Kathua in Bengal.

A Brij Bhushan Sharan Singh cannot be allowed in Bengal.

In your resignation letter, you were very critical of the handling of the case. Please elaborate. I had differences with the party leadership. My approach is different. I would

have jumped straight into the problem and opened dialogues and back channels, then talk and talk till a resolution is found.

I remember an incident at Barrackpore Rastraguru Surendranath College in 1979 when as an IAS officer I, despite repeated warning by fellow officers, I went straight in the college and engaged with the protesting students.

I believe that both parties—the state government and the protesting doctors —must engage, talk to each other and find a solution. Only dialogues can resolve the situation.

#### What next for you?

I will continue to fight for the right causes. I will speak and write.

## **Docs demand nat'l** support for justice

THE national capital on Monday witnessed a united show of doctors' strength who came together to demand justice for their colleague in Kolkata. Senior doctors and a delegation from the West Bengal Junior Doctors Front (WBJDF) held a joint press conference with Delhi Resident Doctors Associations (RDAs) seeking national support for their justice amid the standoff with the West Bengal government.

The doctors accused the Kolk-

pering and demanding a thorough probe by the CBI. Subarna Goswami, a prominent member of the Joint Forum of Doctors, sought accountability, stating, "We want the Kolkata Police Commissioner to be removed and a probe to find out under whose direction he was acting," said Dr Goswami.

He criticised what he described as a "health syndicate" within the state administration. He alleged that the syndicate, involving highranking officials and medical institution heads, was obstructing the investigation and tampering evidence. "This syndicate, responsible for rampant corruption in every health institution, must be dismantled to ensure the safety of junior doctors when they return to work," he asserted.


The junior doctors' delegation reiterated their demands including enhanced workplace safety, implementation of gender audits, establishment of Internal Complaint Committees in all institutions, and an end to the threat culture in medical institutions.

The medicos called for national solidarity, urging citizens across the country to support their cause. "We implore everybody to resonate

with our 5-point demands of justice. Together, we hope that we can be united in the face of injustice, cowardice and malice and reclaim back the basic tenets of liberty, autonomy and justice," they said.

Meanwhile, the Delhi RDAs, extending solidarity to their colleagues in West Bengal, warned that any coercive action by the Mamata Banerjee government against the protesting doctors will lead to escalation of the protest.

"While we have temporarily suspended our strike as per the Supreme Court's directive, any coercive measures against our fellow doctors in West Bengal will force us to resume our nationwide strike," said Indra Shekhar, President of the AIIMS RDA.

### Manipur net ban lifted, schools to reopen today

THE Manipur government on Monday lifted the week-long ban on mobile internet services in the five Imphal Valley districts and ordered the reopening of schools and colleges from Tuesday.

The decisions were made as no major incidents of violence were reported since last Wednesday. "...the Governor of Manipur is pleased to order revocation of any extant orders for temporary suspension of internet and mobile data services including Lease Lines, VSATs, Broadbands and VPN services in the territorial jurisdiction of the state with immediate effect," an order issued by the home department said.

The ban on internet was imposed in the Imphal East, Imphal West, Thoubal, Bishnupur and Kakching districts on September 10 following the outbreak of violence during protests by the students. Broadband and fixed lease line internet services were restored on September 12.

However, curfew is on in Imphal East, Imphal West, Thoubal and Bishnupur, albeit with relaxation. CM urged everyone to use the internet responsibly and refrain from posting any inflammatory content.

#### Ayodhya emerges as top tourist destination

Ayodhya has edged out Varanasi to emerge as the top tourist attraction in UP, with 11 crore domestic and international tourists visiting the temple town in the first six months of this year as compared to 4.61 crore visiting Varanasi. The surge is evident. When compared with the first six months of last year, which saw 19,60, 34, 967 tourists, this year registered a jump of over 13 crore visitors with Ayodhya being on top of the list with 10.99 crore tourists, including 2,851 foreign visitors, thronging the temple town. Varanasi followed with 4.61 crore, including 1,33,999 international travellers.

In a recruitment exam conducted by the Chhattisgarh Vyavsayik Pariksha Mandal (Professional Examination Board) for 300 posts of students' hostels superintendent, over 3.53 lakh aspirants appeared on Sunday. As many as 6.30 lakh youths had initially put in their applications. Such a huge number of applicants were vying for the post for which the minimum education qualification was 12th pass. After a questioning session, he was released, said police.

Following the alleged suicide of a 17-year-old girl at the top floor of the MLA's house in Bhadohi on September 9, and the rescue of a 15-yearold girl by a joint team of labour, an FIR was lodged against the MLA and his wife on the charges of human trafficking and keeping bonded labour.

AN alleged suicide by a 25-year-old girl and booking of the local Congress MLA's son for abetting the suicide has heated up the BJP-Congress politics in tribal-dominated Alirajpur district of Madhya Pradesh.

"My son and that promising daughter knew each other. But the girl's social media and phone data suggests that my son has nothing to do it," said Patel.

## **TRUMP'S ATTACKER HAD PLANNED TO RECRUIT AFGHANS TO FIGHT FOR UKRAINE**

Ryan Wesley Routh has criminal record, donated to Democratic party

#### WASHINGTON

The 58-year-old man detained in connection with an apparent assassination attempt on former president Donald Trump has said in an interview in 2023 that he planned to recruit potential Afghan soldiers through Pakistan to fight in Ukraine against Russia.

Ryan Wesley Routh, who authorities suspect was planning to attack the Republican presidential nominee as he played a round of golf, made these remarks to *The New York Times*.

During an interview with newspaper in 2023, Routh also said he was seeking recruits for Ukraine from among Afghan soldiers who had fled the Taliban. He said he planned to move them, in some cases illegally, from Pakistan and Iran to Ukraine. He said dozens had expressed interest.

"We can probably purchase some passports through Pakistan since it's such a corrupt country," he was quoted by the New York Times.

He has shown pro-Ukraine views into his public statements because of which he was interviewed by several news organisations, including *The New* York Times and Semafor in 2023. Routh is a self-employed Hawaii who at times has criticised the former president.

Elon Musk deleted a post on Monday morning that questioned why former President Donald Trump has faced two apparent assassination attempts in recent months while President Joe Biden and Vice President Kamala Harris have not encountered any, CNN reported. Musk later claimed the post was a joke. "And no one is even trying to assassinate Biden/Kamala," Musk wrote in the now-deleted X post. Musk initially resisted numerous calls throughout Sunday night to delete the post. In one post responding to a demand to take down his remarks, Musk doubled down: "No one has even tried to do so is the point I'm making and no one will."

## Worst typhoon in 75 years brings Shanghai to a halt

#### BEIJING

BEBINCA, the strongest typhoon to have hit China's Shanghai city in 75 years, on Monday left a trail of destruction, bringing the megacity with a 25 million population to a grinding halt.

Bebinca, the 13th typhoon to hit China this year, made landfall in Shanghai around 7:30 am, according to the Shanghai Central Meteorological Observatory. The typhoon, with the maximum wind force near its centre reaching 42 meters per second, churned ashore at the Lingang area of Pudong district. Bebinca unleashed gales and torrential rain in the city. state-run Xinhua reported.

Pictures on social media showed trees uprooted and light poles toppled. The typhoon ruined the three-day Mid-Autumn Festival holiday for the people of Shanghai. Au-

several routes passing through the city till Monday.

Shanghai Disneyland, Disneytown and Wishing Star Park remain closed on Monday, with the two resort hotels providing services to in-house guests, the Shanghai Disney Resort said in a statement. It added that normal operations are expected to resume from Tuesday.

Before the typhoon arrived, officials took precautionary measures such as closing the Yangshan freight port. Arrangements were made for truck drivers to stay in a "drivers' home" near the port.

Doctors and nurses in the city were busy as the typhoon created trouble for their patients. Shanghai First Maternity and Infant Hospital issued a notice on Monday asking pregnant women who were unable to come for their regular checks to reschedule. PTI

## Secret Service needs more hands: Biden

WASHINGTON: President Joe Biden said on Monday that the US Secret Service needs more personnel to perform its duties after a second apparent assassination attempt against Republican election candidate Donald Trump. "One thing I want to make clear, the (secret) service needs more help, and I think the Congress should respond to their needs," Biden told reporters at the White House. "I think we may need more personnel." Biden added that "thank God the president's OK" following Sunday's incident in which the Secret Service opened fire on a gunman, who was later arrested, in Florida. Meanwhile, Donald Trump on Monday blamed his election rival Kamala Harris and US President Joe Biden after he was targeted in a second apparent assassination attempt, saying their "rhetoric" about him endangering democracy is to blame. Trump's rapid politicisation of Sunday's incident, in which a man allegedly planned to fire on the Republican while he played golf in Florida, guaranteed that tensions ahead of the presidential election in seven weeks would continue to boil. Both Biden and Harris have denounced the event.

#### Trial begins of man close to Charlie Hebdo attackers PARIS

#### A French jihadist, who was close to the brothers behind the 2015 massacre at the satirical magazine Charlie Hebdo, went on trial in Paris on Monday.

Peter Cherif, also known as Abou Hamza, was arrested in Djibouti in 2018 after years allegedly fighting in the ranks of Al-Qaeda in the Middle East.

He is being tried for terrorism-related offences allegedly committed between 2011 and 2018, and the 2011 kidnapping of three French aid workers in Yemen. In 2015, Cherif was placed on a US blacklist as a member of the Yemen-based militant group Al-Qaeda in the Arabian Peninsula (AQAP).

Cherif, 42, was linked to a Paris jihadist cell and was named in the enquiry into the January 2015 attack on satirical magazine Charlie Hebdo, due to his regular contact with the perpetrators, brothers Said and Cherif Kouachi. Twelve people were killed in the massacre that sent shock waves across France.


Peter Cherif has not been formally charged over the attack but his potential involvement is expected to be at the centre of the trial.

Investigating judges believe that he "facilitated the integration into AQAP of one of the Kouachi brothers, most probably Cherif" and that he had knowledge of the plan to carry out an attack in France

According to several witnesses, AQAP advised foreign fighters in Yemen to return to their countries of origin to stage attacks. Peter Cherif is also believed to have maintained contact with Cherif Kouachi on his return AFP to France.

## Govt may develop K'taka as semiconductor hub Bajaj Housing

Karnataka government and Centre working together to create semiconductor ecosystem there, says Kaynes CEO

THE government may develop a semiconductor ecosystem in South India after establishing a hub in Gujarat, said Raghu Panicker, CEO of Kaynes Semicon, a subsidiary of Karnataka-based electronic manufacturer Kaynes Technology. Panicker highlighted that both the Karnataka government and the central government are actively working on developing another semiconductor hub in Karnataka.

"I think so (the government is developing a semiconductor unit in South India), because I see the Karnataka government is very active in this. And so is the central government. I'm not exactly privy to give more details, but they are doing it," said Panicker.

The government recently approved Kaynes Technology's application for an OSAT (Out-

This is the fifth application accepted by India's Semiconductor Mission, launched by the Ministry of **Electronics and Information** Technology in December 2021, with an outlay of ₹76,000 crore to make India a semiconductor hub like Taiwan.

"The construction work has already started in Sanand, Gujarat, and the first production or first phase of production will start with a 100 million chip capacity in 10 to 12 months. After two and a half years, when the plant is fully operational, it will produce 1 billion chips," said Panicker. Initially, Kaynes planned to set up its facility in Telangana but later changed its location to Sanand, Gujarat, where other compa-

nies like Micron Technology are also establishing their presence. The reason for shifting its semiconductor manufacturing unit to Gujarat was the development of the entire ecosystem in the region, said Panicker.

Kaynes Technology has chosen its technology partners for its semiconductor unit, including Globetronics from Malaysia, Aptos Technologies from Taiwan, AOI in Japan, and California-based Mixx Technologies. The chips produced in this unit will cater to a wide variety of applications which include segments such as industrial, automotive. electric vehicles. consumer electronics, telecom and mobile phones, among others. When asked about the government's focus for the next phase of the semiconductor incentive scheme, Panicker suggested that it should include incentives for equipment manufacturing.

SHARES of Bajaj Housing Finance made a stellar debut on the stock exchanges on Monday. On the NSE and the BSE, the company's shares were listed at ₹150 per share, 114.29% higher than the issue price of ₹70.

The stock closed its first day at ₹165 on NSE, higher by 135.71% from the IPO price of ₹70, and at ₹164.99 on BSE, a 135.70% premium. This blockbuster listing added a whopping ₹79,000 crore to the company's valuation on day 1, highest in India's capital market history for a new entrant. Bajaj Housing Finance's market capitalisation stood at ₹ 137,507 crore at Monday's close as against ₹58,300 crore at the time of issue. The firm also widened the valuation gap among the housing finance companies. Housing & Urban

It received bids for more than 4,628 crore equity shares as against the 72.75 crore shares which were on offer. The share applications were valued at nearly ₹3.24 lakh crore, another high for an IPO. Sanjiv Bajaj, chairman and MD of Bajaj Finserv, said on Monday that even they had not expected the way the shares opened.

"It also has additional responsibility on management and the board. The way we have built a quality business in the last 7 years, we will move ahead in the same way," said Bajaj after the listing ceremony in Mumbai. He expects 12-15% credit growth in the housing finance industry as the economy is showing very strong tailwinds.

It also referred to a letter that "a group of Sebi employees" had sent to the HRD on August 6, and a second letter they had sent seven days later.

## From tennis ball to pace sensation: Rana's journey

HE had not held a cricket ball in his hand until he turned 17 but only four years later Nahid Rana started hurrying world-class batters with his raw pace. He crossed 150kmph on his Test debut against Sri Lanka in March this year and consistently touched the 150kmph mark in two five-day matches Bangladesh played against hosts Pakistan. The 21-year-old dismantled Pakistan in the Rawalpindi Test claiming four wickets including that of captain Shan Masood, Babar Azam and Saud Shakeel in the second innings to hand his team a historic 2-0 clean sweep.

With Bangladesh touring India for two Tests and three T20Is, Najmul Hossain Shanto and Co will expect Rana to continue in the same vein. More importantly, the pace sensation standing at around six feet two inches would be keen to outfox batters like Virat Kohli and Rohit Sharma on his first tour to India.

Rana might be the centre of attraction given his recent exploits on the field and the pace he generates but it was a farfetched dream almost five years ago when he decided to leave his village Horishpur (Harishpur) for district headquarters Chapainawabganj to pursue his dream of becoming a cricketer. "One of my acquaintances from his village called me and told me about the pace he generates," Alamgir Kabir, former Bangladesh pacer who played three Tests for the country, told this daily. Alamgir works as a fast bowling coach at the Clemon Rajshahi Cricket Academy started by former Bangladesh Test captain Khaled Mashud along with a few divisional cricketers.

But for Rana to make a move, he had to fulfil a demand put forth by his elder brother, who was working in Saudi Arabia and the primary earning member of the family. "Rana's father



is a small-time farmer and it was his elder brother who used to send money to the family from Saudi Arabia to make ends meet. Initially, the brother was skeptical and was of the opinion that due to cricket Rana's studies might take a back seat. So he demanded Rana to complete his 10th class before moving to district headquarters. Once that was done, he asked Rana to complete his 12th along with cricket coaching," added Alamgir. He also used to climb mango trees up and down, along with his friends. These activities apparently developed his muscles and made him fit enough to bowl faster."

Rana used to bowl for hours in the nets with the coach videographing him. They both used to watch the videos later and work on the pacer's skills. The efforts put in by the pacer and the coach paid rich dividends as the former made his first-class debut for Rajshahi Division against Barisal in the National Cricket League in October 2021. In the next season (2022-23), Rana claimed 41 wickets to grabbed eyeballs. However, it was his stints for Khulna Tigers in the Bangladesh Premier League that caught the eye of selectors and eventually fetched a national call-up for the Test side this year.

Usually, youngsters of his age follow the footprints of famed cricketers in their early days. But Rana is different. "I once asked him whom he follows as a cricketer and his reply was unique. 'Sir I want to be Nahid Rana, why should I become like anyone else'. The reply was surprising but I also asked him to be natural and carve out his own paths." With 11 wickets from the first three Tests, Rana has already announced himself on the world stage. How he fares in the two Tests against India will further shape his career and Alamgir strongly believes there will be many not only in Bangladesh but across the world to follow the footprints of Rana when he hangs his boots.

THE biggest challenge to Manchester City's Premier League dominance was due to start on

Monday at a hearing into a slew alleged financial breaches. On the line is City's reputation and punishment could be as extreme as expulsion from the league.

City, which has won the last four league titles, denies the charges, which include providing misleading information about its finances. It will be down to a team of lawyers to clear the club's name and finally quash accusations that have cast a cloud over its unprecedented period of success. Manager Pep Guardiola confirmed on Friday that the longawaited hearing into more than 100 charges of alleged financial wrongdoing was due to start. "I'm happy it's starting on Mon-

day. I know there will be more rumors," he said. "Everybody is innocent until guilt is proven."

City was accused by the Premier League in February last year of providing misleading information about its finances over a nine-year period between 2009-18 after it was bought by Abu Dhabi's ruling family in 2008. City was trying to estab-

lish itself as one of the leading clubs in Europe, signed some of the world's best players like Yava Toure, Sergio Aguero and Kevin de Bruyne and won three league titles — in 2012, 2014 and 2018. The league's financial fair play rules are designed to ensure clubs essentially spend what they earn and commercial deals are assessed for being at legitimate market value.

The charges came after a four-year investigation and following the publication of



leaked emails and documents, likely hacked, that were published starting in 2018 by German magazine Der Spiegel.

The documents allegedly showed attempts to cover up the source of City's income in a bid to comply with Financial Fair Play rules operated by European soccer's governing body UEFA and the Premier League. City was also accused of breaches relating to its alleged failure to co-operate with the investigation.

The hearing into the charges will be held by an independent commission made up of three

judges appointed by a lawyer who chairs the league's judicial panel. The hearing will be held behind closed doors, and a verdict is not expected until next year. Potential punishment for a "serious breach" of the league's rule book is wide-ranging. Dependent on whether City is found guilty of any of the charges, possible sanctions include a fine, points deduction or in "extreme cases, expulsion from the competition" according to the league's rules.

City said it was surprised by the charges when they were made last year. "The Club welcomes the review of this matter by an independent Commission, to impartially consider the comprehensive body of irrefutable evidence that exists in support of its position," it said in a statement. "As such we look forward to this matter being put to rest once and for all."

weekends when she stayed away from the computer screen. After a medical evaluation, she was diagnosed with hypermetropia, and her symptoms were managed through corrective glasses, reducing non-essential screen time, and practising good digital hygiene, including frequent breaks, proper ergonomics. and adjusted screen settings.

Computer vision syndrome (CVS), also known as digital eye strain, is becoming increasingly common as screen time has increased among adults and children, leading to eye strain, headaches, and other visual discomforts. The condition, driven by prolonged use of digital devices, is particularly affecting people in the age group of 25-40, and children who spend excessive time on computers and smartphones.

Experts highlight that factors like inadequate breaks and reduced outdoor activities are contributing to the rise in symptoms. Moreover, the pandemic's shift to remote work and learning further amplified these issues, making digital eye strain a growing health concern.

Dr Ashwin Santosh Shetty, consultant ophthalmologist at Aster CMI Hospital, noted a spike in cases, pointing out that 25% of people in the 25-40 age group are facing eye strain due to increased working hours in front of and insufficient breaks from screens. "The problem is not limited to adults, children are also increasingly experiencing eye problems, primarily due to excessive screen time for learning and leisure activities, reduced outdoor play, and poor digital hygiene," he said.

The symptoms are usually reversible with proper care, such as reducing screen exposure, encouraging outdoor activities, and consulting an ophthalmologist if symptoms

Dr Kala Jeethender Jain, consultant cardiologist at Yashoda Hospitals, Hyderabad, added, "AI-driven tools, such as deep learning models, analyze imaging data and echocardiograms to detect subtle changes in cardiac function that may be missed by the human eye, enhancing early detection of conditions like cardiomyopathy and coronary artery disease."

Research studies back these observations. According to a 2021 study published in 'Circulation: Cardiovascular Imaging,' a journal by the American Heart Association (AHA), AI algorithms demonstrated superior performance in analysing cardiac imaging compared to traditional methods. The study revealed that AI-driven tools achieved a 92% accuracy rate in detecting left ventricular ejection fraction (LVEF) from echocardiograms, surpassing the 85% accuracy rate of human experts.

However, some cardiologists urge caution on the current state of AI in cardiovascular science. Dr Rajiv Passey, senior cardiologist at Sir Ganga Ram Hospital in Delhi, pointed out the need for further research. "Significant limitations remain in the current studies, underlying technology, and the clinical application of these techniques. Prospective, multi-centre randomised controlled trials involving







When we were recycling, we wanted to create something using waste. So, we went to hospitals, picked up those X-rays and cut them into sequences. If you look closer you can see figures.

Each one has worked with different ideas," David added.

Regarding the time taken to get all of these together into a design, Rakesh said, "It takes time. We worked with ragpickers who collected it for us."

The two designers have done a lot of handloom work too. "We started with handlooms. At the same time we also focus on industrial fabrics. We worked with handloom clusters in southern AP and Telangana and also worked with weavers in Banaras, Maheshwar in Maharashtra, and West Bengal too. It changes from season to season," Rakesh said.

On working with the weavers of Telangana, Rakesh pointed to a *saree* and mentioned, "The first *saree*, a double Ikkat *saree*,

is also the V&A woven by the famous Gajam Govardhana. In fact, I have learned Ikkat from him. He understands the whole process and it makes it easy for us. When we get something complicated he is actually the first person to help us."

Keeping up with trends and also commenting on fast fashion, David says, "We don't believe in fast fashion. This might sound like a cliché but we believe in style. We talk about sustainability and responsibility, which ing appropriate and having good manners. It is not just about a new dress from Zara."

He added that the duo draws inspiration from pretty much everything, such as the

LAMES danced in her kohl-lined eyes as she • swung her sickle from left to right, bringing the trembling *razakars* to their knees. "My *bhoomi*(land), my pandisthe (crops)!" she cried. That was the indomitable Chakali Ilamma, who fought against social anyayam (injustice) under Nizam rule.

And what better way to commemorate her 39th death anniversary than a Kuchipudi dance ballet—conceptualised and choreographed by renowned danseuse Alekhya Punjala. Organised by the State Department of Language and Culture along with the Telangana Sangeet Nataka Academy at Ravindra Bharathi, the performance made jaws drop right from the

opening act, a Bonalu depiction enlivened by traditional teen*maar* folk beats.

As the *teenmaar* receded to give way for the folk song Bon*am Techamu Thalli* in *Kalyani* raagam with Adi taalam, Alekhya, our Chakali Ilamma, gently tapped her feet and made a powerful entrance. Flanked by her fellow washerwomen, each serving a melange of grace and elegance and singing Vuthuku, *Vuthuku* in *Sarasangi raagam* with *Adi taalam*, Ilamma sang with her infinite wisdom, "Remove the maila (dirt) of the human *manasu* (mind) by washing their *batalu* (clothes)." Oh, we were stunned by the powerful dialogues written by the late Vaddepalli Krishna.

Amid deeply entrenched caste divides, a kind landowner encouraged Ilamma to farm, of-

fering land. We saw Ilamma's norm-driven reluctance—defined by Alekhya's furrowed brows and anxious eyes—grow into pride and relief when she took to farming. Thanking Goddess Bathukamma, the women held baskets of flowers and sung in *Maand raagam* with Khanda Gati taalam, "Bathukulu marayani bathukummale *aadalinka* (We will sing, dance and rejoice as our lives have changed for the better)." What versatile music, com-

posed by VBS Murali, and melodious songs sung by Harini Ivaturi and Sai Charan Ivaturi.

Suddenly, Mayamalavagowla raagam took over with Adi taalam as the villainous razakars stormed onto stage, disrupting the happy women and hoarsely singing, "How dare you offer *poolu* (flowers) and rejoice like this?" The men ordered the washerwomen to dance naked for them as the latter begged, "Nee banchana, nee

banchana (I'm your slave, please don't do this).'

This was where Ilamma's character arc took a turn for greatness—eyes red, she wielded a sickle in her hand and literally put her foot down. Not just the *razakars*...we trembled too as we beheld her fury when she said, "Just like we remove kalupu (weeds) in the field, let us cut the *gonthu* (throats) of these ruthless fellows. Each one of us are *Maa Kaali*." This rage even baffled Ramachanand other ministers who attended heaped praises on what could be best described as a heart-wrenchingly beautiful depiction of Telangana's most fierce warrior.

















Despite his lifelong dream of climbing Mount Everest and setting a world record, the economic downturn during the pandemic made sponsorships hard to come by. "A few years ago, the state government recognised my potential and promised to sponsor my Everest expedition, but that fell through. Self-funding for expeditions is a tough challenge, not just in mountaineering but in any sport. I have to thank my parents for their support; they even encouraged me to take a loan to climb Mt Kilimanjaro and Mt Elbrus," he says, adding that he is getting ready for further accomplishments (climbing Mt Everest) and looking for the support to make this dream come true.

When asked what advice he would give to aspiring mountaineers or adventurers, Vineel says, "Start with shorter hikes to build your skills and endurance, then gradually take on more with mountaineering courses. Always climb with experienced companions and remember, mountaineering is a lifelong journey of learning and exploration. And be aware of the financial side; avoid taking unnecessary risks."

He reveals that he's filled with happiness and pride when standing atop those peaks. "My mother saw the talent in me, and I've proven her right. Finishing the journey is bittersweet, but the memories last forever. The phrase 'records are waiting' keeps me going—I believe some of them are meant for me.'

The maps featured in this exhibition include traditional Indian pilgrimage maps, printed bazaar maps, and city maps, each offering a window into the society of a bygone era. "Through this exhibition, we have tried to juxtapose the precision behind the science of origami and cartography (the age-old science and art of map-making)," says the curator.

Ankon has built an international reputation as a pioneer of the folding technique through his diverse projects. His studio's work has been exhibited in India, Italy, France, UK, USA, Japan, the Netherlands, Brazil, Switzerland, Singapore, UAE, The Maldives, Malta, and China, most recently at the CODA Museum in Apeldoorn, The Netherlands, and Arte Laguna, Arsenale de Nord, Venice (2021), the India Pavilion of the London Design Biennale at the Somerset House (2022) and the Shanghai Paper Art Biennale (2023). His inspiration draws from the natural and universal phenomenon of folding, evident in the very DNA of life, the formation of landscapes, and the movement of oceans. "Folding is my spiritual cord with the universe, my anchorage, and the act of folding is my prayer," says Ankon, further adding, "This exhibition is a series of intense explorations between history and city grids, map-making and folding, what maps reveal and what they hide, how spatial information is encoded into the abstract symbology of maps and how maps which are essentially 2D can be translated into a series of 3D sculptures, murals and installations—expressions of form, space and light. Most importantly, this collaboration is an exploration of how to find the sacred within onethe deep science and craft of maps can be made accessible and of immense interest to a wider art appreciating community, enlarging its ambit to beyond map nerds and bibliophiles."



#### Shaakha-Proshaakhaa (Aerial roots & branches)

A series of historical and contemporary maps of India's road and rail networks over time are transformed into a spatial installation consisting of aerial roots and branches, akin to a 'Bargad Ka Ped'. "From the times of the Indus Valley civilisation to the times of Buddha, Mahavira and the Adi Shakharacharya, and to Gandhi's extensive rail journeys in India upon his return from South Africa, our ancients and modernist thinkers have travelled the length and breadth of this land, creating those travel networks that have connected our nodes, and have rooted us into a singular and uniquely interconnected civilisation. This work is a metaphor of those maps of connections. This immersive installation is planned inside a mirror room, which would reflect and multiply the work ad infinitum in the space, capturing the true significance of 'endless, infinite and everlasting," informs Ankon.

#### **Votive urns**

Religious maps and pilgrimage maps from the Kalakriti Archives are harnessed in this work to create a series of folded and pleated urns and vessels. Like the maps themselves which convey a desire of the initiate to undertake a spiritual journey



#### **Cloud maps**

The formation of clouds is one of the most beautiful and stunning phenomena that occur on Earth. This installation references 'Cloud Maps' released into the public domain by the European Space Agency (ESA), NASA, ISRO, The Japan Aerospace Exploration Agency (JAXA) and their geosynchronous satellites, as well as video footage from the International Space Agency (ISS). These are maps that are frozen at a moment in time and then change immediately the next moment—they are maps of clouds as much as they are maps of time—of the seasons, markers of the ephemeral but glorious nature of our lives—etched in gold and black.

#### Moons & constellations installation

A series of illustrated maps of the constellations embedded in the indigo and white speckles of the Milky Way galaxy—and a surprise when viewed from the other side—the faces of the glorious moons of our Solar System—challenging our conventional notion of spheroids in space.



Vikrant, you have often described yourself as a sensitive individual. Playing a serial killer must have taken a toll on your psyche. Were you a little bit apprehensive while taking up the role? VM: I was apprehensive, but not in terms of how the character will affect my emotional and mental health. After working for years, I know how to separate my personal and professional life. I didn't want it to be gimmicky, I was wary of that. I didn't want to play a serial killer to grab attention or for shock value. Squid Game creators face lawsuit from Indian filmmaker

IRECTOR Soham Shah has filed a lawsuit against Netflix for allegedly plagiarising his 2009 film *Luck* to make the Korean series Squid Game, a claim the streamer on Sunday said holds no merit. "This claim has no merit. Squid Game was created by and written by Hwang Dong Hyuk and we intend to defend this matter vigorously," a Netflix spokesperson said in a statement. According to the documents of the lawsuit obtained by American outlet TMZ, Squid Game — which became the most watched series on Netflix when it premiered in 2021 — is a "rip-off" of the movie starring Imran Khan, Shruti Haasan, and Sanjay Dutt. Created, written and directed by Hwang Dong Hyuk, Squid Game follows 456 players, all of them in deep financial debt, who are brought to a secret place to play a deadly children's game for a chance to win a 45.6 billion won prize.

On the other hand, Luck revolves around an underworld kingpin who recruits people endowed with 'luck' from across the globe to take part in a series of challenges designed to test their chance factor, as gamblers around the world bet on them.
