# **Oman among top cyber** secure countries: ITU

The sultanate has been ranked among the world's most prepared countries in cybersecurity, according to the 2024 Global Cybersecurity Index (GCI) released by International Telecommunication Union (ITU).

Oman secured a place in the top Tier 1 category, with a score of 97.02 out of 100, highlighting its strong commitment to cybersecurity across various key areas.

The index assesses countries based on their performance in five key pillars - legal, technical, organisational, capacity development and cooperation measures.

Out of maximum 20 points per pillar, Oman excelled in cooperation and organisational efforts, receiving full marks in these areas, while scoring 19.59 points in legal measure, 19.03 in capacity development and 18.39 points in technical measure.

As per the report, Oman's cybersecurity strengths lie in its organisational structure and international cooperation. However, there is room for growth in legal, technical and capacitybuilding areas, ensuring continued improvement in future rankings.

In the Arab region, Oman is joined in Tier 1 by Bahrain, Egypt,





Jordan, Morocco, Qatar, Saudi Arabia, and the United Arab Emirates, reaffirming the Middle East's growing commitment to strengthening cybersecurity.

He also highlighted the success of Oman's Hadatha Cybersecurity Programme, which was developed under the National Programme for the Digital Economy. "This programme aims to position Oman as a global leader in cybersecurity preparedness, and our ranking in the GCI aligns perfectly with these objectives," he added.

According to the report, countries around the globe are improving cybersecurity efforts, but stronger actions are needed to meet evolving cyberthreats.

On average, countries have taken more cybersecurity-related actions and improved their cybersecurity commitments since the last index was released in 2021

Worrisome threats highlighted in the report include ransomware attacks targeting government services and other sectors, cyber breaches affecting core industries, costly system outages, and breaches of privacy for individuals and organisations.

Doreen Bogdan-Martin, Secretary-General of ITU, stated, "Building trust in the digital world is paramount. The progress seen in the index is a sign that we must continue to focus efforts to ensure everyone can safely and securely navigate today's complex digital landscape."

# Public revenues drop, oil income increases 9%

Oman's public revenues fell slightly to RO7.154bn this year till the end of July, marking a decrease of RO29mn compared to the same period in 2023, when revenues stood at RO7.183bn. This decline is attributed to a drop in gas and current revenues, according to the latest fiscal performance bulletin of the Ministry of Finance. Despite overall dip in rev-

enues, Oman's net oil income saw a 9% increase, rising to RO4.038bn from RO3.714bn in the same period last year. The average price of oil reached US\$83 per barrel, while daily production averaged 1,002,000 barrels.

In contrast, gas revenues saw a significant drop. By July this year, net gas revenue stood at RO1.09bn, down 18% from RO1.329bn in 2023. This decrease is largely due to changes in the methodology adopted for collecting gas revenue.

Current revenues also declined amounting to RO2.012bn by July this year, down RO120mn from the previous vear

Public spending, however, rose to RO6.754bn this year till the end of July, reflecting a 4% increase from RO6.481bn spent during the same period in 2023.

This increase is mainly due to higher development spending and contributions to various budget items.

Civil ministries' current expenditure decreased slightly to RO4.808bn, down by RO28mn compared to the previous year. Development expenditure for ministries and government units amounted to RO653mn, representing 73% of the total

RO900mn allocated for development in 2024.

Total contributions and other expenses rose sharply to RO1.243bn, a 46% increase from RO854mn in 2023. Subsidies for social protection, the electricity sector and oil products amounted to RO326mn, RO286mn and RO174mn, respectively, this year till the end of July.

In alignment with Oman Vision 2040, Ministry of Transport, Communications and Information Technology (MTCIT) has floated a tender for the Space Accelerator Programme. This initiative is aimed at supporting and accelerating the development of local companies engaged in Oman's space sector.

Managed by National Centre for Space, Advanced Technology and Artificial Intelligence, the programme is designed to enhance the sector's economic contribution, support emerging local entrepreneurs and promote the adoption of modern technologies.

It will focus on areas such as communications, earth observation, spatial data analysis, unmanned aerial vehicles, artificial intelligence, big data processing, spacecraft simulation and the Internet of Things.

The programme will provide resources, funding, and mentorship to small and medium enterprises (SMEs) to help them innovate and expand both locally and globally. Both local and international companies with expertise in space exploration are invited to participate. The deadline for obtaining tender documents is September 22.

Oman's National Programme for the Digital Economy has identified the space sector as a crucial focus area, guided by MTCIT's National Centre for Space, Advanced Technology and Artificial Intelligence. Over the next decade, there will be strong emphasis on ground applications, activities and attracting investment in space-related ventures, reflecting Oman's unique capabilities and potential for development

In 2023, Oman welcomed 321,012 cruise tourists arriving on 202 ships at Sultan Qaboos, Salalah and Khasab ports. This year, with 102 visits recorded between January and May alone, the number of tourists arriving by cruise ships is expected to reach 380,000.

# Dhofar gears up for World Theatre Festival amid record tourist influx

Dhofar is experiencing a cultural and tourism surge with visitor numbers during the ongoing khareef season surpassing 1mn. The governorate is also gearing up to host the World Theatre Festival in October, marking a significant cultural milestone as the largest event of its kind being held in the Arab world. In addition, the 'Marhaba Dhofar' initiative, aimed at boosting tourism cooperation with Saudi Arabia, is set to begin on Monday.

Visitor data from National Centre for Statistics and Information shows that 1,006,635 tourists had arrived in Dhofar by the end of August, a 9% increase

over the previous year. Omanis represented the majority of visitors (713,105), followed by tourists from GCC countries (171,762). Dhofar's scenic landscapes and cool weather during khareef continue to attract large numbers of tourists, most of whom arrive by land.

### World Theatre Festival

Dhofar is currently preparing to host the World Theatre Festival in October. The festival, described as the largest in the Arab world and the fifth-largest globally, is expected to draw participants from several countries. According to Dr Ahmed bin Mohsen al Ghassani, Chairman of Dhofar Municipality, the event

will enhance Dhofar's cultural profile and promote global cultural exchange

Ghassani made the comments at the conclusion of the inaugural Dhofar International Film Festival

on Wednesday. He highlighted the festival's role in showcasing Omani cinematic achievements and supporting young filmmakers. The first edition of the festival featured 200 films from 18 countries, with 41 films advancing to the final competition.

The municipality chairman emphasised the significance of film festivals in promoting cultural awareness, noting that

Oman has made notable strides in documentary filmmaking with several international awards this year. He also pointed out that the sultanate is experiencing a cultural renaissance with strong ongoing support for art and cinema.

In addition, the 'Marhaba Dhofar' initiative will kick off with participation of 40 Saudi tourism companies and 13 media professionals on Monday. # **Self-reliance key to** early learners' future success: Educators

With the 2024-2025 academic year now in session, experts are urging parents to help their children, particularly those in grades one to four, develop self-reliance in their studies.

This guidance comes at a time when 811,679 students are settling into their new classes which started earlier this month, according to the Ministry of Education. Of the total, 307,765 students are in grades one to four, with an almost equal split between boys and girls. In grades five to eight, there are 275,953 students - 138,621 male and 137,332 female. Grades nine to 12 have 227,961 students - 115,052 male and 112,909 female. Additionally, 74,078 new students joined this year in grade one. Educator Ali Hamad al Shayadi stressed the importance of encouraging students to take charge of their learning. "When students in early grades learn to manage their own studies, they build independence and problem-solving skills," he explained. Creating an environment where children are motivated to explore on their own helps develop lifelong learning habits. This approach not only improves academic performance but prepares children for future challenges by fostering proactive behaviour and resourcefulness. Shayadi, however, acknowledged the fact that guiding children towards self-reliance can be challenging for families. "With rising academic pressure, parents must find ways to help their children become independent without doing their tasks for them," he said. He advised parents to provide a quiet study space, assist in creating task lists and offer continuous support. "Effective study



skills like time management and task organisation are key," he added.

Social researcher Khalid al Balushi pointed out that children may sometimes struggle with concentration or attention. He encouraged parents to be patient and try to understand the reason behind their child's difficulties. "It's crucial to determine if the child is facing challenges with a subject, feeling pressure or deal-




study materials, and progressive-

ly increasing the level of difficulty. According to teacher Abdul Hadi Mustafa, fostering self-reliance starts with open communication. "Effective dialogue is

He recommended starting with calm tone and allowing them to express their concerns can help identify any fears they may have about becoming independent." He emphasised the need for parents to understand their child's nature and tolerance for responsibility. Some children may be quick to embrace independence, while others might need more time and support.

Mustafa also advised parents to give children simple tasks and responsibilities, even if they make mistakes. "Encouragement is key," he said. "Let them know that mistakes are part of the learning process, and improvement comes with time." He added that the process of helping children become self-reliant should start around second grade, with the goal of full independence by fourth or fifth grade. As children continue their educational journey, the focus on building self-reliance remains essential for fostering not only academic growth but also confidence and problem-solving

skills that will benefit them for

years to come.



# Islamic banking will continue to outpace conventional peers: Moody's Ratings

Sustained economic growth, governments' commitment to promoting the broader Islamic finance industry, and growing demand for sharia'a-compliant products across the GCC region will continue to drive Islamic financing growth, which will outpace that of conventional banks, according to Moody's Ratings.

Islamic banking has the highest market penetration in Saudi Arabia at 85%, with significant potential for growth in the UAE, Oman, Kuwait, and Qatar, Moody's said in a sector comment report. Saudi Arabia, the rating agency added, is poised to benefit the most from growth opportunities given the financing needs of the government's Vision 2030 program.

Moody's has forecasted that the profitability of Islamic banks in the GCC countries will remain strong over the next 12 to 18 months. The agency attributed the robust profitability of Gulf Islamic banks to increased commercial activity driven by government efforts to diversify economies across the GCC.

The report noted that Islamic financing will continue to out-

perform its conventional counterpart, with rising demand for sharia'a-compliant products. It also predicted further growth through mergers, as the sector seeks to enhance revenue generation and reduce costs.

Moody's highlighted that Islamic banks in GCC countries will continue to maintain strong capital and liquidity, enabling them to capitalise on the growing demand for sharia'a-compli-

ant financial services in the Gulf region. 'Islamic banks across most of

the region have ample liquidity to support their expansion, thanks to strong deposit inflows. However, Islamic banks will continue to hold relatively lower levels of liquid assets than their conventional peers, reflecting a lack of liquid sharia'a-compliant financial instruments for liquidity management,' Moody's said. The agency expects non-oil economic growth in GCC countries to remain strong in 2025, driven by ambitious government economic diversification plans and strong business confidence.

Badis Shubailat, Assistant Vice President and Analyst at Moody's, said, "Sustained economic growth, government commitment to bolstering the broader Islamic finance industry, and increasing demand for sharia'a-compliant products in the GCC region will continue to drive Islamic finance growth, outpacing its conventional peers."

## Asset quality will remain stable

The asset quality of GCC Islamic banks is expected to remain stable over the next 12 to 18 months, supported by continued economic growth across the region, backed by infrastructure spending and strong business sentiment, particularly in Saudi Arabia.

'This is because Islamic banks' lending is concentrated in large-scale, low-risk projects backed by the sovereign wealth fund, the Public Investment Fund. Islamic banks' non-performing financing ratios have remained broadly stable since the onset of the pandemic, comparable to those of conventional peers,' Moody's said.

The rating agency stated that GCC Islamic banks will also benefit from government-led initiatives to promote home ownership and increase private sector employment, presenting opportunities for retail lending growth.

'A key structural feature of

GCC Islamic banks remains their focus on household financing. This type of financing is typically spread across a diverse range of customers, backed by collateral, and has historically performed well. A large proportion of GCC retail banking customers are public-sector employees who have had stable employment through various credit cycles,'

Corporate financing, according to Moody's, remains a significant component of Islamic banks' credit exposure, particularly to the historically cyclical and confidence-sensitive construction, contracting, and real estate sectors.

Moody's said.

'This brings high concentrations to single corporate borrowers, and this is typically more pronounced for smaller Islamic banks with narrower retail franchises. However, the asset risk of Islamic financing for large corporations will be mitigated by lending to low-risk governmentbacked projects. This is especially the case in Saudi Arabia, where the government is supporting the contracting sector, historically the largest contributor to problem loans, in an effort to ensure minimal disruption to its gigaprojects,' Moody's said.

### India removes minimum export price on onion

New Delhi, India - India has removed the minimum export price imposed on onion, according to a notification from the Directorate General of Foreign Trade (DGFT).

The decision comes on the heels of robust kharif crop production prospects and favourable monsoon, coupled with stable market conditions both at the wholesale and retail levels.

Earlier, the government lifted the onion export ban on May 4, 2024, and allowed the export with the minimum export price of of \$550 per tonne and an export duty of 40%.

Initially, India had in early December 2023 prohibited the export of onions till March 2024. Later, it restricted the export until further orders.

While the restriction was on, the exports of onions were, however, allowed based on permission granted by the central government to other countries based on the request made by the countries. ANI

He added that Muscat and Salalah airports have witnessed significant growth in passenger numbers, noting that the government is investing millions of Omani riyals in developing the infrastructure of the transport and aviation sectors to ensure the sustainability of this growth. GCC airports are among the most strategically important hubs in global aviation due to their unique geographical locations, connecting continents and serving as key links in international air traffic. The expected GCC aviation bloc, which may be formalised during this forum, is expected to strengthen the global standing of these airports by consolidating joint cooperation and developing infrastructure, thereby opening the door to broader economic and investment opportunities.

# Markets eye likely Fed rate cut this week for fresh cues

New Delhi, India - Investors across financial markets will look for fresh cues from the outcomes of the upcoming US monetary policy review meeting this week, particularly the extent of interest rate cut, if any. The US Federal Reserve's next meeting is scheduled for September 17-18, 2024.

US Federal Reserve Chair Jerome Powell recently indicated that it was time for the US central bank to reduce interest rates as inflation rates aligned with its target. Addressing the much-awaited Jackson Hole Symposium last month, Powell said that "the time has come for policy to adjust" but stopped short of hinting at the quantum of interest rate cut.

It is most likely that the US central bank will loosen its monetary policy, but investors are monitoring the extent of the cut - shallow or deep.

"The September Federal Open Market Committee (FOMC) meeting is expected to be when the US Fed will start lowering rates, though uncertainty persists over how much the Fed will lower rates this year," S&P Global Market Intelligence said in a weekly note.

Investors remained mixed with equal proportions of US equity investors seeing the likeli-

hood for just 50 or 75 basis points worth of cuts in 2024, said S&P Global Market Intelligence.

Inflation has been a pain point for the policymakers in the US, who wish to bring retail inflation to 2% on a sustainable basis. The silver lining is that the latest inflation data (for August) showed that the inflation rate is steadily moderating towards the intended target.

Foreign portfolio investors seemed to have upped their investments in India, hoping for a better return on investments amid high chances of interest rate cuts in the US.

Indian markets surged strongly last week, reclaiming record highs, largely supported by positive global cues.

According to Ajit Mishra -SVP, Research, Religare Broking, "Looking ahead, the coming week will be critical with the US Fed meeting scheduled, and its outcome expected on September 18. With a 25 bps rate cut already priced in, a significant market reaction is unlikely. The Fed's guidance on inflation, growth, and future rate cuts will be key in shaping broader market sentiment, particularly regarding global liquidity and risk appetite.

"A 50 bps cut could spark a positive reaction, especially in emerging markets like India. However, this effect may be short-lived as it could also raise concerns about the underlying strength of the U.S. Economy."

Domestically, participants in Indian markets will also be closely monitoring wholesale inflation data. Mishra advised that along with banking and financials, investors must focus on IT, real estate, and metals for long trades while being selective in other sectors.

# IMF sees Fed to begin rate cuts as inflation falls

Washington, US - The International Monetary Fund (IMF) expects the US Federal Reserve to begin interest rate cuts next week as inflation is falling in the world's biggest economy.

IMF spokesperson Julie Kozack told a press briefing Thursday that inflation in the US has declined in response to the Fed's actions, and the IMF sees inflation on a path to the Fed's 2% target.

"The Fed's efforts were aided by important supply side gains and strong prod u c t i v i t y growth. We expect course PCE inflation to ond this woor

end this year around 2.5 percent and be back to target by mid 2025," she said." There is less upside risk to this path than we saw earlier this year."

"With this recent data, it shows that the balance of risks has clearly shifted with labour markets cooling and upside risks to inflation, as I just noted, less pronounced. And that means that we see the imminent start of a loosening cycle as telegraphed by the Fed as appropriate," she

Frankfurt, Germany – European Central Bank (ECB) President Christine Lagarde reaffirmed a cautious, data-dependent ap-

"Inflation is expected to rise again in the latter part of this year, partly because previous sharp falls in energy prices will drop out of the annual rates. It should then decline towards our target over the second half of next year," Lagarde explained. On the growth side, the eurozone economy is expected to grow by 0.8% in 2024, rising to 1.3% in 2025 and 1.5% in 2026, a slight downward revision due to weaker domestic demand over the coming quarters. "The risks to economic growth remain tilted to the downside," Lagarde said, adding that "credit growth remains sluggish amid weak demand."

garde's press conference, however, was the need for European structural reforms to boost growth and productivity.

Riyadh, Saudi Arabia – Saudi Arabia's General Authority for Statistics (GASTAT) released the Consumer Price Index (CPI) for August 2024. The index shows Saudi Arabia's annual inflation rate held steady at 1.6% in August 2024.

Inflation slightly ticked up from 1.5% in both June and July, following a threemonth period of stability at that rate. This marginal increase was driven by an 8.9% rise in the prices of the housing, water, electricity, gas, and other fuels sector, and a 0.9% increase in the prices of food and beverages. In contrast, the prices in the transportation sector decreased by 3.4%.

The stable inflation rate indicates consistent stability over the year, and Saudi Arabia's robust economic resilience.

It also underscores the efficacy of Saudi Arabia's economic strategies and timely decisions in addressing global inflation and price surges.

According to GASTAT, CPI measures the price of a fixed basket of 490 goods and services paid by consumers. The basket is selected based on a 2018 household income and expenditure survey, which determined the items and their respective weights.

Prices are collected through on-site visits to sales points. SPA proach to monetary policy, stressing that decisions would be made "meeting by meeting" based on economic data, without committing to a fixed rate path. At its September meeting, the

ECB cut its deposit facility rate by 25 basis points to 3.5%, as expected, stating that "it is now appropriate to take another step in moderating the degree of monetary policy restriction."

However, Lagarde underscored that future policy moves remain uncertain and will depend on incoming economic indicators.

"Our interest rate decisions will be guided by the inflation outlook, incoming data, and the transmission strength of our monetary policy."

Lagarde stated that the decision to lower the deposit facility rate by 25 basis points to 3.5%

was taken unanimously. Other key rates were adjusted

as part of broader changes to the monetary policy framework, effective from 18 September. Notably, the main refinancing operations rate was cut by 60 basis points to 3.65%, narrowing its spread to the deposit facility rate to 15 basis points. The marginal lending facility rate was similarly reduced by 60 basis points to 3.9%, preserving a 25basis-point spread over the refi-

nancing rate.

Regarding the economic outlook, recent inflation data has come in as expected, with ECB's new staff projections aligning with earlier forecasts.

Headline inflation is forecast

The ECB will meet again on 17 October, but Lagarde clearly refrained from making any speculations about future interest rate moves.

The core message of La-

She praised Mario Draghi's report on European competitiveness and Enrico Letta's report on strengthening the single market, both of which underscore the urgency for reform and offer concrete proposals.

"It's a formidable report" that presents "a diagnosis which is severe, but which is just in our view," she said.

She added that it "points to structural reforms, practical proposals to achieve such structural reforms that could be extremely helpful for Europe to be stronger, but also for us as a central bank, to achieve better results in our monetary policy if productivity can rise as a result of the structural reforms."

"Structural reforms are the responsibility of the governments," she remarked.

# China firmly opposes US tariff hikes on Chinese goods

**Beijing, China –** China is strongly dissatisfied with and firmly opposes US abuse of Section 301 to hike tariffs on some Chinese goods, the Ministry of Commerce said Saturday.

The Office of the United States Trade Representative on Friday announced final modifications concerning the statutory review of the tariff actions toward China under Section 301.

China has repeatedly lodged solemn representations with the U.S. side concerning the Section 301 tariffs, said a spokesperson for the ministry.

The World Trade Organization (WTO) has already ruled that the Section 301 tariffs violate WTO rules. However, instead of rectifying its wrongdoings, the US side further increases tariffs on Chinese products, adding one mistake to

another, said the spokesperson. The move is a typical practice of unilateralism and trade protectionism, said the spokesperson, adding that it seriously undermines the international trade order, as well as the security and stability of global industrial and supply chains.

Moreover, the move not only fails to solve the United States' own problems concerning trade deficits and industrial competitiveness, but also pushes up prices of US imports and forces US companies and consumers to bear the additional costs.

The 2024 Report on WTO Compliance of the United States, which was released Thursday by the ministry, once again expressed serious concern over the US abuse of Section 301, and pointed out that the United States is a "disrupter of global in-



US Trade Representative on Friday announced final modifications concerning the statutory review of the tariff actions toward China under Section 301 dustrial and supply chains."

The US side had previously sought public opinions on the results of the Section 301 tariff review. The majority of opinions either opposed the imposition of additional tariffs or requested broader tariff exemptions.

"This shows the Section 301 tariffs are unpopular among the U.S. public," said the spokesperson.

The United States should rectify its wrongdoings immediately and remove all additional tariffs on Chinese goods, the spokesperson said, adding that China will take necessary measures to firmly safeguard the interests of Chinese enterprises.

Also on Saturday, the China Council for the Promotion of International Trade (CCPIT) said that the unilateral measures, which are clearly against the WTO rules, will seriously undermine the confidence of relevant Chinese and U.S. industries in long-term stable cooperation, and have a negative impact on global industrial and supply chain cooperation.

China's business community strongly opposes such actions, said a CCPIT spokesperson.

The CCPIT and the China Chamber of International Commerce have always advocated for cooperation among business communities around the world. Once again, they called on the United States to respect the laws of the market economy and the principles of fair competition, immediately cease its wrongdoing, and resolutely uphold the multilateral trading system with the WTO at its core, the spokesperson said. # Sanad centres cleared 2,433 jobs till Aug

Mohammed bin Salem al Mushaikhi, Director of Sanad Service Centres in the Ministry of Commerce, Industry, and Investment Promotion (MoCIIP), said that the Sanad Service Centres in the country have achieved their desired goals in recent months, successfully completing numerous services that simplify and expedite processes for customers. "These centers have also pro-

vided 2,433 job opportunities by the end of August," he said. The 'Sanad Services' portal received around 6.7mn visitors seeking information and electronic services. These centres, affiliated with MoCIIP, witnessed increasing demand for transaction processing, completing

more than 900,000 transactions and electronic services within the first eight months of 2024, he informed.

A total of 608,907 transactions were completed through the Sanad Services electronic portal, while 292,132 services were processed through the centres' access to the Oman Business Platform, the official further stated.

Till the end of August, 913 centres were providing around 370 electronic services.

### **Trusted platform**

"From January to August 2024, Sanad Service Centres completed 901,039 transactions and

services," Mushaikhi said. According to the statistics of the Sanad Services electronic portal, Muscat Governorate accounted for the largest share of completed services, representing 48% of the total services, followed by North Batinah governorate with 13%, and Dhofar governorate with 7%.

Mushaikhi noted that approximately 23 governmental and private institutions offer their services through Sanad Service Centres.

These services vary according to customer needs and include over 370 different offerings, such as medical examination forms, business registration, work permits, contracts, technical and health services, water services, vehicle registration, taxi plate registration, and more.



The centres also collaborate with newspapers to provide advertisement services.

Moreover, sanad centres cooperate with electricity and water companies to expedite customer transactions with high accuracy. They collaborate with Nama Group for tasks such as service requests, customer data updates, meter inspections, and billing issues.

Mushaikhi highlighted the growing demand for the Sanad Services electronic portal, which has seen approximately 6.7mn visitors seeking information and services across various centers in the Sultanate of Oman.

He emphasised that this reflects trust in the sanad centres' employees, who strive to provide the best service and expedite transaction completion. Some

centres have even increased their workforce to up to 18 employees to extend working hours and reduce waiting times.

### Supporting egovernance

Mushaikhi explained that significant efforts are being made through Sanad Service Centers to achieve excellence in providing electronic services, both governmental and private, in line with Oman's e-government strategy. With 913 centres currently

spread across the governorates, Muscat leads with 265 centres, followed by North Batinah with 144, and Dhofar with 119.

Other governorates also have numerous centres, such as South Batinah, Dakhliyah and North Sharqiyah. He underlined that sanad centres are managed by a highly trained national workforce, facilitating transactions for individuals and private enterprises with governmental entities

This contributes to the national e-government strategy and supports the economy by promoting small and medium enterprises, while also providing more job opportunities for Omanis.

Mushaikhi mentioned that MoCIIP continuously monitors customer feedback on Sanad services and works to simplify procedures and introduce new transactions. In recent months, the ministry has conducted workshops to explore expanding electronic services for citizens, residents, and investors. The ministry also seeks to support Sanad Service Centres by overcoming challenges, ensuring their sustainability, and involving centre owners in future ministry plans.

Regarding the identity of Sanad centres, Mushaikhi stated that it is part of a continuous development initiative aimed at enhancing the centres' leadership in electronic services.

The identity is a key step toward achieving the desired development, with the ministry ensuring that customers feel they are dealing with a large, well-organised institution, delivering consistent, high-quality services.

# SpaceX's Polaris Dawn mission capsule returns to Earth

Washington, D.C., US -SpaceX's Polaris Dawn mission capsule, carrying tech entrepreneur Jared Isaacman, two SpaceX engineers and a former Air Force Thunderbird pilot, splashed down off the coast of Florida early on Sunday,

The Dragon spacecraft splashed down in the Gulf of Mexico at 3:37am local time (0737 GMT/UTC), a webcast of the splashdown showed, with a recovery team deploying to retrieve the capsule and four crew

members "We are mission complete," Isaacman radioed as the capsule bobbed in the water in anticipa-

tion of the recovery team. The spacecraft reached a peak altitude of 875 miles (1,408km), taking the crew to the farthest point humans have ever travelled from Earth since the Apollo missions to the Moon. During a five-day journey, the crew conducted the first private spacewalk while orbiting nearly 740km (460 miles)



above Earth, higher than the International Space Station and the Hubble Space Telescope.

Isaacman became just the 264th person to complete a spacewalk, and SpaceX's Sarah Gillis became the 265th. Until now, all spacewalks have been performed by professional astronauts.During Thursday's commercial spacewalk, the Dragon capsule's hatch was open for just under half an hour. Isaacman emerged in space only to his waist to briefly test

SpaceX's brand-new spacesuit, followed by Gillis, who was knee-high as she bent her arms and legs for several minutes.

The spacewalk lasted less than two hours, significantly shorter than spacewalks on the International Space Station. Most of that time was spent depressurising the entire capsule and then re-pressurising the cabin. Even SpaceX engineer Anna Menon and mission pilot Scott 'Kidd' Poteet, who remained strapped in, wore

spacesuits. This was the 41year-old Isaacman's second charter flight with SpaceX, with two more to come under his personally-funded space exploration programme called Polaris, after the North Star.

Polaris Dawn was the first of three missions under the programme. The founder and CEO of credit card processing company Shift4 split the cost with SpaceX. Isaacman won't reveal how much he spent. DW

# **Heavy rainfall devastates Central Europe**

Poland, Slovakia, Hungary, southern Germany and parts of Austria are expected to see more heavy rain

Berlin, Germany - Emergency responders in the Czech Republic, Poland, and Austria struggled to manage rising waters even as Romania reported four flood-related deaths on Saturday amid unprecedented heavy rainfall.

Poland, Slovakia, Hungary, southern Germany and parts of Austria are expected to see more heavy rain.

Some areas in Austria have been declared disaster zones and residents evacuated from there.

In Czech Republic, the northwestern administrative region of Usti and Labem bordering Germany is worst affected, with more than 20,000 households without power.

The highest flood alert level has been issued in approximately 35 locations across the Czech Republic. Authorities also suspended all shipping traffic.

Krakow in Poland was hit hard, with residents being evacuated and public transport disrupted.

On Friday, when authorities pealed to residents to stock up



trapped in their homes overnight. One person was rescued from floodwaters of the Pielach River, west of Vienna.

Several municipalities issued evacuation orders, with rubber dinghies pressed into use.

In Vienna, parts of the underground lines were suspended.

One person drowned and 1,600 people were evacuated in the Klodzko district of southwestern Poland as local rivers rose to record levels after days of heavy rainfall.

Krakow in Poland was hit hard, with residents being evacuated and public transport disrupted

"The situation is very dramatic, it's most dramatic in Klodzko county," Prime Minister Donald Tusk told reporters on Sunday after meeting with the crisis management team in the town of Klodzko.

Some 17,000 households in

the district were left without power, and cellphone service was down in some areas. Road access to the towns of Ladek Zdroj and Stronie Slaskie was virtually cut off, Tusk said.

Klodzko, a town of 25,000, was partially submerged as the local river rose nearly 7 metres (about 22 feet), well above the alert level of 240 and surpassing a record set during heavy flooding in 1997 that partially damaged the town and claimed 56 lives in Poland.

Meanwhile, authorities de-

clared the state of Lower Austria, surrounding Vienna, a disaster zone due to severe flooding from continuous heavy rain on Sunday.

Lower Austria Deputy Governor Stephan Pernkopf warned of 'massive floods' and potential

landslides in some places, according to the APA news agency, adding that 'the situation is worsening due to the massive rainfall across the country'.

Around Vienna, roads are flooded and emergency services had to step in to rescue people Czech border. Since Friday morning, southwest Poland has received more rain than during the 1997 millennium flood, with alert levels surpassed at 47 gauging stations nationwide. DW

## Venezuela: 6 held for plotting to kill Maduro

Caracas, Venezuela - Venezuela announced on Saturday the arrests of six foreign nationals for allegedly plotting to assassinate President Nicolas Maduro.

Interior Minister Diosdado Cabello confirmed the arrests at a news conference in Caracas and said the three suspects from the US, two from Spain and a Czech national were planning to assassinate Maduro and organise 'terrorist acts' within the country.

Cabello said 400 rifles and pistols, allegedly sent from the US, were seized during an intelligence operation, which he said would be used to 'cause violence' in Venezuela. He claimed that the two Spanish nationals who were arrested were linked to Spain's National Intelligence Centre (CNI).

# **Eight migrants die in English Channel off northern France**

Paris, France - Eight migrants died while crossing the English Channel off northern France, French media reported on Sunday.

French media and several international outlets reported that the incident off Ambleteuse in the Pas-de-Calais region took place overnight, leading to a rescue operation that brought survivors to a local sports hall.

This incident coincided with a busy period for French authorities, who rescued around 200 people from distressed boats over 24 hours.



The migrants rescued included 55 individuals from Le Portel and 61 from La Becque d'Hardelot, according to the media

UK Foreign Secretary David Lammy lamented the incident, noting the dangerous conditions faced by irregular migrants.

"It's awful. It's a further loss of life," he told a BBC programme. The government has been 'discussing how we go after those (human smuggling) gangs, in cooperation upstream with other European partners', he added. He also called for more coordinated efforts to combat human trafficking.

But Steve Valdez-Symonds from Amnesty International UK criticised the lack of safe asylum routes, saying: "The government's 'smash the gangs' slogan ... contributes to the death toll."

He also called for shared responsibility between the UK and France to prevent future tragedies.

These deaths follow a similar incident less than two weeks ago where 12 people died after a boat broke apart in the channel. Anadolu Agency

# Germany's Scholz heads to Central Asia in bid to expand relations

Berlin, Germany - German Chancellor Olaf Scholz is to kick off a three-day trip to Central Asia on Sunday with a visit to Samarkand in Uzbekistan, where migration is likely to be the focus of talks with Uzbek President Shavkat Mirziyoyev.

Scholz's trip will also take him to Kazakhstan, where he will join a summit with all five former Soviet republics in the region.

The tour comes as Germany seeks closer ties with Central Asian nations, which are heavily under the influence of Russia and China.

### Migration on the agenda

In Uzbekistan, Scholz is expected to sign several migration agreements with the Uzbek leader. Among them is a deal making

it easier for skilled Uzbek workers to immigrate to Germany, while also facilitating the return of Uzbeks to their homeland if they are required to leave.

There could also be an agreement on making it possible to derejected Afghan port asylum-seekers in Germany back to Afghanistan via Uzbekistan.



### **Regional summit**

On Monday and Tuesday, Scholz will visit Kazakhstan, the biggest economic power in the region. The visit will include a sum-

mit on Tuesday with all five former Soviet republics in the region - Uzbekistan, Kazakhstan, Kyrgyzstan, Tajikistan and Turkmenistan.

Germany entered into a strategic partnership with the countries last year that encompasses economic issues, energy, climate and the environment.

Talks in Kazakhstan are also likely to centre on oil and gas supplies to Germany, as well as sanctions on Russia for its invasion of Ukraine.

Kazakhstan has been accused of helping Moscow bypass some of those sanctions.

Meanwhile, Scholz on Saturday ruled out the delivery of long-range precision to Ukraine in the future regardless of decisions made by NATO allies.

He made the comments while responding to questions at a citizen's dialogue event in the town of Prenzlau in Germany's eastern state of Brandenburg.

Ukrainian President Volodymyr Zelensky has been requesting long-range weapons so that Ukrainian forces can attack Russian logistics and military airfields far behind the front line. Scholz said that the delivery of Taurus cruise missiles would entail 'a great risk of escalation' of the Ukraine conflict. DW

# **Missile from Yemen lands** in central Israel, 9 injured

Jerusalem - Nine Israelis were injured on Sunday with minor wounds as they rushed to shelters following the launch of a surface-to-surface missile from Yemen towards central Israel.

In a brief statement, the Israeli army said that 'following the alerts activated in central Israel, a surface-to-surface missile was detected entering the country from the east and landed in an open area without causing any injuries'.

The army added that the missile was launched from Yemen, and the explosive sounds heard moments earlier were due to the interceptor missiles. The Israeli army also said the results of the interception are under investigation.

Daily Haaretz reported that the missile landed in an open area in central Israel on Sunday morning. Following its detection, numerous alarms were activated in illegal settlements across central Israel, and interceptor missiles were launched from both the Arrow and Iron Dome systems. The army is still determining whether the interception was fully successful.

Haaretz also said fragments from the interceptor missiles landed at a train station on the outskirts of Modi'in in central Israel, causing damage.

Additionally, a fire broke out in an open area in Kfar Daniel near the city of Lod in central Israel due to more falling debris.

Israeli Army Radio reported that 'the ballistic missile launched from Yemen travelled a distance of approximately 2,000km (1,243 miles), taking

The radio added that the air force is considering the possibility that one of the Arrow interceptor missiles partially hit the incoming missile from Yemen. Israel's emergency medical services confirmed in a state-

belt at the Nesher plant. The fire was reported at 6:30am local time (0430GMT), just as missile defence systems across the country were activated. The cause of the blaze is being investigated by the fire department.

# EU naval mission starts Red Sea oil tanker salvage

Athens, Greece - An operation trying to salvage a stricken oil tanker, burning in the Red Sea for almost a month now after attacks by Yemen's Houthi rebels, has begun, according to a European Union naval mission on

Saturday. The EU's Operation Aspides released images showing its vessels escorting three ships making their way toward the Greek-flagged oil tanker Sounion.

The operation aims to prevent an environmental disaster in the region.

salvage attempt A Greek defence ministry source told AFP news agency that Aigaion Pelagos, a Greek-flagged tugboat, 'has begun to gradually tow the tanker northwards, escorted by military vessels'.

Satellite images analysed by the Associated Press confirmed the presence of three salvage vessels near the Sounion, with a warship nearby. According to the Greek state news agency ANA-MPA, 'three frigates, helicopters and a special forces unit' were involved in the salvage operation, including the Aigaion Pelagos.

Beirut, Lebanon - Israeli aircraft dropped leaflets in southern Lebanon on Sunday urging residents to evacuate, according to local media.

The leaflets called on residents of the town of al-Wazzani town and its surroundings to leave, the state-run National News Agency reported.

The warning came as four people were injured in Israeli artillery shelling in Kfar Kila and Odaisseh in southern Lebanon as they evacuated their homes, the broadcaster said.

The Israeli army said early on Sunday that around 40 rockets were fired from southern Lebanon towards northern Israel, causing several fires.

Lebanese group Hezbollah confirmed that it had targeted

Israel has continued its brutal offensive on the Gaza Strip following an attack by the Palestinian group Hamas last October 7.

The Israeli onslaught has displaced almost the entire population of the territory amid an ongoing blockade that has led to severe shortages of food, clean water and medicine. Anadolu Agency

"Despite challenging conditions, with temperatures reaching up to 400 degrees Celsius (roughly 750 degrees Fahrenheit) due to the fire, the specialised salvage team successfully secured the tanker to the Aigaion Pelagos," ANA-MPA reported. A previous salvage at-

tempt was aborted earlier this month because of the unsafe conditions.

The Sounion was attacked by Iran-backed Houthis on August 21 while carrying

Will Turkey's bid to join BRICS speed up progress in EU accession talks?

Istanbul, Turkey - Turkey has decided to officially bid to join BRICS, a grouping of some of world's emerging the economies, originally comprised of Brazil, Russia, India, China and South Africa - but largely dominated by Moscow and Beijing.

Omer Celik, spokesperson for Turkish President Recep Tayyip Erdogan's ruling Justice and Development Party (AKP), confirmed Turkey's application and said that the request was 'pending'.

"Our president has already expressed multiple times that we wish to become a member of BRICS," he said in early September. "Our request in this matter is clear, and the process is proceeding within this framework.'

Russian President Vladimir Putin welcomed Turkey's aspiration, according to Turkish media reports, and said that he will 'fully support' Turkey's inclusion in the gathering.

If Turkey indeed becomes a member of BRICS, often described as a counterbalance to a Western-led global order, it could move further away from joining the European Union (EU) - and from deriving benefits of the 27-member bloc's single market.

Turkey has the right to decide on its own international partnerships, the EU, however, expects candidate country to support EU values, according to Peter Stano, a spokesperson of the EU's diplomatic service.

"We expect all EU candidate

countries to support EU values firmly and unequivocally, to respect obligations deriving from relevant trade agreements, and align with the EU's Common Foreign and Security Policy,"

Stano told DW.

"These are significant signals of shared values and interests, and of countries' strategic orientation," he added. Some see Turkey's aim to

join the BRICS group as a reaction to its lagging progress in EU accession talks.

In an annual report last year, European parliamentarians concluded that Turkey's 'align-

ment rate with the EU's Common foreign and security policy has slipped to an all-time low of 7%, making it by far the lowest of all enlargement countries'. Nacho Sanchez Amor, a parliamentarian with the Socialists and Democrats group in the European Parliament, said Turkey's path to the EU is through reforms. "We have recently seen a renewed interest from the Turkish government in reviving the EU accession process," he noted in the 2023 statement.

"This will not happen because of geopolitical bargaining, but only when the Turkish authorities show real interest in stopping the continuing backsliding in fundamental freedoms and rule of law in the country."

Turkey's accession process started in 2005, but ground to a standstill in 2018 over several issues

# **Manipur: Why peace remains elusive?**

The latest flare-up of violence occurred on September 1, after months of relative calm

New Delhi - More than a year after deadly ethnic violence broke out between the majority Meitei community and the minority Kuki in India's northeastern state of Manipur, tensions continue to rage.

Peace has remained elusive and - according to many in the state - so has a concrete action from the government.

The latest flare-up of violence occurred on September 1, after months of relative calm.

According to authorities, several people have been killed in drone and rocket attacks

The use of such aerial weapons is a first for the restive state and the government called it a 'significant escalation' of violence.

The police in Manipur claim that Kuki groups carried out the drone attacks on Meitei-dominated areas. Kuki organisations, however, refute the allegations, saying that it was the Meiteis who used drones.

Last year was the first time that the Meitei, who are predominantly Hindu, live mostly in and around the state's capital city Imphal, and the Kuki - who

are mainly Christian and inhabit the surrounding hills - clashed against each other.

It came on the heels of a demand by the Meitei community to be officially accorded tribal displaced.

### State inaction?

Activists have questioned the response of the authorities to quell the violence. Many have pointed out that Prime Minister Narendra Modi is yet to visit the state or make a comprehensive statement.

"There is a total abdication of the responsibility to protect the lives and the properties of the people in Manipur and that's why the anger of Manipuris is going very deep," a Manipuri activist, who asked not to be named, told DW.

lutely flabbergasted. How come India, with its sophisticated weaponry, intelligence and technology, is not able to control the situation in a tiny part of the country? It has been going on for 16 months. This is what every Manipuri is asking," she added.

### What's behind ethnic tensions?

Tellang Letminlen Haokip, a Kuki student leader from Churachandpur, said his community has been discriminated against for decades and that the ethnic tensions run deep.

"We have been economically and politically exploited. There is a huge mistrust between those living in the hills and those in the valley. There is hardly any development work in the hills. All good infrastructure is in the valley and we are denied sources of development and opportunities," he said.

40-year-old Surjit, from the Meitei ethnic group, described the ethnic divisions as 'a ticking time bomb that has exploded'.

He noted that the Meiteis have been deprived of buying land in the hills, and that illegal migration of Kukis from Myanmar over the years has added to the strife.

"We want a scheduled tribe status, so that we can buy land in the hills, which currently we cannot," he said, referring to an official designation which would grant privileges and affirmative action benefits under India's constitution.

"Then there is also the problem of illegal migration from Myanmar," he stressed, accusing the Kukis coming illegally from Myanmar of poppy cultivation and drug trafficking.

"After attempts from Imphal to destroy these plantations as part of a war on drugs, they (the Kukis) feel that they have been wronged by the Meiteis staying in the valley. But in my view, it's not wrong to destroy something that could lead to people of the state falling prey to drugs," he said. DW

### China issues warning as **Typhoon Bebinca approaches**

Beijing, China - China has issued an emergency response to flooding as strong rainfall as the approaching Typhoon Bebinca is expected to impact southeastern regions of the country, state media reported on Sunday

The warning comes as Bebinca moved away from Japan's southwestern island region of Amami early on Sunday and headed northwest across the East China Sea, Tokyo-based Kyodo News reported.

The Japan Meteorological Agency reported that the typhoon was located about 230km (143 miles) westnorthwest of the city of Amami and was moving northwest at around 25km per hour.

Bebinca, the 13th storm this year, packed winds of up to 180kph (112mph) with an atmospheric pressure of 965 hectopascals at its centre.

It is expected to weaken to a tropical storm on Monday or later.

China's Water Resources Ministry has issued a Level-IV emergency response to flooding for Shanghai and the provinces of Jiangsu, Zhejiang, and Anhui, state-run broadcaster CGTN reported. Anadolu Agency

# Bangladesh: US pledges support for renewed growth

Dhaka, Bangladesh - A visiting US delegation, the first from the West since Bangladesh's transitional government took office in August, has pledged to support the country's path towards renewed growth and expanded economic opportunities.

The delegation made the pledge after meeting with Muhammad Yunus, the transitional government head, on Sunday in the capital Dhaka, according to a US Embassy social media post.

The US affirms its 'dedication to fostering inclusive economic growth, institution building, and development to benefit the people of Bangladesh', said the post, adding: "As Bangladesh looks to chart a more equitable and inclusive future, the US stands ready

to support those efforts." Brent Neiman, assistant Treasury secretary for international finance, is leading the US delegation, which also includes Assis-

tant Secretary of State for South and Central Asia Donald Lu. The team arrived on Saturday for a three-day official visit.

The visiting team also met

foreign affairs adviser Md Touhid Hossain. "We are committed to helping expand economic opportunities, build institutional capacity, uphold human rights, and mitigate climate risks with our partner, Bangladesh," said the US Embassy following their meeting. The embassy also said that they support Bangladesh's path towards renewed dynamism and growth.

"With the right economic reforms in place, the American private sector can help unlock Bangladesh's growth potential through trade and investment," said the embassy following a meeting with Bangladeshi businesspeople on Saturday.

Nobel laureate Yunus took charge on August 8 after former Prime Minister Sheikh Hasina fled in the face of a student-civilian uprising. In an interview, she later claimed the US was behind her ouster.

London, England - Gabriel Magalhaes' second-half header earned Arsenal a crucial 1-0 win at Tottenham Hotspur in a feisty north London derby on Sunday to keep pace with early Premier League leaders Manchester City.

Spurs started sharper and David Raya was forced into early saves, turning Dejan Kulusevski's first-time effort behind before he clawed away a dangerous cross from the Sweden winger.

Record signing Dominic Solanke, making his home debut, squandered a good opening in the 14th minute after Arsenal lost possession deep in their own half, taking too long on the ball and allowing William Saliba to recover

Arsenal fought their way into the contest, with Guglielmo Vicario tested by a Kai Havertz header before Gabriel Martinelli scuffed his shot with Bukayo

### 'England could face **Euros** ban over regulator plans'

London, England - UEFA has warned the UK government that England risk a ban from the Euro 2028 tournament they are cohosting if Prime Minister Keir Starmer goes ahead with existing plans for a men's football regulator, British media reported.

In a letter to Culture Secretary Lisa Nandy, obtained by The Times and the BBC, European soccer governing body UEFA's General Secretary Theodore Theodoridis said there should be "no government interference in the running of football".

According to the letter, Theodoridis cautioned against plans outlined in the King's Speech to give the new regulator the power to oversee clubs in England's top five leagues, saying the game's independence was a "fundamental requirement". "One particular area of concern stems from one of UEFA's fundamental requirements, which is that there should be no government interference in the running of football," Theodoridis wrote. "We have specific rules that guard against this in order to guarantee the autonomy of sport and fairness of sporting competition; the ultimate sanction for which would be excluding the federation from UEFA and teams from competition."

# Forest stun Liverpool; Man City's Haaland continues scoring spree

# Proud of the way we played as a team,

London, England - New Liverpool manager Arne Slot suffered his first setback as his side surprisingly lost 1-0 at home to Nottingham Forest in the Premier League on Saturday but Manchester City maintained their perfect start to the season.

Forest had not tasted victory at Anfield since 1969 but Callum Hudson-Odoi's 72nd minute curler beyond Liverpool goalkeeper Alisson secured the three points as Nuno Espirito Santo's side moved into the Premier League's top five

Erling Haaland, whose place in Manchester City's side was in doubt after being granted compassionate leave this week, continued his incredible start to the season with two goals as City recovered from conceding after 22 seconds to win 2-1.

Reigning champions City are top with a maximum 12 points from four games, with Liverpool second on nine along with third-

placed Aston Villa who hit back from 2-0 down to beat Everton 3-2 thanks to an Ollie Watkins double and a stunning Jhon Duran winner that left the visitors still without a point. Fourth-placed Brighton & Hove Albion, who drew 0-0 at home to promoted Ipswich Town, are on eight points along with Forest.

Manchester United's new signing Matthijs de Ligt grabbed his first goal of the campaign and Marcus Rashford scored for the first time since March as Erik Ten Hag's side cruised to a 3-0 victory at Southampton who are yet to earn a point.

Chelsea rode their luck at Bournemouth in the late kickoff but earned their second league success of the season with the substitute poking home in the 86th minute for a 1-0 victory. Bournemouth twice hit the woodwork and had an Evanilson

penalty saved by Robert Sanchez in the first half.

Liverpool, England - Nottingham Forest manager Nuno Espirito Santo said he was proud of the way his team played, despite injuries to key players, to clinch their first win at Anfield since 1969 by beating Liverpool 1-0 in the Premier League on Saturday.



from a last-gasp defeat when he blocked a shot by Emmanuel Gyas in stoppage time.





Baku, Azerbaijan - Oscar Piastri won the Azerbaijan Grand Prix as McLaren went top of the constructors' standings in a race that finished with a virtual safety car after a penultimate lap collision between Ferrari's Carlos Sainz and Red Bull's Sergio Perez.

Ferrari's pole-sitter Charles Leclerc, who was overtaken by Piastri on the 20th of 51 laps and then battled nose-to-tail before his tyres faded, came second with George Russell inheriting third for Mercedes after the Sainz-Perez collision.

Red Bull's Formula One leader Max Verstappen finished fifth, just behind his closest title rival Lando Norris, who started 15th for McLaren and ended up fourth with a bonus point for fastest lap. "That was probably the most

A new sculpture of late Queen **Elizabeth II and the late Prince** Philip – plus corgis – attracts a mixed response

> newly unveiled sculpture of Queen Elizabeth II, Prince Philip and two corgis in Northern Ireland, intended to pay tribute to the late monarch, has received somewhat mixed reviews from the public. While the local council said the bronze statue of the Queen

infamous bust of Cristiano Ronaldo. "Even the corgi is confused," another user wrote. Online commentators were delighted by the chance to mock and deride the statue. Some questioned whether it was an accurate likeness of her majesty, with one suggesting that it more closely resembled the film character Mrs. Doubtfire, played by Robin Williams. Even a

local politician Vera McWilliam told the BBC "we have to be honest, it does not resemble the Queen in any shape or form." The Queen, has been portrayed frequently throughout her reign, but some took to the internet to accuse this latest homage of being "offensive" while another said "it's actually an insult to Her Majesty's memory."

It depicts Elizabeth, gazing into the distance, dressed in a tweed skirt, rubber boots, checked vest and headscarf, with a handbag hanging from her left arm, and two of her famous corgis at her feet. Behind her stands a likeness of her husband, Philip, his hands behind his back.

The council acknowledged that art can sometimes spark diverse opinions but said that it was 'particularly pleased with how the (Elizabeth) sculpture complements its surroundings, standing adjacent

to the statue of Prince Philip, Duke of Edinburgh, and accompanied by two lovingly crafted corgis'.

Elizabeth, who died in 2022, was one of the most photographed people in the world, and was the subject of thousands of paintings and sculptures. As such, there have been several controversial depictions of her and other members of the British royal family over the years.

opinion in the media and online, with one critic describing it as 'intolerably bad', and others calling it 'beautiful'.

Meanwhile, the first official portrait of King Charles III since his coronation also proved divisive, with its depiction of the monarch against a fiery red background that appears to almost swallow him whole. And in 2000, Lucian Freud had painted a portrait of the Queen that seemed the antithesis of earlier romanticised

'has been warmly received by most who have seen it in person,' some on social media have ridiculed it for not looking like her.

"Could be anyone," wrote one commenter on a Facebook post from the council announcing the work's unveiling. Another wrote that the sculpture was 'beautiful but didn't look like our late queen or represent how she al-

ways dressed'.

Although the council limited comments on its original post, the debate spread to X, where pictures of the sculpture gathered hundreds of thousands of views and several users compared it to the



e leads me besides still waters, in the paths of righteousness... I will fear no evil, your rod and your staff, they comfort me... It is like flicking through the biblical Psalms and reliving what they stand for.

tation of the divine. The narrative development of his works unfolds through a pictorial language based on colour and signs, such as mnemonic traces, ancient symbols that represent the search for truth, the path of life, and the encounter with the divine.

### **Duality of perception**

Matti explores the concept of the 'visible invisible', a theme that plays with the duality of what can be physically perceived and what escapes sight, but is felt or intuited spiritually. The Psalms, with their deep and meditative lyricism, reflect this tension between the tangible and intangible presence of God.

Matti Sirvio's works are a crossroads - a synthesis between geometric and organic forms that emerge from an indefinite background, as if they were in continuous movement between light and shadow, as a symbol of the divine presence that illuminates without being directly perceptible. They are a combination of forms suspended in ethereal space that recall natural elements, often mentioned in the *Psalms* with oscillations between dark tones in contrast to the light and intense shades of green, fresh, vibrant and meditative.

### Bridge between two worlds

Matti Sirvio's research has moved since his artistic debut along the path of abstraction, the most immediate and direct one that allows him to express and communicate the essence of the soul's movements, encountering the biblical message, giving it greater inspirational force.

For Matti Sirvio, the Bible is an inexhaustible creative source. His work becomes a bridge between the material and immaterial worlds, a way to express the infinite, the eternal and the mystery of God.

"The 'visible invisible' is in each one of us. Feelings, values, beliefs, convictions are all recognised by their influence. DNA may be visualised by digital symbols and blueprints but, in reality, it remains invisible. The most significant operator of our inner man continues to be hidden. God is present, invisibly," Matti said explaining the essence of his collection.

"Abstract, in my understanding, refers to everything non-material. True spirituality cannot be captured by man-made rituals and ceremonies. The spirit claims it's freedom like a wind (John 3:8). For an artist, the expression of this spirit in colours, shapes, and composition is
