ICT ACT AMENDMENT Draft proposes banning political parties up to 10yrs

Ministry seeks opinions from stakeholders

The interim government has prepared a draft to amend the International Crimes (Tribunals) Act, 1973, which introduces a provision that allows the banning of a political party for up to 10 years for committing crimes against humanity and genocide.

According to the draft, prepared by the law ministry, the amendment would allow the trial of leaders of any organisation for command responsibility, the appointment of foreign lawyers, and the recording

and broadcast of trial proceedings.

The move to amend the act comes at a time when the government is seeking to try those responsible for the crimes committed to suppress the July uprising that culminated in the toppling of the Hasina-led government.

According to the United Nations Office of the High

Commissioner for Human Rights (OHCHR), more than 600 people were killed between July 16 and August 11.

More than 30 complaints have been filed with the investigation agency of the International Crimes Tribunal against Hasina and her party colleagues for alleged crimes against humanity and genocide.

The government has reconstituted the prosecution and investigation agency, and the probe agency has started field-level investigation into the alleged crimes.

Israeli airstrikes kill 356 in Lebanon

1,246 wounded; tens of thousands fleeing for safety

Israel launched airstrikes against hundreds of Hezbollah targets yesterday, killing 356 people and sending tens of thousands fleeing for safety on Lebanon's deadliest day in decades, according to authorities.

After some of the heaviest cross-border exchanges of fire since the hostilities flared last October, Israel warned people in Lebanon to

Israel's military said it had struck Hezbollah in Lebanon's south, east and north.

Lebanon's health ministry said 356 people had been killed, including 24 children and 42 women, and 1,246 wounded. One Lebanese official said it was Lebanon's

highest daily death toll from violence since the 1975-1990 civil war. The Israeli air force

Through a protest note handed over to the deputy high commissioner of India in Dhaka, the foreign ministry conveyed its "serious reservation, deep sense of hurt and extreme displeasure", according to a ministry statement published on its Facebook page.

The announcement is expected to come after the chief adviser's return from the UN General Assembly in New York," he said.

RMG worker unrest spirals in Ashulia Now 52 factories shut

The Ashulia industrial belt saw an increased number of garment factories shut yesterday amid a fresh wave of protests by workers of dozens of units over several demands, including pay hike.

Meanwhile, factory owners reiterated their call to ensure safety for the smooth operation of the industry as 52 factories, mostly apparel units, have been shuttered in the latest round of unrest. Of them, 19 were shut yesterday.

Md Sarwar Alam, superintendent of police at Ashulia Industrial Police-1, said 43 factories have been shut under the "no work, no pay" provision of the labour law.

Of the closed factories, 39 are members of the Bangladesh Garment Manufacturers and Association Exporters SEE PAGE 2 COL 2

Released top criminals at it again

Nasir Biswas, a 26-year-old mason, was walking close to the Martyred Intellectuals' Graveyard in the capital's Mohammadpur on the evening of September 20.

Criminals attacked and stabbed him multiple times around 6:30pm. He was rushed to the Dhaka Medical College Hospital where doctors pronounced him dead around 8:45pm.

Nasir's brother, Sumon Biswas, yesterday said his brother was murdered by some associates of Imamul Hasan Helal alias Pichchi Helal over a previous enmity.

"Multiple evewitnesses informed me that Helal was at the scene during the stabbing," he told The Daily Star.

Sumon, however, could not confirm the specifics of the previous enmity.

He lodged a murder case at Mohammadpur Police Station on September 21, naming six suspects, including Helal.

Iftekhar Hasan, officer-in-charge of Mohammadpur Police Station, said the complainant in the FIR mentioned that Helal was present at the crime scene.

"We have launched an investigation and are already collecting footage to determine Helal's involvement in the murder. He has since gone into hiding," he told The Daily Star.

Helal was listed as one of the top 23 criminals by police in 2001.

Then a Chhatra Dal leader, Helal was arrested on January 12, 2000. He was released on bail on August 16 this year.

Several residents of Mohammadpur have alleged that Helal's associates have been intimidating local business owners to assert dominance in the area since his release. SEE PAGE 2 COL 1

The number of migrants arriving in Britain by crossing the Channel in small boats has topped 25,000 since the start of the year, provisional figures showed vesterday.

The figures come as the new Labour government -- like the last Conservative administration struggles to reduce the cross-Channel arrivals.

Some 717 migrants crossed the Channel from northern France on Sunday, taking the cumulative number of arrivals so far in 2024 to 25,052, according to the interior ministry.

A similar number, 707, also made the crossing on Saturday.

The total represents a four percent rise on the equivalent figure at this point last year, but a 21 percent drop on 2022.

Stopping the small boat arrivals on England's southern coast was a key issue in Britain's general election in July.

According to the Department of Prisons, Helal is among 43 top criminals and militants, who secured bail in different cases after the fall of the Awami League government on August 5.

Among these criminals are Abbas Ali alias Killer Abbas of Mirpur, Sheikh Mohammad Aslam alias Sweden Aslam of Tejgaon, Sanjidul Islam alias Emon of Hazaribagh, Khandaker Nayeem Ahmed alias Tipton and Khorshed Alam alias Rasu alias Freedom Rasu.

On December 26, 2001, the home ministry released the names of 23 top terrorists, including Abbas, Helal, Tipton, and Freedom Rasu. The four were accused in many cases, including for murder and attempted murder.

Brig Gen Syed Muhammad, inspector general of prisons, said they freed some top criminals after receiving release orders from courts.

'The law enforcement agencies might be able to give further details regarding the bails," he told this newspaper recently

Tawohidul Haque, associate professor at Dhaka University's Institute of Social Welfare and Research, said notorious criminals used to control criminal activities from within jails.

He warned that their release on bail could lead to a rise in criminal activities.

Draft proposes banning political parties PROPOSED AMENDMENTS

The law ministry's Senior Assistant Secretary Ashfaqur Rahman yesterday presented the draft of the proposed amendments at a meeting at the Judicial Administration Training Administration Institute in Dhaka and sought opinions and suggestions from legal experts and protest leaders who steered the movement against the Hasina-led 3(2)(a)

regime. Amendments were proposed for eight sections of the act, which was originally formulated in 1973 to try the perpetrators of the crimes committed during the Liberation War in 1971. The law was later amended twice -- once in 2009 and again in 2013.

Opinions and suggestions will be solicited from stakeholders before finalising the amendments, said Asif Nazrul, the law adviser to the interim government, who presided over the meeting.

"The trial of these murders must be acceptable to everyone. We don't want to take revenge. We want to ensure justice."

"The prosecution and investigation teams of the International Crimes Tribunal have already been formed to facilitate the activities of the tribunal. Now the important challenge for us is to reconstitute the tribunal." A WELCOME MOVE

The participants at the meeting supported and welcomed the proposed amendments and gave suggestions.

LGRD Adviser AF Hassan Ariff and Industries Adviser Adilur Rahman Khan said more discussions will be held and opinions will be solicited from relevant persons for finalising the amendments of the ICT Act to make it stronger and better so that justice is delivered to those seeking it.

The law ministry proposes amending three sections -- 3(2)(a), 4(2), and 19 -- as well as introducing three new sections -

4(A), 13(A), and 20(A) -- and two new subsections -- sub-section (3) under section 3 and sub-section (2) under section 12. It proposed changing the definition of crimes against humanity in section

As per the existing law, crimes against humanity include murder, enslavement, extermination, deportation, imprisonment, abduction, confinement, torture, rape or other inhumane acts committed against any civilian population or persecutions on political, racial, ethnic or religious grounds, whether or not in violation of the domestic law of the country where perpetrated.

The proposed amendment states that crimes against humanity would involve murder, extermination, enslavement, deportation, imprisonment, abduction, confinement, enforced disappearance, torture, rape, gender based violence, sexual slavery, enforced prostitution, forced pregnancy, enforced sterilisation other inhumane acts committed or as part of a widespread or systematic attack against any civilian population or persecutions on political, racial, ethnic, gender, cultural or religious grounds, whether or not in violation of the domestic law of the country where

perpetrated. Section 4(2) of the existing act, which deals with command responsibility, states that any commander or superior officer who orders, permits, acquiesces or participates in the commission of any of the crimes specified in section 3 or is connected with any plans and activities involving the commission of such crimes or who fails or omits to discharge his duty to maintain discipline or to control or supervise the actions of the persons under his command or his subordinates, whereby such persons or subordinates or any of them commit any such crimes, or who fails to take necessary measures to prevent the commission of such crimes, s guilty of such crimes. To this section, the draft amendment adds "leader of an organisation, association, entity, or organised group" in the act along with any commander or superior leader. Section 19(1) of the existing act states that the tribunal shall not be bound by technical rules of evidence and may admit any evidence, including reports and photographs published in newspapers, periodicals and magazines, films and tape-recordings and other materials as may be tendered before it, which it deems to have probative value. The draft adds that data or information generated, prepared. sent, received, or stored in magnetic, electromagnetic, optical, or computer memory; audio and video recordings; Digital Versatile Disc (DVD), Digital Video Disc (DVD); records from mobile phones; hardware, software, or any other digital device may also be tendered before it, which it deems to have probative value. The draft added sub-section (3) under section 3 that states, "For the purpose of determining liability under sub-section (2), the Tribunal shall have regard to the Elements of Crime of the International Criminal Court (ICC), as adopted pursuant to Article 9 of the Rome Statute of the International Criminal Court, to the extent that they are not inconsistent with the provisions of this act."

It also proposed to add sub-section under section 12 that states, Notwithstanding anything contained in the Bangladesh Legal Practitioners and Bar Council Order, 1972 (President's Order) (President's Order No. 46 of 1972), the Tribunal may allow foreign counsel to appear before it, subject to its satisfaction that such counsel has at least 10 years' experience in the practice of international criminal law."

The draft introduces section 4(A) which states, "The Tribunal may decide to make an audio-visual recording of a hearing or part thereof. The Tribunal may decide to make available an audio or video broadcast of a hearing, or part thereof, via the Internet or other means, in accordance with any conditions set by the court to protect the safety, privacy, and dignity of participants."

Another proposed section 13(A) states, "Representatives from foreign governments, non-governmental organisations (NGOs), and international bodies may attend public hearings, trials, and other proceedings of the

Bangladesh is important for the US and Prof Yunus has a global standing," said Obaidul Haque, associate professor at Dhaka University's International Relations Department.

He said the US has been trying to deepen the engagement with Bangladesh over the last few years, but it was not going very well. Now that the interim government has taken up initiatives for widespread reforms, and promised democratic elections and good governance, Washington is showing increasing interest.

The US suspended the Generalized System of Preferences (GSP) facility for Bangladesh in the aftermath of Rana Plaza collapse in 2013, citing poor labour conditions. In 2021, it imposed sanctions against Rab and seven of its top officials over human rights violations and in May last year announced visa restrictions for those undermining democratic elections. Former prime minister Sheikh

Hasina made critical remarks of the US that was vocal about human rights, media freedom, and free and fair election ahead of the national polls on January 7 this year.

Sources in police said top criminal Ibrahim Khalil alias Killer Ibrahim, who had been hiding abroad, returned home after mid-August and resumed his criminal activities.

A leader of Bhashantek Slum, requesting anonymity, said Ibrahim's associates locked several rickshaw garages in the area for tolls.

"They [Ibrahim's men] unlock the garages only if the owners pay at least Tk 70,000. Sometimes, their demands go up to Tk 2 lakh."

The leader also said that Ibrahim's men collected tolls from building owners in Bhashantek, and recently extorted Tk 2 lakh to Tk 3 lakh each from landlords by threatening to set fire to or vandalise buildings if they were not paid the money

Shah Md Foysal Ahmed, OC of Bhashantek Police Station, said they were yet to receive any specific complaints regarding Ibrahim's criminal activities. "We will definitely take action once we receive specific information."

Enquired about the bail of notorious criminals, a top police official said that they had been busy with addressing the force's internal issues and maintaining law and order after August 5 and that they were waiting for the interim government's decision in this regard.

He said many top criminals and militants have been freed recently as their jail terms ended.

'The interim government also recently directed the police to adopt a zero-tolerance policy against top criminals and militants. We have stepped up our vigilance across the country and action will be taken against anyone carrying out criminal activities . no criminal will be spared," the official told this newspaper.

On September 10, Inspector General of Police Mainul Islam instructed all police units to adopt a "zero tolerance" policy against militancy and criminal activities.

Amit Shah on Friday said at a rally in Jharkhand that if the ruling Bharatiya Janata Party returns to power in the state, it will chase Rohingya and Bangladeshi infiltrators out of Jharkhand.

Attorney General Md Asaduzzaman said the interests of the accused persons have also been protected in the proposed amendments to the law.

He also suggested a provision allowing the victim families to engage their lawyer in the trial proceedings.

ICT's Chief Prosecutor Md Tajul Islam said, "The ICT Act will be amended in such a manner so that both the prosecution and defence can be satisfied knowing that justice has been ensured."

Welcoming the initiative to amend the ICT Act, Sara Hossain said a provision should be made to involve an international judge in the tribunal to ensure the trial proceedings are of international standard.

Badiul Alam Majumder, chief of the Election Commission Reforms Commission, said, "Those who have undermined democracy and the electoral system, committed financial crimes, including money laundering, and are responsible for the killing of more than 1,000 people in July this year must be brought to justice."

A total of 32 cases have been filed with the investigation agency of the ICT against Awami League President and former prime minister Sheikh Hasina.

(BGMEA). A total of 233 BGMEA member factories were open in the Ashulia area yesterday.

Worker leaders, factory owners and government officials sat for a tripartite meeting at the Ministry of Labour and Employment in Dhaka vesterday as the unrest intensified again after a relative calm last week.

They agreed to issue a joint statement on the unrest today.

Labour and Employment Secretary AHM Shafiquzzaman, who chaired the meeting, suggested that the BGMEA leaders inform the ministry about the workers' demands before issuing the joint statement.

The worker leaders raised 20 demands, including a review of the wage, full implementation of the latest wage structure by all the factories, an amendment to the labour law, and an increase in annual increment and attendance and tiffin allowances.

The draft amendment also proposed section 20(A) which deals with the prohibition of political organisations engaged in international crimes and "Notwithstanding anything states, contained in any other law for the time being in force, if any political organisation is found to have committed, aided, abetted, or facilitated the commission of any of the crimes under section 3 of this act, such organisation shall be subject to a ban for a period not exceeding 10 years."

It also says the ban imposed under this section shall include all activities of the organisation, including but not limited to: (a) participation in elections; (b) organising meetings, rallies, or any form of public gathering; (c) use of media and digital platforms for propaganda or communication; and (d) collection of funds and conducting any financial transactions.

Any person acting in contravention of the ban imposed under this section shall be liable to penalties as determined by the Tribunal, the section states.

The Tribunal, however, may, at its discretion, reduce the period of the ban upon an application filed by the organisation concerned, provided that it can demonstrate substantial reforms and compliance with the principles of international humanitarian law and human rights, it added.

by Treasury Department's Assistant Secretary Brent Nieman, visited Dhaka in mid-September, the first foreign delegation's tour after the interim government was formed.

The delegation said Washington would be happy to support Prof Yunus' reform agenda and expressed eagerness to offer technical and financial assistance for reforms.

According to foreign policy Bangladesh's main analysts, challenge is now the economy, and the reforms agenda being taken up will be successful if the economic challenge can be addressed. Things may be different otherwise.

political With better understanding, Bangladesh may secure greater economic benefits and have access to new avenues for muchneeded external funds, at favourable conditions, said Mohammad Sufiur Rahman, a senior research fellow at the South Asian Institute of Policy and Governance at North South University.

Even with about 18 percent duty, Bangladesh's export to the US is close to \$8 billion and it can be easily increased by a few billion if there is a duty-free quota-free facility, and non-tariff barriers are addressed.

The US administration may, if felt imperative to do so, consider flexible ways and special vehicles to offer GSP facility to Bangladesh in the changed circumstances," he told The Daily Star yesterday.

With Washington's support, the International Monetary Fund, the World Bank, and the Asian Development Bank may favour allocating funds for Bangladesh. Such support will have positive impacts on the overall economy because the funding will lead to economic stabilisation, employment generation, and increased wages, he said.

These in turn can embolden the interim government's resolve and capacity to secure improved governance, higher labour standards, and better human rights. Such a positive spiral can also encourage greater economic interaction and investments from other quality Western countries.

"If Bangladesh improves in human rights, labour rights, and governance sectors, and eventually the sanction against Rab is withdrawn, this have positive impacts on will Bangladesh's export to the Western countries," Obaidul added.

Analysts said Prof Yunus, who has earned US trust, is expected to discuss these aspects and take forward the US-Bangladesh relations to a new level.

Dhaka needs to ensure that it maintains a balanced foreign policy, they added.

Shafiquzzaman said the BGMEA leaders will inform the ministry about the decision on wage review, 10 percent increment and a few other demands before issuing the joint statement. The BGMEA called a meeting of their general members in the evening to discuss the issues.

Nazma Akter, president of the Sammilito Garment Sramik Federation. at the meeting urged the government to take a decision that will help both the owners and workers survive.

Babul Akhtar, general secretary of the Bangladesh Garments and Industrial Workers Federation, said

they also want safety to be restored in the sector.

Chowdhury, managing Tapan director of Square Pharmaceuticals, said the unrest began in the pharmaceuticals industry, which he said is "the most organised sector" with most factories giving five bonuses and sharing profits, apart from other benefits.

AK Azad, chairman and managing director of Ha-Meem Group, said many small and medium enterprises are in "big trouble" because of the unrest, and many factories would not be able to pay salaries timely as they could not continue production.

BGMEÂ President Khandoker Rafiqul Islam said 260 factories were closed as they could not implement the new wage structure that came into effect in December last year. He also said the unrest has been continuing even after meeting the workers' demands.

Country needs inclusive reforms

Speakers tell dialogue on ending discrimination

Women from all backgrounds, regardless of caste, creed, or religion, should be included in decision making for national progress and to end discrimination, said speakers at a dialogue in the capital yesterday

Titled "All are Equal", the session was organised by ActionAid Bangladesh and brought together over 20 participants, including activists and representatives from indigenous communities, people with disabilities, sex workers, and women's rights advocates.

The discussion focused on the need for state reforms and inclusive development in the wake of recent student protests.

Nishitha Zaman Niha, coordinator of Boishommo Birodhi Chhatro Andolon, stressed the importance of addressing rural women's rights to bridge societal divides.

"We need a Bangladesh free from discrimination and state oppression," she said

Begum, Anowara representing women farmers, highlighted wage

discrimination and limited access to markets. "Women farmers lack land rights and face inadequate sanitation facilities. We need a discrimination-free society and a 'farmer's card' to access services and benefits."

Khilon Robidas of the Bangladesh Robidas Forum in Gaibandha raised concerns over the discrimination faced by Dalit communities, especially women and children.

"People mock them due to their distinct dress, marking them as members of the community," he said.

Nilofa, secretary of the sex workers network, called for justice and protection for sex workers, citing ongoing physical and mental violence.

Puchainu Marma from the SUSHIL project in Bandarban highlighted the struggles of indigenous communities in the hill tracts, calling for land rights and security under the new government.

Farah Kabir, country director of ActionAid Bangladesh, urged for the issues of discrimination to be addressed during ongoing reforms. SEE PAGE 4 COL 6



Dhaka air worst in the world Says AQI index

UNB, Dhaka

Dhaka has topped the list of cities worldwide with the worst air quality, with an AQI score of 227 at 9:00am yesterday. Today's air was classified as "very unhealthy".

When the AQI value for particle pollution is between 50 and 100, air quality is considered "moderate", usually sensitive individuals should consider limiting prolonged outdoor exertion, between 101 and 150, air quality is considered "unhealthy for sensitive groups", between 150 and 200 is "unhealthy", between 201 and 300 is said to be "very unhealthy", while a reading of 301+ is considered "hazardous", posing serious health risks to residents.







The project's revised cost is Tk 33,472

The physical work on MRT Line-1 and Line-5 (northern route) started in March and July last year, respectively, more than three years after the projects were approved in October 2019.

According to the planning ministry official, Japan is financing the two projects, which will continue.

The official however added that should the interim government make any different decisions, the planning ministry will act in accordance.

The project authority of MRT Line-1, the country's first underground metro rail line, has so far been able to hire contractors for only one out of 12 packages. The project deadline is set for December 2026.

Under the Tk 52,561 crore project, the authority will build a 19.87km underground line from Dhaka airport to Kamalapur and an 11.37km elevated line from Dhaka's Natunbazar to Narayanganj's Pitalganj.

Similarly, the project authority of MRT Line-5 (northern route) has so far hired contractors for only one out of 10 packages.

The 20km line stretching from Hemayetpur to Bhatara will have underground and elevated sections. The deadline for the Tk 41,239 crore project is December 2028.

The proposed MRT Line-2 will be 36km long from Gabtoli to Narayanganj via Mohammadpur, Nilkhet, Azimpur, Central Shaheed Minar, Gulistan, Sadarghat, Mugda, Demra, and Chattogram Road.

The cost of the project will be around Tk 61,000 crore.

The DMTCL in September 2022 sent a preliminary development project proposal (PDPP) to the planning commission for the project's feasibility study. The commission in August last year approved the PDPP in principle and sent it to the Economic Relations Division to look for a financier, according a project document.

Shibir now out into the open at DU

He also said the full committee of the university unit will be unveiled soon.

After the fall of Ershad in 1990, Paribesh Parishad, a platform comprised of the DU authorities and student representations, slapped a ban on the activities of Shibir, the student wing of Jamaat-e-Islami, a party that actively opposed Bangladesh's independence struggle and sided with the Pakistan army during the Liberation War.

Members of Shibir's predecessor -- Islami Chattra Shangha -- formed Al-Badr and were involved in the 1971 killings of Bangalee intellectuals towards the end of the war. Some members of Al-Badr had been convicted and executed by the International Crimes Tribunal during the first and second terms of the Awami League-led government.

Over the last two days, following the revelation of Shadik and Farhad's identities, different student bodies came up with mixed reactions.

Talking to The Daily Star, Maeen Ahmed, general secretary of DU Chhatra Union, said, "Paribesh Parishad is a social or political pact, in which the university administration and student organisations have a stake. I think that honouring the pact, the previous decision regarding Shibir should have been reviewed or reformed. The university administration should have tried to learn Shibir's current stance on the grounds on which it was banned."

At Saturday's meeting, which was attended by the two Shibir leaders, some left-leaning student organisations raised questions before the vice-chancellor.

DUChhatra Union General Secretary Maeen said, "I asked the VC, 'How did you find him [DU unit president of Chhatra Shibir]?' 'Shouldn't you have taken the opinions of other student organisations?' But the administration has acted irresponsibly."

He, however, said he appreciates that an organisation has chosen to come out into the open instead of keeping itself under wraps.

"Because the good and bad deeds

of covert politics cannot be assessed and those behind them cannot be held accountable," added Maeen.

Nahiduzzaman Shipon, general secretary of DU unit Jatiyatabadi Chhatra Dal, said it should be a collective decision of all organisations whether Shibir can be allowed on campus or not. "All stakeholders including social, political and cultural organisations, should be involved in taking decisions in this regard," Shipon told The Daily Star.

Asked,SarjisAlam,akeycoordinator of the Anti-Discrimination Student Movement, said they would hold a discussion yesterday before making comments.

Meanwhile, in a press statement yesterday, Farhad denied any involvement with BCL.

"I have not been involved with any activities of the Social Welfare and Research Institute unit of Chhatra League. I have never submitted any résumé to anyone for any position in BCL," he said.

Farhad said they consider the controversy over his alleged involvement with BCL a "conspiracy to destroy the spirit of the anti-fascist movement".

He said he was the president of Kabi Jasimuddin Hall debating club and the general secretary of Social Welfare and Research Institute debating club.

Meanwhile, a photo of Tanbir Hasan Saikat, general secretary of BCL DU unit, exchanging floral greetings with him went viral on Facebook on Sunday night.

In another picture, Farhad was seen sitting next to Tanbir and BCL central unit's technical education affairs secretary Rakib Sirazy at an iftar mahfil of the debating club.

Regarding the photos, Farhad said, "When I was the president of hall debating club and general secretary of Social Welfare and Research Institute debating club, my photos with political persons attending various debate events were posted on social media ... all of those were debating club-related events, not political events."

According to the case statement, Shahadat had left home around 2:00pm on August 13, telling his wife that he would return by 7:00pm.

When he did not come home and his phone was switched off, his wife Sharmin began looking for him. It was not until the next evening that Harun saw a post on Facebook showing Shahadat's body lying near the Badna Shah Mia shrine in the city's Probortak intersection.

More than a month later, when the video went viral, Shahadat's family identified him and found out how he was killed.

"Now we can say he was brutally tortured to death in a planned manner -- he was called over the phone before the incident," said Shahadat's uncle Harun.

Shahadat's phone has been missing since the murder, said his wife Sharmin. "We want justice. How can anyone who is mentally sound torture someone to death while singing?"

Mohammad Solaiman, the officerin-charge of Panchlaish police station, said CCTV footage from the area.

The investigation is ongoing, the OC said, adding that police are trying to determine the motive behind the murder and identify those responsible.

name in the title of the report is wrong and misleading.

The report also mentioned that his wife is involved with the RACE business even though she holds no shares in the company. This indicates that the report was made to damage his and his family's dignity and reputation, reads the rejoinder.

It is also not clear why The Daily Star portrayed a picture of Sarafat and titled the news defaming him personally whereas Imam, the person who is being investigated by CID and BSEC for the stock manipulation, has not been portrayed or highlighted in the said article.

Moreover, the Canadian University of Bangladesh (CUB) is a not-forprofit trust.

The CUB, like all other private universities, participated in RAJUK's lottery system and was allotted the plot for establishing the university's permanent campus following the established legal procedures.

The other applicants' private universities were also allotted similar plots during the process. The land is the sole property of the CUB. The plot allotment price was declared by the government and like other private universities, the CUB paid for the land in full.

Sarafat resigned from his position as chairman of Padma Bank in January 2024 due to physical illness. His name has been linked to the allegations in the news report without fully understanding the facts and circumstances. The allegations are a result of journalism lacking proper investigation.

More importantly, the report cited ongoing investigations that are not part of the public record and should remain confidential to avoid bias and ensure a fair judicial process.

The rejoinder called for publishing the correct news incorporating the information provided with the same importance to ensure the correct information.

investigation report and we did not mention any information or comments beyond the findings.

The investigation found that Sarafat, the chairman of RACE Asset Management, has manipulated the stock prices of many companies for financial gain and caused losses of crores of taka to general shareholders.

Sarafat did not refute RACE's involvement in the irregularities.

In the rejoinder, Sarafat says that he resigned from the position as chairman of Padma Bank. The report also mentioned him as the former chairman of the bank.

According to CID findings, Sarafat, his wife Anjuman Ara Shahid and Imam invested the money from the 10 mutual funds of RACE and bought shares of the then Farmer's Bank (now Padma Bank) and became directors of the bank's board.

Sarafat, however, did not dispute this fact in the rejoinder.

He did not give any response in the rejoinder regarding the extension of the tenure of the mutual fund by 10 years in collusion with the Bangladesh Securities and Exchange Commission and Investment Corporation of Bangladesh without returning the entire money to the investors in the fund, which CID mentioned in the report.

As such, we stand by our report.

No magic solution to economic crisis

Says Sri Lanka's new president, vows to restore public faith in politics

AFP, Colombo

Sri Lanka's first leftist president was sworn in to office yesterday and vowed to restore public faith in politics, but said he had no magic solution to the hardships suffered following an unprecedented economic crisis.

Self-avowed Marxist Anura Kumara Dissanayaka of the People's Liberation Front (JVP) took his oath at the colonial-era Presidential Secretariat in Colombo after trouncing his nearest rivals in Saturday's vote.

The previously fringe politician, whose party led two failed uprisings that left tens of thousands dead, saw a surge of support after the 2022 economic meltdown immiserated millions of ordinary Sri Lankans.

Dissanayaka, the bearded 55-year-old son of a labourer, was sworn in by chief justice Jayantha Jayasuriya in a televised ceremony attended by diplomats, lawmakers, Buddhist and other clergy and the military.

"I am not a conjuror, I am not a magician, I am a common citizen," he said after taking his oath. "I have strengths and limitations, things I know and things I don't... my responsibility is to be part of a collective effort to end this crisis."

China wants to deepen BRI cooperation with Sri Lanka under new leader: **Xi Jinping**



Chinese President Xi Jinping yesterday said he hoped to broaden cooperation with Sri Lanka under his Belt and Road infrastructure initiative (BRI) as he congratulated the island nation's new leader Dissanayaka.

'We hope something good will happen," construction worker Thilina Hansaka told AFP. "I don't think much of anything can be done overnight, or even in five years. Let's give him a chance and see what he is capable of doing."

Dissanayaka succeeds Ranil Wickremesinghe, who took office at the peak of the financial crisis following the government's first foreign debt default and months of punishing food, fuel and medicine shortages

Wickremesinghe, 75, imposed steep tax hikes and other austerity measures under the terms of an International Monetary Fund (IMF) bailout. His policies ended the shortages and returned the economy to growth but left millions struggling to make ends meet.

CLIMATE MEETINGS IN NEW YORK Leaders warn of growing mistrust between nations

UN Secretary General António Guterres launched a two-day, climatethemed "Summit for the Future" on Sunday evening as part of the UN General Assembly, where some leaders warned of growing mistrust between nations as climate-fueled disasters mount.

National leaders addressed the group after adopting a "Pact for the Future" aimed at ensuring and increasing cooperation between nations, with many calling for urgent access to more climate finance.

"International challenges are moving faster than our ability to solve them," Guterres told leaders at the summit. "Crises are interacting and feeding off each other - for example, as digital technologies spread climate disinformation, that deepens distrust

and fuels polarization."

Prime Minister Mia Mottley of Barbados echoed Guterres' warning and urged a "reset" in how global institutions are governed so they can better respond to crises and serve those most in need. The UN climate summit continued yesterday with speeches from China, India, and the

Elsewhere during the week, US President Joe Biden is expected to deliver a speech at an event also attended by actress and climate activist Jane Fonda and World Bank President Ajay Banga, among others.

Another event hosted by the Clinton Foundation features speeches by Prince Harry and actor and water activist Matt Damon.

The Climate Group counted some 900 climate-related events planned across the city this week.

Pakistan picks new chief of spy agency ISI **REUTERS**, Islamabad

picked Pakistan has Lieutenant-General Muhammad Asim Malik as the new director general of the Inter-Services Intelligence (ISI), its top spy agency, according to a security source and a local TV channel, the first change in the key post since 2021.

The Pakistani military's public relations department not immediately did respond to a request for comment.

The reported move comes as the political role of the agency faces intense scrutiny. One former ISI chief has been arrested for supporting the political cause of jailed former prime minister Imran Khan

Refusing to sit on the chair used by her predecessor Arvind Kejriwal, Atishi chose to sit on a different chair. "This is Delhi's Chief Minister's chair, this chair, is Arvind Kejriwal ji's," she said after taking charge at the Delhi Secretariat.

The third and the youngest woman Chief Minister of Delhi, Atishi has retained the 13 portfolios she held in the Kejriwal government, including those of education, revenue, finance, power and PWD.

"I have full faith that in the election which is due in February, the people of Delhi will elect Arvind Kejriwal ji as Chief Minister again. Till then this chair will be in this room, in expectation of Arvind Keiriwal ii." she said.




30 bodies found in boat adrift off Senegal coast

Senegal's navy has recovered at least 30 bodies from a boat discovered adrift around 70 kilometres off the coast of the capital Dakar, the army said vesterday

Investigations are under way to establish where the vessel came from and to confirm the death toll, the army said in a statement. Senegal's coastline sees frequent tragedies involving attempts to reach Europe by boat.

After being alerted to the incident late Sunday, a navy patrol towed the adrift, long, wooden fishing boat known as a pirogue to the port of Dakar where it arrived around 06:00 am (GMT) yesterday, the statement said.

High expectations from CA's UNGA trip Scope for improved relations and

collaborations

For Bangladesh, the 79th session of the United Nations General Assembly (UNGA) holds more significance than usual as this is the first major global summit the country is taking part in following the fall of the Sheikh Hasina regime. Chief Adviser Prof Muhammad Yunus flew out of the capital at around 5:10am on September 23 to attend the UNGA, as well as a number of meetings. Given his international stature, we expect to see opportunities open up for Bangladesh to build meaningful, strategic collaborations that will help with its reform agenda in the short term, and with trade, economic growth and development in the long term.

The chief adviser is scheduled to address the UNGA on September 27, where he will present the context of the antidiscrimination student movement that evolved into a mass uprising in the face of state-sponsored violence, ultimately ending the 15-plus years of Sheikh Hasina's authoritarian rule. He is also set to highlight the reform initiatives that his government has undertaken, which we believe is a crucial part of his UNGA agenda. Presenting before the world our people's aspirations for a strong, fair and equitable justice system, impartial state machinery that serves only the people, and a democratic system where no one's voice is suppressed is key to gaining acceptance and cooperation from the international community-both at the government-to-government and people-to-people levels.

On the sidelines of the UNGA, the chief adviser is scheduled to meet US President Joe Biden on September 24. This meeting is considered significant as it's the reflection of US support for the interim administration in Bangladesh, according to diplomatic sources in New York. Plus, it's not usual for a US president to hold bilateral meetings during the UNGA. So, we hope to see a new strategic partnership emerge out of this meeting that will strengthen our ties with the US and protect our interests at the same time. Another high-level meeting is set to take place between Bangladesh Foreign Affairs Adviser Md Touhid Hossain and Indian External Affairs Minister S Jaishankar, which we expect to kick-start the process to normalise relations between the neighbouring countries after weeks of tension surrounding Hasina's fall and her being sheltered in India.

The chief adviser is also set to hold bilateral meetings with several heads of governments, and some of our strategic and development partners, including the EU. Bangladesh will also host a high-level reception on September 24, marking the 50th anniversary of its UN membership, and will attend a high-level side event on the Rohingya crisis.

As it goes through a massive transformation following the events of August 5, Bangladesh has yet to find an even footing. Our economy continues to struggle, our foreign exchange reserve crisis is still concerning, and our export earnings are still not up to the mark. Years of corruption and irregularities have left some lasting wounds, and to heal them, we need help from our partners. We hope the interim government will be able to garner the support needed to smoothen Bangladesh's reforms and aid in its interests moving forward.

Why has the government's flood response been so slow?



65-year-old Kabir Ahmed. a sharecropper from Jagatpur village in Feni's Fulgazi upazila, lost his two tinshed houses when the embankment of the Muhuri River breached on August 22. Floodwaters destroyed Kabir's home, forcing him to seek shelter at a neighbour's house with his seven family members and his cattle.

On September 15, The Daily Star published a story about Kabir online. After that, an NGO visited him, offering to build him and his family a new house. Kabir refused the offer, his reason being that without repairing the embankment, any new house would be washed away by the next flood. As a result, the NGO left without providing assistance.

On September 14, we met another farmer, Md Alam, from the same village. One of his five cows died in the August flood. He is now in great distress, feeding banana plants to the remaining four cows as the flood washed away all his hay and there is no grass left on the croplands. The district livestock officer (DLO) mentioned they received only Tk 5 lakh to distribute to the flood-affected farmers for fodder.

According to an official from Bangladesh Water Development Board's (BWDB) Feni office, around three kilometres of the 122-kilometre embankment along the Muhuri, Kahua, and Cilonia rivers in Parshuram and Fulgazi upazilas were damaged. Due to a lack of fund allocations, the local water development office could not begin repair work until September 22. Meanwhile, 200 hectares of Aman paddy fields have been buried under one to five feet of sand, which were carried by floodwaters from upstream India.

Officials from the Parshuram upazila agricultural extension advised farmers to switch to cultivating alternative crops, as paddy cultivation would not be feasible for the next three to four years due to the sand deposits. shelter elsewhere during the flood.

I am familiar with the floods that occur every year in the northern parts of the country, where the Teesta, Brahmaputra and Jamuna river basins overflow due to upstream flow. Flooding in this region mainly occurs in the char areas, and people there have learnt to cope with it since childhood. Normally, if the embankment holds, there is no flooding in the mainland. But this time, the eastern mainland

This raises several questions, was hit leaving many people who don't have experience of big floods to face the worst flood in their lives. The government should have acted swiftly to help them return to normal life. Instead, it remains bogged down in bureaucratic delays. Rehabilitation can only begin once bureaucrats finalise their victim lists, a process that is taking far too long. There needs to be a rapid assessment team during floods and another one to mobilise quick responses.

There are many examples where we witnessed local administrations and ruling party members distributing blankets after winter was gone and the temperature started to rise. These instances were not just laughablethey were tragic.

According to the US Department of Agriculture (USDA), the recent floods damaged 200,000 hectares of crops, including paddy seedlings. The agency has predicted that Bangladesh will have a shortage of rice compared to its target this year. Had the government taken quick actions, farmers could have replanted Aman within the necessary time frame.

The flood-affected farmers were unable to arrange seeds, fertilisers and other means of production post-flood. As a result, thousands of hectares of Aman paddy land remain uncultivated across the 11 flood-affected districts. If the government had provided cash incentives, fertiliser and seeds immediately after the water receded, these lands might not have remained fallow.

After independence, this is the first time that people from all walks of life have extended such massive help to flood-affected people, which is truly wonderful. At Dhaka University's TSC, many children even came out with their parents to donate the savings they had collected for years. For the older generation, this was a remarkable and heartwarming sight.

Following the mass uprising and this public mobilisation, the government should consider reforming the outdated bureaucratic system. People are ready for change, and the government should follow suit. Ultimately, to bring about any meaningful reform, the government must prioritise saving farmers from natural disasters to ensure increased agricultural production.

EDITORIAL

It is quite alarming to know the level of corruption that engulfed Shilpakala Academy over the last 15 years or so. According to a report by Prothom Alo, financial irregularities, nepotism in recruitment and promotion, and various other forms of corruption almost crippled this once guiding light of our cultural landscape. The report focuses particularly on the extended tenure of its seven-time director general, Liaquat Ali Lucky, who, since being appointed in 2011, presided over a particularly corrupt and dysfunctional period. He made arbitrary decisions and even misused funds allocated to the academy for personal gain. Despite protests from theatre activists, he was reappointed repeatedly, with the last instance being on March 29, 2023. This speaks volumes about the mismanagement that plagued the institution.

Reportedly, while the annual budgetary allocation for Shilpakala increased tenfold over the last 15 years-its current budget exceeding Tk 100 crore-financial corruption within the institution has risen in parallel. There is an allegation of over Tk 200 crore being misappropriated, which is yet to be investigated properly. Other irregularities include inflating the cost of the same costume five times, withdrawing excess funds for nationwide events, submitting fake vouchers for foreign trips, and providing fraudulent receipts for crores of taka in the name of purchasing artworks. These just sum up the financial misconduct committed during Lucky's tenure.

In addition, while a number of officials close to the former DG received preferential treatment–promotions and postings in Dhaka-in violation of the rules, many others were unjustly denied promotions or even salary increases. Moreover, during this period, district-level cultural activities were reportedly neglected to a considerable extent, with some districts still lacking cultural officers.

The question is, how can the Shilpakala Academy be freed from such practices and restored to its former glory? To achieve this, thorough and fair investigations must be conducted into all the allegations and all those involved in corruption must be held accountable. With Syed Jamil Ahmed, a visionary theatre director, now at the helm, there is hope for a new direction. It is expected that under his leadership, the academy will be run better and become more inclusive and diverse, offering people across the country a space to enjoy or express themselves through arts. This transformation is needed for the academy to reclaim its role as a leading cultural institution.

For over 15 years, under Sheikh Hasina's authoritarian regime, the people of Bangladesh endured rampant oppression and untold cruelty. The regime was characterised by state-sponsored torture, enforced disappearances, maiming, and pervasive human rights abuses. Cruelty was employed as a deliberate tactic to suppress dissent and erode people's democratic aspirations. The oppressive system was maintained with impunity by the state machinery and bureaucracy. As a result, the state is widely mistrusted and seen by Bangladeshis as anti-people.

Given the scale of corruption and brutality orchestrated by the regime, the judicial system alone cannot swiftly or adequately deliver justice. The institutional nature of the crimes and urgent demand for accountability call for a truth and reconciliation process (TRP), similar to the one guided by South Africa's postapartheid Truth and Reconciliation Commission (TRC).

A TRP, led by a commission or council-type body, would expose the human rights violations without relying on retribution. It would provide a platform for victims and witnesses to share their stories and give perpetrators the chance to confess their crimes, bringing the atrocities to the fore. This process would help Bangladesh (re)build a just and accountable society, by creating a culture that listens to victims and addresses past atrocities transparently.

By focusing on restorative justice, the TRP could help break the cycle of vengeance and promote a peaceful transition to democracy. This approach is essential for rebuilding a society after prolonged injustice, as it establishes a foundation for accountability, reduces impunity, and restores public trust in institutions. Additionally, by demonstrating that truth-telling and reconciliation can be powerful tools for healing divided societies, the TRP could help form a moral centre for the country, establishing new norms and institutional safeguards to prevent future abuses.

The TRP should be tailored to Bangladesh's unique situation with a focus on: i) investigating human rights violations like killings, torture, and abductions between 2009 and 2024. The TRP would present its findings on the extent of state-sponsored violence to the public; ii) offering victims a space to tell their stories and recommending reparations and rehabilitation to address national trauma and promote healing; and iii) considering amnesty for those who fully disclose their actions based on set criteria, which may be limited to lower-level perpetrators who followed orders or helped cover up abuses.

The concept of addressing state violence and delivering accountability through the process of victim testimony and perpetrator confessions emerged in post-apartheid South Africa. Following the end of apartheid, a brutal system of racial oppression

Tamina Chowdhury the newly elected government of Nelson Mandela sought to confront past injustices without resorting to retribution or further violence.

The TRC was created in 1995 through the Promotion of National Unity and Reconciliation Act, to uncover the truth about the atrocities committed during apartheid.

Some believed that amnesty allowed perpetrators to escape justice, and others argued that it did not address systemic injustices or offer sufficient reparations to victims. Moreover, the government did not fully implement the TRC's recommendations for reparations.

The commission was chaired by Archbishop Desmond Tutu, respected anti-apartheid activist and Nobel Peace Prize laureate. His leadership was crucial in guiding the commission's work with a moral and ethical focus on reconciliation.

The TRC had three main committees: i) Human Rights Violations Committee: investigated human rights abuses like killings, torture, and abductions committed between 1960 and 1994; ii) Reparation Rehabilitation Committee: and focused on restoring the dignity of victims by recommending reparations and rehabilitation; and iii) Amnesty Committee: assessed and granted amnesty to perpetrators who came past. forward and fully disclosed their actions.

that spanned from 1948 to 1994, hearings were often emotional and widely covered in the media, exposing apartheid's horrors to the nation.

A well-designed TRP can offer a path to healing. By uncovering the truth, giving victims a voice, and fostering reconciliation, it can help break the cycle of violence and write a new chapter in Bangladesh's storyone that must be different from its

Who is 'Indigenous?'

the context of Bangladesh has thrown up many questions on the appropriateness of the "Indigenous" identity of the peoples of Bangladesh, particularly the Pahari (hill) peoples of the Chittagong Hill Tracts (CHT). The government line is that the Paharis are not indigenous to Bangladesh, while Bangalees are. On the other hand, the Jumma peoples and the Plains Adibashis insist that they are indigenous peoples.

Who is right? Who are the Indigenous-the Adibashis or the Bangalees? Or are they both indigenous?

An informed discussion on the subject will not be possible unless we clarify the context. The relevant context here is human rights and the framework necessarily has to be the one ascribed by that premier club of the world's sovereign states: the United Nations. Although our former foreign minister is known to have cited dictionary meaning(s) of the term, "Indigenous," quoting them to be those who "belong to a particular place rather than coming to it from somewhere else," the debate cannot be settled by referring to dictionaries, but by looking at the term's meaning as understood in the relevant UN instruments, processes, and other international human-rights mechanisms, while paying appropriate attention to the political and legal contexts of Bangladesh.

And, of course, we must not ignore history. Let us therefore explore the history of settlements in Bangladesh, and the implications of the recent amendments of the constitution.

Ancestral backgrounds of the Adibashis

The most pertinent question in this respect is, were there peoples living in different parts of Bangladesh-and not necessarily spread over all parts of Bangladesh-before the arrival of the currently dominant groups (the Bangalees) in those parts of the country?

Citing the government of Bangladesh's communication to him, the UN Special Rapporteur Martinez Cobo wrote that the government regarded members of tribal and semi-tribal populations as Indigenous on account of their descent from populations which are settled in specified geographical areas of the country.

Thus, the question is, were the different Adibashi peoples settled in the different parts of the country such as the CHT (e.g., Chakma, Marma, Tripura), the Barind tract (e.g., Santal, Munda, Oroan), the Madhupur tract (Garo, Hajong) and so forth, before the Bangalees settled there?

Indigenousness of the CHT Adibashis (Jummas)

The recent debate on "Indigenousness" in of the Jummas themselves clearly attest to the fact that all the 11 Jumma peoples were in existence in the CHT-Chittagong-Feni-Noakhali-Comilla region, not just in the hills but also in the plainlands, prior to conquest (in 1666, by the Mughals of a part of Chittagong, Feni-Noakhali, Comilla, etc., but excluding the present-day CHT).

Suniti Bhushan Qanungo writes: "In prehistoric times Chittagong was inhabited successively by the Austro-Asiatic and the Mongoloid groups of peoples." He adds, "The Mughal conquest of Chittagong drove the Arakanese beyond the hill ranges, and vacated places were occupied by new settlers from Arakan Hill Tracts, or the State of Tripura". In contrast, Bangalees were the last to settle in the CHT.

Most importantly, the CHT was not part of Bengal until after British advent. Eminent historians and sociologists therefore have noted, "In 1860, the British occupied the hills to the east of Chittagong and annexed them to their colonial empire. For the first time in their history, the Chittagong hills were administered from Bengal. Before that time, political power in the hills had been dispersed among many chiefs."

Indigenousness of the Plains Adibashis

As in the case of the CHT, in the plains region as well, there is no record of Adibashis having displaced Bangalees and settled in their present locations. The Santal and Oraon made the Barind tract inhabitable and converted harsh terrain into paddy lands. Similar settlements were made by Rakhaing (Patuakhali-Barguna), Garo and Khasi (Mymensingh-Sylhet), but not by conquering and displacing Bangalees.

As in the case of the CHT, the plains Adibashis were also present in Bangladesh from before there were written histories,

of Bengal included several of the peoples who are claiming indigenous identity.

But the crucial point here is that by having assimilated into the dominant groups and adopting the dominant identity (regardless of the religious and nationalist aspects of that identity) Bangalees can no longer claim the Indigenous mantle as it is understood in the human rights context. The Indigenous concept only makes sense when the peoples are "nondominant" in statecraft and otherwise.

Contrary to the popular belief portrayed in the media, having an "Indigenous" status does not give anyone privileges of any sort over and above that of other citizens. Essentially, it means the recognition of their full participatory rights as citizens, keeping in mind the exclusion and discrimination historically meted out to them in the process of state-formation, nation building and development, which Bangalees have enjoyed from the formation of the state. It also means the creation of an enabling environment, in which they may preserve their distinctive cultural identities, which are threatened on account of their marginal situations from the beginning of state formation.

other sectors of the societies now prevailing on those territories, or parts of them. They form at present non-dominant sectors of society and are determined to preserve, develop and transmit to future generations their ancestral territories, and their ethnic identity, as the basis of their continued existence as peoples, in accordance with their own cultural patterns, social institutions and legal system."

First and foremost, we should be examining the concept in relation to the ILO Convention on Indigenous & Tribal Populations (Convention No. 107) of 1957, which Bangladesh ratified in June, 1972, under the leadership of Sheikh Mujibur Rahman, about six months before the Constitution of Bangladesh was adopted.

As a collective entity, Bangalees live less in conformity with the "social, economic and cultural institutions" of the time of their precolonisation or pre-conquest period ancestors, and more in conformity with "the institutions of the nation to which they belong", and hence they cannot be regarded as indigenous within the meaning of Convention 107.

In contrast, hill communities of the CHT, and Adibashi groups of the plains, "irrespective of their legal status" are quite the opposite. Traditional institutions in the CHT are formally recognised by law, and while those in the plains are not-still conform to their ancestral institutions' traditions, norms, and mores.

In the case of "economic institutions", Bangalees clearly do not retain very many practices of the pre-colonial or pre-conquest period, unlike Pahari groups, for example: collective forest management, subsistenceoriented jhum or "shifting" cultivation, etc.

It is clear from the wording of ILO Convention No. 107 that "indigenous" and "tribal" population groups are both referred to as "tribal or semi-tribal" populations. Therefore, Indigenous populations are those among the tribal and semi-tribal population groups who "[are descended] from the populations which inhabited the country. or a geographical region to which the country belongs, at the time of conquest or colonisation and which, irrespective of their legal status, live more in conformity with the social, economic and cultural institutions of that time than with the institutions of the nation to which they belong."

The concept of tribal and semi-tribal population groups has been related in this convention with "social and economic conditions [that] are at a less advanced [read disadvantaged] stage than the stage reached by the other sections of the national community,' and a "status [that] is regulated wholly or partially by their own customs or traditions or by special laws or regulations."

The concept of indigenous peoples is meaningless in the case of Bangalees from a human rights perspective because Bangalees are at the helm of state power, while the Adibashis were, and still are, substantively, the "excluded" citizens, marginalised and disadvantaged.

within or outside the district. The Mughal government encouraged the colonisation in northwestern Chittagong, which had been depopulated during the Arakanese regime. The new colonisers, mostly the inhabitants of Noakhali-Tripura-Comilla region were the latest settlers in the district."

Portuguese accounts refer to "Chacomas," separately from Bengal, Arakan and Tripura in the mid-16th century. Migration of Jummas to and from present-day Bangladesh, the Indian states of Tripura and Mizoram, and Myanmar happened for centuries. It was not a one-off event. Thus, it is understandable why the CHT Regulation of 1900 defined an Indigenous

imperial conquests, and colonisation.

Even today, despite the de-recognition, and subsequent non-recognition by the state, it is the traditional institutions that these peoples turn to for resolving their internal disputes and for carrying out other cultural activities (Manihi: Santall, Nokma: Garo, Myntri: Khasi). They do not turn to the mainstream statecentric institutions, unlike the Bangalee peoples.

Indigenousness of Bangalees

Of course, Bangalees have also lived in different parts of the plains and delta areas for centuries. However, they have not ventured into the

Indigenousness in UN instruments and practices

According to the UN, the most fruitful approach is to identify, rather than formally define indigenous peoples and hence there is no set definition of indigenous peoples in the UN Declaration on the Rights of Indigenous Peoples. However, international laws do not define minorities either. The "working definition" of Indigenous peoples by José R Martínez Cobo has attained the status of a near-formal definition in the context of UN and international human rights jurisprudence. Cobo writes, "Indigenous communities,

For a long time, I remained largely off to foreign shores by an autocratic detached from the events in Bangladesh as I was focused on my academic pursuits. I didn't worry much about the political fallout at the local and national level or what was happening in the streets or in the corridors of power. I was mainly a man of the classroom and maintained an apolitical stance in my academic work. I wrote and published works related to my research interests. I thought thenas I do now-that by producing academic work, I would hopefully make lasting contributions to my field of knowledge which would benefit generations of learners.

At one point, I received casual and seemingly innocuous comments from some of my friends and acquaintances. Referring to the situations in Bangladesh, they expressed doubts about the efficacy of producing scholarly work that does not give meaning, or is not sensitive, to la condition humaine. What they said amounts to this: long-term academic work may have its own value, but how can an academic remain indifferent to the pain of tens of millions of their compatriots under a brutal regime? Or, how could we not raise concerns when massive corruption plagued all state machineries? Or, how long could we remain silent when our country was being plundered and large sums of our money siphoned and a half years. Thanks to the

government and its cronies? For a while, I quietened such whisperings of conscience and continued focusing on my armchair intellectual work which was largely disconnected from the immediate here and now. But my subconscious mind continued speaking to me and

sending me messages. As I visited Bangladesh or spoke with the people of the country and its diasporas, it was obvious that something went terribly wrong in our motherland. People were in constant fear. Anyone could be apprehended by the security forces or forcefully disappeared from their homes or from the streets-during the day or in the middle of the night. Anyone could be fired from their job, their businesses could be ransacked, or their properties could be grabbed. Or, anyone could be harassed or beaten to death in the streets. One simple statement was enough for the security forces or for the ruling party ruffians to justify all such cases of human rights violations: the victim belonged to one of the opposition parties to whom the Hasina-led regime directed its ferocious fury and repressive measures.

We have some numbers or have heard stories about people who were killed or subjected to enforced disappearances during Hasina's autocracy, which lasted for fifteen

on those innumerable Bangladeshis who lived in fear or had a peripatetic life inside and outside the country, as they went into hiding to escape police arrest or torture by the thugs of the ruling party. It is hard to record how many expatriate Bangladeshis didn't visit their beloved birthplace, as they feared persecution. Their crime might have been some of their social media posts which could be interpreted as criticisms of the government. Many other expatriate Bangladeshis didn't visit their country simply because of a sense of insecurity that would grip them inside the country once they left the airport. All these kept disquieting me.

Then the "What can I do?" question also insurmountable. It was somewhat paralysed me and made me feel helpless. It was a real letdown

I found an answer in the end. Yes, I could write to protest against the evils of autocracy. However, it was going to be a challenging task for two main reasons. First, it would take away much of my research time. But I was confident that I would be able to address this through better time management.

The second issue was unpredictable, more serious and beyond my control-writing against the autocratic government would compromise my security. How would I avoid the wrath of a regime that was fundamentally unjust and used enforced disappearances as a tactic to silence dissent?

The government subjected the writer and artist Mushtaq Ahmed (1967–2021) to nine-month long slow

regime wanted to send a forewarning message to all other writers who might have contemplated exposing its human rights violations and financial corruptions.

Many capable intellectuals and opinion leaders heeded the message and remained silent. They prioritised their own safety and comfort over the independence of their mind and their sense of responsibility to the nation. Some of them continued writing but never touched on the wrongdoings of the government. They explored the aesthetics of flora and fauna or the serenity of lakes, and similar bland subjects. Others provided epistemic lacking strength of character, poetcover-ups to Hasina's autocracy by



Long story short, I got over material and psychological obstacles and began writing for Bangladeshi English dailies. By doing so, I was heeding the call of conscience. The alternative was not to write about the regime's corruptions and injustices on the people. Had I made that choice, the pangs of conscience would have outweighed the temptation to inhabit a comfort zone which is free from the pitfalls of the world that often beset the best among us.

Empowering self-sufficiency in Bangladesh:

Specialised ICT training for people with disabilities

The first month of the five-month training held at the CRP's Manikganj training centre focuses on **basic Microsoft** Office applications (Word, Excel, **PowerPoint**, and Access). As the students get acquainted with MS Office skills, they begin their training on a digital marketing course.

In Bangladesh, a staggering 2.8% of the population lives with at least one form of disability, according to the Bangladesh Bureau of Statistics (BBS). For people aged between 15 and 65 with disabilities, unemployment rates soar to approximately 72%, showcasing the stark gap in opportunities. Bangladesh's National Policy for the Disabled gives guidelines for prevention, identification, rehabilitation, education, research and accessibility, among other things, to those with disabilities. The Disability Welfare Act 2001 addresses, among others, the "protection of rights of people with disabilities, equal opportunities for participation in education, training, employment opportunities etc." There are also specific indications in the said Act to promote employment of the Persons with Disabilities (PwD) in government and other recruitment processes. The government has also reserved a quota in public service for PwD. However, despite all this, the representation of PwD in the workforce is quite insignificant.

Breaking barriers with digital skills

For youth with disabilities, employment barriers go beyond societal stigma or lack of education. The physical environment itselfsuch as poor transportation systems and inaccessible workplaces-restricts

their mobility and integration the workforce. Educational institutions, industries, factories, and formal workspaces, unequipped are train and to accommodate PwD. leaving further them marginalised. However, the growth of AI and digital skills Bangladesh in is creating new opportunities people with for disabilities, offering fresh hope for greater inclusion in the workforce.

One such initiative is currently being implemented by the Building Youth Employability Through Skills (BYETS) project of Swisscontact, in collaboration with the Centre for the Rehabilitation of the Paralysed (CRP). Together, they have launched a specialised five-month residential ICT training program aimed at equipping young PwD with in-demand digital skills. This program empowers them to compete in today's job market by providing the tools and knowledge needed to navigate the evolving digital landscape.

The first month of the five-month training



skills, they begin their training on a digital mobility challenges, they can now pursue marketing course. This training will allow the participants to pursue freelancing virtual office assistance." Palli further states opportunities, which is particularly useful for those whose physical mobility restricts them from traditional office jobs. After completing the training the trainees will be this training program, highlighting CRP's supported to become freelancers enabling them to work from home. In a country where most infrastructures are not equipped to accommodate wheelchair users or individuals with limited mobility, freelancing opens doors to financial independence that would otherwise remain closed.

A path to self-sufficiency

For many of these trainees, this ICT training is not just a course-it is a life-changing opportunity. Riduan Rahman, a 20-year-old participant who finished his HSC last year, reflects on the impact the training has had on him so far: "Before I joined this program, I didn't have any ideas about the things that I am being taught." According to Riduan, he is being taught basic yet important digital skills such as editing documents in Word, checking CVs, and doing calculations in Excel. The trainees have also just started their classes on digital marketing, where they are learning the basics of social media marketing, search engine optimisation, and other necessary tools.

Riduan suffered a spinal cord injury at age four and thus lacks strength in his body from the waist down. He recounts that despite his physical inabilities, he hasn't stopped pursuing his goals. Through the program, he is gaining the confidence to pursue freelancing and hopes to become self-reliant, funding his education without the need for further financial support.

Many others like Riduan are set to benefit from the program's efforts to empower financial independence, this initiative fosters them with the skills needed for freelancing an inclusive society, promoting equality and or remote jobs - as the program currently ensuring that no one is left behind in the hosts 10 individuals undergoing this inclusive workfo

a career in fields such as data entry and that special equipment such as wheelchairenabled computer assistance is provided to the PwD participants currently undergoing utmost care for its resident trainees.

A vision for a more inclusive Bangladesh

In Bangladesh, NGOs have often played a pivotal role in reaching populations deprived of their entitlements due to gaps in government services. Unfortunately, in the case of PwD, the initiatives by NGOs are scanty as well. NFOWD, the National Disability Think Tank, is the only registered network of its kind and is the apex body for NGOs focused on disability in the country. With 388 members, it represents the few NGOs, out of thousands in the country, dedicated to supporting PwD.

The Executive Director of CRP, Dr. Md. Sohrab Hossain, says, "CRP has partnered in this unique initiative because we believe that the program can make a meaningful impact in the lives of PwDs. This training not only creates confidence in the participating trainees but also creates a scope for having independence in their lives. Their success will create inspiration for PWDs, enabling them to make an inclusive society. This initiative strives to build a more inclusive, skilled workforce in Bangladesh, addressing the often-overlooked potential of PwD."

The initiative is not just about short-term employment; it seeks to create long-term success stories. The BYETS project hopes that, by investing in these young people and helping them navigate freelancing platforms, they will become entrepreneurs in their own right. By empowering PwD to achieve

Bangladeshi Stanford graduate's AI startup receives \$750K funding

Story Engine Inc., an AI startup co-founded by Bangladeshi Stanford graduate Sheikh Srijon, has received \$750,000 in preseed funding from the reputed venture capital firm Andreessen Horowitz (A16Z). The startup, founded by Sheikh Srijon, Zhizhuo Zhou, and Wanrong He, aims to revolutionise the realm of webtoon and anime creation through generative AI technology.

The Story Engine platform allows users to create consistent, controllable characters and visual stories across multiple panels, solving key challenges faced by existing AI tools like Midjourney, says Srijon. "While 53% of Gen Z in the US watch anime, only a fraction of them have the tools to create their own visual stories," he says, explaining that his startup aims to democratise the creation of webtoons and anime, much like YouTube did for video content.

According to Srijon, this funding will help the team scale their operational expenses while being able to train their AI models better. They also received Google Cloud credits worth \$500k, which Srijon says helps extend the lifeline of any young startup. 

Barca goalkeeper Ter Stegen to undergo knee surgery

Barcelona goalkeeper Marc-Andre ter Stegen will have surgery on a ruptured knee tendon, the Catalan club said Monday, with the club's captain potentially sidelined for the rest of the season.

The 32-year-old German international was stretchered off after falling awkwardly during his team's 5-1 victory over Villarreal on Sunday.

"(Ter Stegen) has a complete rupture in the patella tendon in his right knee," said Barcelona in a statement.

"On Monday afternoon he will undergo a surgical process and once complete a new update will be released."

Ter Stegen, who was criticised after making a mistake in Barcelona's 2-1 Champions League defeat at Monaco on Thursday, suffered the injury before half-time at Villarreal's Estadio de la

In a historic achievement, Indian women's team clinched gold for the first time at the Olympiad after narrowly missing out in 2022. They decisively defeated Azerbaijan 3.5-0.5, edging second-placed Kazakhstan by one point in the points table.

The double gold feat was termed as an "unbelievable" achievement by India's chess great Viswanathan Anand.

In contrast, Bangladesh's men's team finished 78th, and the women's team placed 81st in the tournament contested by a record number of 197 teams, representing 195 nations.

"If you look at the bowling and batting departments of the two sides, you will see that they [India] are some way ahead. We expected a tough time, and they [India] did provide that.

"It was a good sporting wicket in Chennai, especially in the first two days. If we consider the batting, we failed to live up to the challenge. There was some recovery in the second innings, and some batters regained some confidence," he said.

The biggest difference was felt in the batting units of the two teams. While India

had three centurions in two innings, only Najmul Hossain Shanto got close to three figures.

It was reported that a team meeting took place in the morning at the team hotel, with all players involved. Head coach Chandika Hathurusingha and the coaching staff spoke to the batters in particular about the mistakes made and analysed what went wrong.

Bangladesh may also need to consider combinations and changes in the playing eleven, with ace all-rounder Shakib Al Hasan under observation after suffering

to come, so combination changes will be considered, keeping Shakib's injury troubles in mind.

As majority of teams use seven batters and four specialists, with the all-rounder being part of the seven batters, Mehedi Hasan Miraz is the all-rounder who could step in and bat earlier in Shakib's absence. This would mean that the other left-arm spinner, Taijul Islam, waiting in the wings for a match, could come into the playing eleven, depending on the conditions.

The bigger headache, as could be inferred from the team meeting discussion, is that all Test teams depend on the top order for runs, and thus Bangladesh need more from the top six in the second and final Test.

"I think it will be a huge injury, when he lav down on the field ... you can see it directly," Barcelona coach Hansi Flick said after the game.

Inaki Pena replaced Ter Stegen and is set to fill in for the German, although Barcelona may look to sign a replacement.

Flick said it was too soon to comment on the issue.

"I don't know if I like this question directly after the match... I just want to see how Marc is, he's our captain and is a very important player for us," said Flick.

"Please understand that I don't want to talk about that."

Ter Stegen started two Nations League matches for Germany in September after Bayern Munich veteran Manuel Neuer's retirement from international duty in August.

Sri Lanka win Galle Test to make moves in WTC

Left-arm spinner Prabath Jayasuriya took two overs to polish off the New Zealand tail and complete a fivewicket haul as Sri Lanka sealed a 63-run victory in the opening Test at Galle International Stadium on Monday

Chasing 275 for victory, New Zealand were all out for 211 despite Rachin Ravindra's gallant 92, their batters unable to negotiate the sharp turn and low bounce at the venue.

Jayasuriya (5-68) claimed his eighth five-wicket haul, seven of them coming at his happy hunting ground in Galle alone.

With the win, Sri Lanka claimed important points to challenge teams at the top of the World Test Championship (WTC) table.

India have continued their strong run in the WTC 2025 cycle with a 280-run victory over Bangladesh, while Sri Lanka's win helped their move towards a potential spot in the competition final at Lord's next year.

The two results have led to shifts in the race for the two final spots, with India tightening their grip on top spot, and Sri Lanka leapfrogging their current opponents into third spot.



Calmly accounting for the Tigers in Chennai, India's win in Chennai and the 12 World Test Championship points reasserts their status at the top of the table, moving to a percentage of 71.67%, extending their lead on Australia in second (62.50%).

Bangladesh, who had jumped to the fourth position following an exceptional 2-0 win against Pakistan, drop to sixth place (point percentage of 39.29%) behind Sri Lanka and England after the defeat.

"The win in England boosted our morale," Sri Lanka captain Dhananjaya de Silva said referring to their Test match victory at The Oval earlier this month.

"We've the ability to win Tests and the boys are delivering now."

Jayasuriya's match haul of nine wickets earned him the player of the match award.

"I like this Galle pitch," Jayasuriya said.

"I just concentrate on bowling a consistent line and length, focus on that and get the results."

The second Test, also in Galle, begins on Thursday.

Moving to third on the WTC25 table after victory in Galle, Sri Lanka stand the best chance of challenging the 2023 World Test Championship finalists for a spot in the 2025 final.

The 63-run victory over the Black Caps in Galle was their fourth in eight matches, moving them an even 50% of possible World Test Championship points, with a best possible percentage of 69.23% for Dhananjaya de Silva's men.

That figure would likely be enough for a chance of lifting the mace in next year's finale at Lord's, though the side would need to beat New Zealand once more, claim a clean sweep of South Africa, and beat Australia 2-0 at home in a series early next year.

Both Shadik and Farhad got enrolled at DU after completing Alim from Baitush Sharaf Adarsh Kamil Madrasa in Chattogram.

Shadik Kayem, who was actively involved in the Anti-Discrimination Student Movement, said they divulged their identities in line with a decision of the organisation.

"In the last 15 and a half years, the fascist government forced us to stay underground. We were portrayed as monsters. We want to get rid of it," Shadik told The Daily Star.

"Everyone will do their politics, everyone will enjoy the freedom of expression, nothing will be imposed on anyone - that is what we want," he said.

Video shows men singing, dancing around youth they murdered

Twenty-year-old Sharmin Akter was recovering after losing her 24-year-old husband Md Shahadat Hossain, who was found murdered a month ago, but she spiralled once again as a heartbreaking video surfaced of the last moments of his life.

The 20-second video from August 14 in Chattogram showed the limp body of a young man tied to two poles.

A crowd of young men were singing a local song and dancing around him, seemingly taking pleasure in a life slipping away before their eyes.

Metro line-5 proposal to be re-evaluated

Interim govt takes its first step to review mega projects

For the first time, a proposal for a mega project will be sent back for further review as the interim government intends to re-evaluate all large projects to assess their usefulness carefully.

According to officials at the Planning Commission, the MRT Line-5 project proposal is likely to be sent back to the metro rail authority within a day or two. The project is awaiting final approval from the Executive Committee of the National Economic Council (Ecnec).

(MRT) Line-5 (Southern Route) is planned to be built between Gabtoli and Dasherkandi at a cost of Tk 54,618 crore (approximately \$5.1 billion), with funding from the Asian Development Bank (ADB) and South Korea.

During the immediate past

The 17.20km Mass **Rapid Transit (MRT)** Line-5 (Southern **Route) is planned** to be built between **Gabtoli and** Dasherkandi at a cost of Tk 54,618 crore (approximately \$5.1 billion)

The 17.20km Mass Rapid Transit documents, the MRT Line-5 will be built from Gabtoli to Dasherkandi via Kalyanpur, Shyamoli, Asad Gate, Russell Square, Karwan Bazar, Hatirjheel, Tejgaon, and Aftabnagar. There will be 11 underground and four elevated stations. The tunnel section will be between Gabtoli and Aftabnagar, while the elevated portion will be from Aftabnagar to Dasherkandi. A feasibility study on the project has already been completed with ADB financing. The deadline for the project is 2030.

According to the preliminary commitment, ADB will provide \$3 billion and South Korea \$1.5 billion in financing for the project.

Rejoinder, our reply

Chowdhury Nafeez Sarafat has issued a rejoinder in response to a Star report titled "Nafeez Sarafat manipulated stock market", published on September 2 based on the investigation report by the Police's Criminal Investigation Department (CID).

The rejoinder said the report was made based on improper investigation and inaccurate information, which is not consistent with the principles of journalism.

The rejoinder reads that RACE Asset Management is run by its managing director and chief executive officer Hasan Taher Imam, who holds 75 percent shares of the company.

Earlier this year, it was Sarafat who identified potential irregularities within the company and acting in good faith filed formal complaints to the Bangladesh Security Exchange Commission. His actions prompted an investigation into Hasan Taher Imam and RACE Asset Management.

37 Khulna rivers in dire straits **Finds Bela study**

The rivers of Khulna division are in a poor state, primarily due to reduced water flow from upstream and inadequate management of siltation.

Many rivers lack water flow and encroachment on them continues.

A recent study by the Bangladesh Environmental Lawyers Association (Bela) identified that out of 138 rivers in the division, 37 are now in a state of critical distress. This alarming information was shared during a discussion on river conservation held yesterday at a hotel in Khulna city.

The endangered rivers are Soilmari, Chunkuri, Rupsa, Bhadra, Mayur, Hori, Hamkura, Pasur, Mukteshwari, Harihar, Ichamati, Garai, Kaliganga, Bhairab, Kapotaksha, Madhumati, Navganga, Chitra, Kumar, Atarobanki, Payala, Mathabhanga, Baleshwar, Bhola, Marihap, Kakshial, Mongla-Ghsiakhali Channel, Kholpetua, Ghangrai, Shibshah, Teligati, Guachapa, Hariyabhanga,

More than a month after the ruthless killing, the incident came to the fore after the video was posted on Facebook on Saturday.

The victim was identified as Shahadat, 24, a resident of the BRTC area's Boiler Colony under Kotwali Police Station in Chattogram. Originally from Nadna village in Noakhali's Sonaimuri upazila, he worked as a day labourer in the BRTC fruits market, said his family members.

The location of the assault was confirmed by police to be under the Akhtaruzzaman flyover near the Sholoshahar No 2 Gate area in the port city.

Police found Shahadat unconscious with multiple injuries in the Probortak area of the port city on the night of August 14. He was taken to Chattogram Medical College Hospital, where doctors declared him dead.

The following day, Shahadat's uncle, Md Harun, filed a case with the Panchlaish Police Station, naming unknown persons as suspects. The motive for the murder or any prior disputes were not mentioned in the report.

On Sunday, the Planning Commission placed the MRT Line-5 proposal before Planning Adviser Wahiduddin Mahmud, who gave his consent for further review.

"Now we will send the proposal back to the metro rail authority. It could be sent tomorrow [today]," a Planning Commission official, wishing to remain unnamed, told this newspaper yesterday.

The interim government has decided against initiating new mega projects and to review ones under the Annual Development Programme (ADP). The planning adviser has given a directive to evaluate mega projects to assess whether they should be executed, especially the new ones.

Awami League government, Dhaka Mass Transit Company Ltd (DMTCL), the implementing and operating agency of metro rail, sent the project proposal to the planning ministry before its approval at the Ecnec. In April, a Project Evaluation Committee meeting evaluated the project.

According to the project

In July 2013, the AL government formed the state-run company DMTCL to build and operate metro rail. The company adopted a timebound action plan to build a 140km metro rail network, comprising six lines, in and around Dhaka by 2030 to reduce traffic congestion and air pollution.

The country's first metro rail line, also known as MRT Line-6, is now fully operational on the Uttara to Motijheel route, significantly reducing travel time in a major part of the city. Its extended part from Motijheel to Kamalapur is expected to be opened by June next year.

Mahfuzur Rahman Mukul, Khulna divisional coordinator of Bela, presented the key findings, noting that 20 of the rivers in distress were not flowing and the Hamkura river was about to disappear.

Encroachment, unplanned infrastructure development, siltation, industrial pollution, and the construction of barriers like bridges and sluice gates are the main reasons for their poor state.

He also cited that the establishment of Carew & Co (Bangladesh) Ltd sugar mill in 1938 severed the connection between the Mathabhanga and Bhairab rivers, leading to the latter's health to slide. The construction of narrow railway bridges in 1861 also disrupted river systems, impacting the Kumar, Navaganga, Chitra, and Bhairab rivers.

After 1950, around 4,000km of embankment, 782 sluice gates, and 92 polders were constructed. Of them, 1,556km of dam, 92 sluice gates, and 37 polders were built in the south-western region.

POST-COUP MYANMAR India invites anti-junta forces to Delhi

India has invited political and military opponents of Myanmar's ruling junta to attend a seminar in New Delhi, sources said, a significant move by the South Asian power that has maintained ties with the top generals shunned by Western nations.

A civil war in Myanmar since its military unseated an elected civilian government in a February 2021 coup now risks destabilising India's 1,650-km (1,025-mile) border with Myanmar, and some of its key infrastructure projects there.

A leader of an armed group and two sources with direct knowledge of the issue said the parallel National Unity Government (NUG) and ethnic minority rebels from the states of Chin, Rakhine and Kachin bordering India had been invited to a seminar in mid-November.

It was not immediately clear what the seminar would seek to achieve or why India has made the move.

The event would be hosted by the government-funded Indian Council

Oldest human **DNA from South** Africa decoded

Researchers have reconstructed the oldest human genomes ever found in South Africa from two people who lived around 10,000 years ago, allowing a better understanding of how the region was populated, an author of the study said Sunday.

The genetic sequences were from a man and a woman

whose remains were found at a rock shelter near the southern coastal town of George, about 370 kilometres east of Cape Town, said University of Cape Town (UCT) biological anthropology Professor Victoria Gibbon.

They were among 13 sequences reconstructed from people whose remains were found at the Oakhurst shelter and lived 1,300-10,000 years ago. Prior to these discoveries, the oldest genomes reconstructed from the region dated back around 2.000 years.

A surprise finding from the Oakhurst study was that the oldest genomes were genetically similar to those from San and Khoekhoe groups living in the same region today, UCT said in a statement.
